Thursday, March 11, 1943.

Mr. PAYSON: Mr. Speaker, I move that the House reconsider its action taken earlier in today's session relating to Item 1, on the House Advance Journal and Calenlar, Bill "An Act relating to the Jointly - Contributory Retirement System" (S. P. 428) (L. D. 766) whereby that Bill was referred to the Committee on Pensions in concurrence.

The SPEAKER: The gentleman from Portland, Mr. Payson, moves that the House reconsider its action taken early in today's session whereby Bill "An Act relating to the Jointly - Contributory Retirement System" (S. P. 428) (L. D. 766) was referred to the Committee on Pensions in concurrence. Is this the pleasure of the House?

The motion prevailed.

Mr. PAYSON: Mr. Speaker, I now move that this bill be referred to the Committee on Judiciary in nonconcurrence. In explanation, I would like to say that there have been between fifteen and twenty bills relating to the Jointly-Contributory Retirement System, which have all gone to the Committee on Judiciary. This particular bill is a sweeping revision of the whole pension system. There is now pending before the Judiciary Committee another sweeping revision of the Contributory Pension system, presented by the gentlewoman from Brunswick, Miss Bangs. It is possible that these two bills, if referred to different committees, might both come out "Ought to pass" and they are in direct conflict with each other. It seems to me perfectly obvious that they ought to be in the committee where all the other bills have been referred; and I may say that I have talked with the sponsor of the bill this morning and he will not object to the reference of this bill to the Judiciary Committee.

The SPEAKER: The gentleman from Portland, Mr. Payson, now moves that Legislative Document 766 be referred to the Committee on Judiciary in non-concurrence. Is this the pleasure of the House?

The motion prevailed and the Bill was referred to the Judiciary Committee in non-concurrence and sent up for concurrence.

Mr. BUBAR: Mr. Speaker, my reason for tabling this measure was that two years ago a similar measure was before our Legislature, and the main talking-point for that was that it was one of those enabling acts. It required no money-the proponents stated a number of times according to the record, that they were not asking for a nickel of the State's money, but that it was another one of those enabling acts. This year they are back asking for a sum of money to keep the thing going.

I have no particular objection to the bill the way it is now unless the proponents wish to go further. Thereupon the bill had its second

reading.
