On motion by Miss Clough the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

The SPEAKER: The Chair now lays before the House the third

tabled and today assigned matter, Senate Report "Ought not to pass" of the Committee on Inland Fisheries and Game on Bill "An Act Permitting Non-Resident Citizens to Transport Deer." (S. P. 188) (L. D. 274) tabled by the gentleman from Buxton, Mr. Davis, on March 18th, pending acceptance of Report in concurrence; and the Chair recognizes that gentleman.

Mr. DAVIS: Mr. Speaker, as the Bill as amended seems to take care of the objections to the original Bill, I move that the Bill be substituted for the Report.

The SPEAKER: The gentleman from Buxton, Mr. Davis, now moves that the Bill be substituted for the "Ought not to pass" Report of the Committee in concurrence. Is this the pleasure of the House?

The motion prevailed, and the Bill was substituted for the "Ought not to pass" Report of the Committee in concurrence, and was given its two several readings.

Any tag or other marker issued under the provisions of this section shall be in lieu of that provided for by section 68'

On motion by Miss Clough of Bangor, the House voted to take from the table the seventeenth tabled and unassigned matter, House Report "Ought to pass" of the Committee on Appropriations and Financial Affairs on "Resolve in Favor of Central Maine Sanatorium, at Fairfield" (H. P. 1074) (L. D. 563) tabled by that gentlewoman on March 16th, pending acceptance of Report.

The SPEAKER: The Chair recognizes the gentlewoman from Bangor, Miss Clough.

Miss CLOUGH: Mr. Speaker, I now move that House Paper 1074, Legislative Document 563, be recommitted to the Committee on Appropriations and Financial Affairs, and in support of this motion I would say that this bill, through an error, came out of committee in a form different from

that desired, and now the Committee on Appropriations and Financial Affairs request that it be recommitted.

The SPEAKER: The gentlewoman from Bangor, Miss Clough, now moves that Legislative Document 563 be recommitted to the Committee on Appropriations and Financial Affairs. Is this the pleasure of the House?

Thereupon, the motion prevailed, and the Bill was recommitted to the Committee on Appropriations and Financial Affairs and sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Mapleton, Mr. Webber.

Mr. WEBBER: Mr. Speaker, I move that the House reconsider its action of March 18th whereby it accepted the "Ought not to pass" Report of the Committee on Education on Bill "An Act Permitting the Department of Education to Cooperate in Establishing University Extension and Correspondence Courses" (H. P. 536) (L. D. 308). My purpose in asking for reconsideration is to make possible a motion that the Bill be referred to the next Legislature.

The SPEAKER: The gentleman from Mapleton, Mr. Webber, moves that the House reconsider its action whereby it accepted the "Ought not to pass" Report on Legislative Document 308.

The Chair recognizes the gentleman from Falmouth, Mr. Dow.

Mr. DOW: Mr. Speaker and Members of the House: When we refer a matter to the next Legislature the usual comment outside is "They passed the buck." I believe the purpose of the gentleman from Mapleton, Mr. Webber, will be better accomplished by leaving the matter as it is and if there is a sufficient interest to bring it before the next Legislature, the same bill, or a similar one, could be presented then and I believe it would receive more favorable consideration.

The SPEAKER: The question before the House is on the motion of the gentleman from Mapleton, Mr. Webber, that the House reconsider its action of March 18th whereby it accepted the "Ought not to pass" Report of the Committee on Edu-

cation on Legislative Document 308. All those in favor will say aye; those opposed no.

A viva voce vote being taken, the motion did not prevail.

On motion by Mr. Perkins of Boothbay Harbor, the House voted to take from the table the fourth tabled and unassigned matter, Senate Report "Ought not to pass" of the Committee on Judiciary on Bill "An Act Amending the Financial Responsibility Law Relating to Obtaining Revoked Licenses" (S. P. 288) (L. D. 449) tabled by that gentleman on March 3rd, pending acceptance in concurrence; and on further motion by the same gentleman the "Ought not to pass" Report was accepted in concurrence.

On motion by Mr. Perkins of Boothbay Harbor, the House voted to take from the table the fifteenth tabled and unassigned matter, House Amendment "A" to Bill "An Act Relating to Town Reports" (H. P. 809) (L. D. 465) tabled by that gentleman on March 11th, pending adoption.

The SPEAKER: The Chair recognizes the gentleman from Boothbay Harbor, Mr. Perkins.

Mr. PERKINS: Mr. Speaker, with your permission I yield to the gentleman from Pittsfield, Mr. Vickery.

The SPEAKER: It is not necessary under the rules of the House that the gentleman yield.

The Chair recognizes the gentleman from Pittsfield, Mr. Vickery.

Mr. VICKERY: Mr. Speaker and Members of the House: On March 11th, I introduced House Amendment "A" to Legislative Document 465, with the intent of limiting the restrictions under the law which does make it necessary for the Municipal Officers in printing their town reports to include in those reports an itemized statement of their receipts and disbursements, the requirement of the law which has been to a large extent disregarded by the municipalities or the larger towns. In submitting that amendment I find that I have stepped upon the toes of some of the smaller towns who feel that their rights are protected by the present law. They are entitled to have their rights pro-

tected. I also feel that the larger towns are entitled to protection. It places the selectmen or officers for the town in a rather undesirable position to be continually disregarding the law; a position which the Selectmen of our town found themselves in when an individual brought the matter to an issue and the several officers were subject to fine. Therefore, in order to clear the situation from my viewpoint, I am going to ask permission to withdraw my House Amendment "A" and in place thereof submit House Amend-ment "B". This amendment will place the matter on a local option basis so that each town, by vote of the town, can have such type of town report as its citizens wish and that amendment will also protect the officers for such reports as have been issued and care for the next year's report which will not be voted on. Mr. Speaker, I ask permission to withdraw my House Amendment "A".

The SPEAKER: The gentleman from Pittsfield, Mr. Vickery, asks consent to withdraw House Amendment "A". Is this the pleasure of the House?

The motion prevailed and House Amendment "A" was withdrawn.

Mr. Vickery then offered House Amendment "B" and moved its adoption.

House Amendment "B" read by the Clerk as follows:

House Amendment "B" to H. P. 809, L. D. 465, Bill "An Act Relating to Town Reports."

Amend said Bill by inserting at the end of the first sentence of the paragraph beginning "Sec. 63" the following:

'Provided a town may at a regular annual town meeting vote to waive the printing in its annual printed town report an itemized list of receipts and disbursements, said vote to stand effective until revoked at a regular annual town meeting. A town may print its annual report in 1944 on the same basis as that used in its 1943 report without a special authorizing vote and all printed town reports issued previous to the year 1944 shall be considered as having complied with the law if said reports were accepted by vote of the town at its annual meeting.'

The SPEAKER: Is it the pleasure of the House to adopt House Amendment "B"?

Thereupon, on motion by Mr. Williams of Clifton, House Amendment "B", with accompanying papers, was tabled pending adoption, and specially assigned for Wednesday, March 24th.

On motion by Mr. Leavitt of Portland, the House voted to take from the table the thirteenth tabled and unassigned matter, House Report "Ought not to pass" of the Committee on Mines and Mining on Bill "An Act Relating to Mining" (H. P. 257) (L. D. 166) tabled by that gentleman on March 11th, pending acceptance; and on further motion by the same gentleman the "Ought not to pass" Report was accepted and sent up for concurrence.

On motion by Mr. Jacobs of Auburn, the House voted to take from the table the eighteenth tabled and unuassigned matter, Committee Amendment "A" to Bill "An Act Relating to the Salary of the Judge of Probate for Androscoggin County (S. P. 166) (L. D. 767, tabled by that gentleman on March 17th, pending adoption.

Mr. Jacobs offered House Amendment "A" to Committee Amendment "A" and moved its adoption.

House Amendment "A" to Committee Amendment "A" read by the Clerk as follows:

House Amendment "A" to Committee Amendment "A" to S. P. 166, Bill "An Act Relating to the Salary of the Judge of Probate for Androscoggin County."

Amend said amendment by striking out at the end thereof the underlined figures "\$2,500" and inserting in place there of the underlined figures "\$2,000."

The SPEAKER: Is it the pleasure of the House to adopt House Amendment "A" to Committee Amendment "A"?

The Chair recognizes the gentleman from Lewiston, Mr. Boutin.

Thereupon on motion by Mr. Boutin, House Amendment "A" to Committee Amendment "A", with accompanying papers, was tabled pending adoption, and specially assigned for Wednesday, March 24th.

On motion by Mr. Brown of Brunswick, the House voted to take

from the table the nineteenth tabled and unassigned matter, House Amendment "A" to Bill "An Act to Provide a Town Manager Form of Government for the Town of Brunswick" (H. P. 187) (L. D. 129), tabled by that gentleman on Mach 18th, under House Rule 36, for reproduction.

The SPEAKER: This amendment has now been reproduced and distributed under Filing No. 112. This has already been read prior to the time when it was reproduced, and unless there is a call, it will not be read the second time. Do I hear objections? I hear none. Is it now the pleasure of the House to adopt House Amendment "A" to L. D. 129?

Thereupon, House Amendment "A" was adopted, and the Bill had its third reading and was passed to be engrossed and sent up for concurrence.

On motion by Mr. Cross of Augusta. the House voted to take from the table the first tabled and unassigned matter, Senate Report "Ought to pass" of the Committee on Legal Affairs on Bill "An Act to Provide for Post War Planning" (S. P. 178) (L. D. 242) which came from the Senate, Report accepted and Bill passed to be engrossed; and which was tabled in the House by the gentleman from Augusta, Mr. Cross, on February 18th, pending acceptance of Report.

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Cross.

Mr. CROSS: Mr. Speaker and members of the House: This bill was tabled by me some time ago for two particular reasons. One, which you will realize, was that it was a bill of particular importance and involved a great deal of money. I did not think at that time that we had had proper time to consider the bill, and for that reason, and for the fact that I felt it might be strengthened by an amendment, I tabled it. I have now prepared an amendment which I think will be acceptable to the sponsor of the bill and which will be presented at the proper time. I therefore move that the Report "Ought to pass" be accepted.

The SPEAKER: The gentleman from Augusta, Mr. Cross, moves acceptance of the "Ought to pass" report of the Committee.

The motion prevailed, and the "Ought to pass" Report was accepted, and the Bill had its two several readings.

The SPEAKER: What time does the House assign for the third reading of this Bill?

The Chair recognizes the gentleman from Augusta, Mr. Cross.

Mr. CROSS: Mr. Speaker, inasmuch as the calendar is especially heavy for Tuesday, and inasmuch as this would come up for third reading, I presume, on Monday, I would move that this matter be tabled and specially assigned for Wednesday morning.

The SPEAKER: Will the gentleman from Augusta specially assign this for third reading on Thursday morning?

Mr. CROSS: If you prefer, Mr. Speaker.

The SPEAKER: The Chair might state that all these matters which are assigned for Tuesday will automatically go over and remain unfinished business and we are anxious not to have any breaks in the business.

Thereupon, the matter was assigned for third reading Thursday, March 25th.

On motion by Mr. Usher of Gorham, the House voted to take from the table the second tabled and unassigned matter, House Report "Ought not to pass" of the Committee on Legal Affairs on Bill "An Act Relating to Tax Abatements" (H. P. 191) (L. D. 138) tabled by that gentleman on February 18th, pending acceptance of Report; and on further motion of the same gentleman the "Ought not to pass" Report was accepted and sent up for concurrence.

The SPEAKER: The House is proceeding under Orders of the Day. If there is nothing further to come up under Orders of the Day, the Clerk will read the notices.

On motion by Mr. Cross of Augusta,
