Monday, April 17, 1944.

This being the day designated in the Proclamation of the Governor for the meeting of the Ninety-first Legislature in extra session, the members of the House of Representatives assembled in their hall at four-thirty o'clock in the afternoon and were called to order by the Speaker.

Prayer was offered by the Rev.

Dr. Wood of Augusta.

The SPEAKER: The Clerk will read the Proclamation by the Governor.

### STATE OF MAINE PROCLAMATION BY THE GOVERNOR

WHEREAS, it appears desirable that the Legislature of this State should meet in special session to consider matters pertaining to sold-ier-voting in the 1944 elections

consider matters pertaining to soldier-voting in the 1944 elections, NOW, THEREFORE, I, SUMNER SEWALL, by virtue of the power vested in me as Governor, convene the Legislature of this State, hereby requiring the Senators and Representatives to assemble in their respective chambers at the Capitol, at Augusta, on Monday, the seventeenth day of April, 1944, at 4.30 o'clock in the afternoon, in order to receive such communication as may then be made to them and to consider and determine on such measures as in their judgment will best promote the welfare of the State.

Given at the office of the Governor at Augusta, and sealed with the Great Seal of the State of Maine, this thirty-first day of March, in the year of our Lord One Thousand Nine Hundred and Forty-four, and of the Independence of the United States of America, the One Hundred and Sixty-eighth.

The Proclamation was read and ordered placed on file.

The Clerk thereupon called the roll of the House.

One hundred and thirty-four members answering to their names, a quorum was declared to be present.

Those who were absent were: Messrs. Forgue, Gowell, Hutchins, Pierce, Southard and Tuttle.

On motion by Mr. Sleeper of Rockland, it was

ORDERED, that a committee of seven be appointed to wait upon His Excellency, the Governor, and inform him that a quorum of the House of Representatives is assembled in the Hall of the House for the consideration of such business as may come before the House.

At this point a message was received from the Senate, through its Secretary, informing the House that a quorum was present in the Senate Chamber, and that body was ready to transact such business as may come before it.

The SPEAKER: The Chair appoints as members to serve upon the committee to notify His Excellency, the Governor: The gentleman from Rockland, Mr. Sleeper, the gentlewoman from Bangor, Miss Clough, the gentleman from Sanford, Mr. Pelletier, the gentleman from Livermore Falls, Mr. Grua, the gentlewoman from Bath, Miss Deering, the gentleman from Caribou, Mr. Libby, and the gentleman from Damariscotta, Mr. Denny.

Mr. Sleeper, for the committee, subsequently reported that the committee had performed the duty assigned to them.

On motion of Mr. Doughty of Gray, it was

ORDERED, that a message be conveyed to the Senate that a quorum of the House of Representatives is present for the consideration of such business as may come before the House.

Thereupon, the Clerk was designated by the Speaker to convey the message to the Senate, and Mr. Pease subsequently reported that he had performed the duty assigned him.

The communication was read and ordered placed on file, the accompanying records ordered returned to the Secretary of State, and the names stricken from the rolls of the House.

The SPEAKER: The gentleman from Rumford, Mr. Poulin, moves that the members of the House stand for a moment in silent prayer in memory of the death of Repre-sentative Ralph L. Boyd of Winn.

The entire membership of the House then stood in silent prayer.

The gentleman from Old Town, Mr. Cousins, presented the following resolution:

WHEREAS the members of the House of Representatives of the 91st Legislature learned with pro-found sorrow of the untimely death

on April 4, 1944 of an esteemed colleague, Hon. Ralph L. Boyd, Representative from Winn, and WHEREAS in his associations with the members of this House and the members of the House of the 90th Legislature, he was ever honorable forceful and kindly and honorable, forceful and kindly, and highly regarded for his character and sterling qualities of mind and heart, and

WHEREAS the members of the House of Representatives feel in his passing a great personal loss and a

genuine grief, NOW THEREFORE, BE IT RE-SOLVED that the State of Maine mourns the loss of a faithful and valued public servant, and the members of the House of Representatives lament the departure of an esteemed and trusted friend, and

BE IT FURTHER RESOLVED that a copy of this resolution be entered in the Journal of the House and a copy transmitted to the widow of the deceased.

The Resolution was read and adopted.

The SPEAKER: The Chair will state that at the present time there are one hundred and forty elected members of the House.

A message was then received from the Senate, through its Secretary, proposing a Joint Convention to be held forthwith in the hall of the House of Representatives for the purpose of extending an invitation to His Excellency, the Governor, to attend the Convention and make such communication as pleases him.

On motion by Mr. Sleeper of Rockland, out or order and under

ORDERED, that Ruel C. Hanks be Official Reporter of the House and that Ervin E. J. Lander be Assistant Reporter for the present session.

On motion by Miss Clough of

Bangor, out of order and under suspension of the rules, it was ORDERED, that Alan C. Pease of Wiscasset, be Page of the House during this special session.

On motion of Mr. Sleeper of Rockland, the Clerk was charged with and conveved a message to the Senate informing that body that the House concurred in the proposal for a Joint Convention.

The Clerk subsequently reported that he had delivered the message with which he was charged.

The Senate then entered the hall of the House and a Joint Convention was formed.

# IN CONVENTION

The President of the Senate in the Chair.

On motion by Senator Harvey of York, it was

ORDERED, that a Committee be appointed to wait upon the Honorable Sumner Sewall, Governor, and inform him that the two branches of the Legislature are in Conven-tion assembled in the Hall of the House of Representatives; and extend to him an invitation to attend the Convention and present such communication as he may be pleased to make.

The Chairman thereupon appointed as members of that Committee on the part of the Senate:

Senators: Harvey of York, Dow of Oxford and Sterling of Somerset,

And on the part of the House:
Representatives: Payson of Portland, Milliken of Madison, Osgood of Bradford, Poulin of Rumford, Barnes of Houlton, McCloud of Bar Harbor and Stephenson of Union.

Subsequently, Senator Harvey for the committee reported that the committee had discharged the duty assigned to it, and that the Governor was pleased to say that he would attend forthwith.

Thereupon, the Honorable Sum-ner Sewall, Governor, accompanied by the Executive Council, the Attorney General and the Adjutant General, entered the Hall of the House of Representatives amid applause, the audience rising, and the

Governor addressed the Convention as follows:

#### THE MESSAGE

Mr. President and Members of the 91st Legislature:

Many many thousands of Maine citizens are today outside our country, in the armed forces of our nation, fighting to preserve the demo-cratic way of life. We meet here to enable them to exercise the fundamental right of democracy — the

right to vote.
Only this Legislature can make this possible. Only by the use of the State ballot can these soldier citizens vote for an entire slate of public officials and representatives in County, State, and National government.

Under existing law, it will not prove practicable for those serving abroad to vote in this year's elections. Personal appearance for registration in towns of over three thousand population is obviously impossible. Party enrollment by overseas mail is impractical. of transit between the fighting fronts and the voting residence severely limits the voter's ability to secure and cast his ballot.

From studies made by the Attorney General and the Secretary of State, it appears that full voting privileges can be made available to these soldier citizens by a private and special law expiring after the next regular session.

If enacted, the following changes

will be effected in our present law: Registration boards or municipal officers in communities of over 3,000 population will be called upon to register all citizens whom they reliably know to be qualified, absent from their residence, and in the armed forces or in certain specified service organizations. Necessity for personal appearance before the personal appearance board is eliminated. Under present law registration without personal appearance is limited to communi-

ties of less than 3,000 population.

Application for absentee ballots may be made in behalf of the soldier-voter by a parent, grandparent, former guardian, spouse, adult brother, adult sister or adult child of such voter. Under present law this application must be made by the voter himself.

Party enrollment may be declared by the soldier-voter on the envelope in which he encloses his ballot. Under present law he must make a separate declaration before

receiving his ballot.

The Federal war ballot may be used in cases where the soldiervoter has applied for a State ballot
and has not received it in time for
use. By Congressional action the use
of this Federal war ballot is limited
to the November election and applies solely to the offices of President and Vice-President.

Other provisions are of a minor nature. All can be drawn in a form which does not require changes in the general Statutes. I am informed that any such changes would make impossible the timely completion of the current work of revision of statutes, and should be scrupulously

avoided.

My sole purpose in convening the Legislature at this time is to make it possible for every Maine citizen in the armed forces to vote wherever he or she may be. I am confident that we are in agreement as to this purpose, and that you will be glad to take appropriate action.

to this purpose, and that you will be glad to take appropriate action. Mindful of the fact that many of you will wish to return to your homes and occupations as quickly as possible after the matter of soldier-voting is disposed of, I am refraining from other recommendations at this time. Should you decide, however, to consider other legislation, there are several matters of an administrative nature which I would ask that you include.

We here are not privileged to serve in our nation's armed forces in this period of world crisis. It is for us to serve at home as trustees of freedom and of democracy.

I am sure we shall be faithful

to this trust.

Governor Sewall, accompanied by the Executive Council, the Attorney General and the Adjutant General, then retired, amid the applause of the Convention, the audience rising.

Thereupon, the purposes for which the Convention was assembled having been accomplished, the Convention was dissolved, and the Senate retired to its chamber, amid the applause of the House, the members rising.

It is my pleasure to transmit herewith a letter from the Honorable Percival P. Baxter of Portland, (S. P. 499) in which he offers a substantial gift of land to the State.

If it is the pleasure of the 91st Legislature to accept this gift of 24,682 acres of forest land, the area of the Baxter State Park will be brought to 84,000 acres

brought to 84,000 acres.

I commend this offer to your thoughtful consideration and urge acceptance of this gift as being in the public interest.

To the Honorable Sumner Sewall, Governor and the Honorable Senate and House of Representatives of the Ninety-first Legislature of the State of Maine— Once again I come to main and the state of the State of Maine—

Once again I come to you with the request that, if you deem it for the best interest of our State, you accept from me the gift of twenty-four thousand six hundred eighty-

two (24,682) acres of forest land to be added to and become a part of Baxter State Park in the Mt. Ka-

tahdin region.

The area now offered the State i township five (5) range ten (10) W E. L. S. Piscataquis County. This township contains twenty - four thousand seven hundred two (24,-702) acres, of which an area of twenty (20) acres in the southwest quarter is owned by Charles A. Daisey. If you accept this gift the State then will have received from me approximately eighty-four thousand (84,000) acres. When the Legislature meets in January 1945, I plan to be present with a gift of additional land for the Park.

phant to be present with a gift of additional land for the Park. In the Deed accompanying this communication you will notice that the timber rights on this township are reserved until August 7, 1965 to the corporation from which I purchased this land. Naturally I preferred to buy this area without such a reservation, but was unable to do so. The Eastern Corporation very properly wished to conserve its timber supply for its mill, and a buyer can only purchase what a seller is willing to part with. This Corporation, however, acted in a liberal and sympathetic manner in selling me this township. It sold to me only because it was willing to help me to carry out my Park project. It would not have sold to any other party, and I deeply appreciate the action of its President and Board of Directors.

Although this township doubtless will be cut over during the above mentioned period, in a few years thereafter it will completely reforest itself and will then be covered with a new growth of trees. Nature will heal all the wounds.

BAXTER STATE PARK will remain the property of the people of Maine as long as the State of Maine exists. It is a long range project and township five (5) range ten (10) will be forever a place of recreation for our people and a sanctuary and home for the creatures of the wild.

I now present to you an Act of Acceptance and request your Excellency and your Honorable Bodies to approve and accept this Gift of Conveyance to the State of Maine as Trustee in Trust for the people of Maine.

These Orders shall not apply to such bills or resolves as are intended only to facilitate the business of the 91st Legislature. (H. P.
