On motion by Mr. McGlauflin of Portland, the House voted to take from the table the first tabled and unassigned matter, House Order relating to Revised Statutes for Members, tabled by that gentleman on January 5th pending passage, and on further motion by the same gentleman the order received passage.

The SPEAKER: The Chair recognizes the gentleman from Nobleboro, Mr. Palmer.

Mr. PALMER: Mr. Speaker, I am going to move to take from the table the second unassigned matter. Before doing so, I wish to make a brief explanation.

It is customary in the House that when a member places anything on the table he and he alone should take it from the table. However, today, Mr. Burgess is unable to be here, and, to clear the table, I want to move that we take from the table the second unassigned It is his wish that I do matter. this.
