The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Atherton.

Mr. ATHERTON: Mr. Speaker, I now move that this bill be referred to the Committee on Judiciary rather than the Committee on Agriculture.

As a brief explanation for this, I wish to say there is another bill, L.D. 123. "An Act Relating to Cruelty to Animals," which also relates to horse pulling contests. It seems best to the sponsors of this bill which I have introduced on behalf of the Bangor Humane Society that it be heard at the same time before the same committee. I have taken the matter up with the Committee on Reference of Bills and they have no objection. It makes no difference to me whether they are both heard by the Committee on Judiciary or by the Committee on Agriculture, but it seems best in any event that they both be heard by the same committee. Since the first one is already in the hands of the Committee on Judiciary, I make the motion that this one be referred to that committee.

The SPEAKER: The gentleman from Bangor, Mr. Atherton, moves that Bill "An Act Relating to Horse Pulling Contest" H.P. 725, be referred to the Committee on Judiciary. Is this the pleasure of the House?

The motion prevailed and the Bill was referred to the Committee on Judiciary and sent up for concurrence.
