Mr. Burgess from the Committee on Judiciary reported "Ought not to pass" on Bill "An Act Establishing the Limestone Municipal Court" (H. P. 294) (L. D. 82)

Mr. Chase from the Committee on Taxation reported "Ought not to pass" on Bill "An Act Exempting Persons Sixty-two Years of Age from Poll-Tax" (H P. 373) (L. D. 133)

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. McClure.

Mr. McCLURE: Mr. Speaker, I move that this bill be substituted for the "Ought not to pass" report of the committee, and I further move that the motion be laid on the table.

The SPEAKER: The gentleman from Bath, Mr. McClure, moves that the bill be substituted for the "Ought not to pass" report of the committee and that the matter lie upon the table. Is this the pleasure of the House?

The Chair recognizes the gentleman from Cape Elizabeth, Mr. Chase.

Mr. CHASE: Mr. Speaker, I rise to make a parliamentary inquiry. The motion seems to combine one motion which is debatable with another which is not. Is it proper to speak on this motion?

The SPEAKER: Does the gentleman wish to have the motion separated?

Mr. CHASE: Yes, Mr. Speaker.

The SPEAKER: The question before the House is on the motion of the gentleman from Bath, Mr. McClure, to substitute the bill for the report.

The Chair recognizes the gentleman from Cape Elizabeth, Mr. Chase.

Mr. CHASE: Mr. Speaker, if the purpose of the gentleman's motion is to assign consideration of this matter to another day by tabling, I have no objection; but to substitute the bill for the report at this time would remove from the issue the fact that the Committee on Taxation has considered this mat-

ter, and that the question of sustaining the committee is the one, I think, which would really come before the House.

Committee The on Taxation asked me on its behalf to report the bill for the committee and to make such explanation as might be necessary of the reasons for the committee's decision. Now the attendance here today seems a little light, and if the gentleman from Bath wishes to table the matter so that the matter will come up on the question of the acceptance of the report of the committee at a later date, I have no objection; but if it is the purpose at this time to substitute the bill for the report, then I do object to that procedure, and if that is the gentleman's purpose I will speak further on the merits of the question.

The SPEAKER: The Chair understands that the gentleman from Bath, Mr. McClure, in making his motion, moved to substitute the bill for the report of the committee and to place the matter upon the table.

Mr. CHASE: Is that the motion, Mr. Speaker, which will be put to the House?

The SPEAKER: The Chair will put the motion to table first. The question before the House is on the motion of the gentleman from Bath, Mr. McClure, that the report with accompanying papers be tabled. Is this the pleasure of the House?

The motion prevailed and the Report with accompanying papers was tabled pending acceptance of the committee report.

Passed To Be Engrossed Amended Bill

Bill "An Act to Incorporate the Town of Troy School District" (H. P. 888) (L. D. 307)

Mr. Campbell, of Augusta, offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 888, L. D. 307, Bill, "An Act to Incorporate the Town of Troy School District."

Amend said Bill by inserting before the last sentence of section 8 thereof the following sentence:

'This act shall take effect for all the purposes hereof immediately upon its acceptance by a majority of the legal voters voting at said meeting.'

Thereupon, House Amendment "A" was adopted, the Bill was passed to be engrossed as amended and sent to the Senate.

House Amendment "A" to H. P. 180, L. D. 56, Bill "An Act to Create the Limestone School District."

Amend said bill by striking out the last two sentences of the 3rd paragraph of section 3 thereof and inserting in place thereof the following:

'The treasurer shall give bond to the district in such sum and with such sureties as the trustees may determine which bond shall remain in the custody of the president. The cost of such bond shall be paid by the district.'

Thereupon, House Amendment "A" was adopted, the Bill was passed to be engrossed as amended and sent to the Senate.

On motion by Mr. Campbell, of Augusta, the House voted to reconsider its action of yesterday whereby Bill "An Act to Incorporate the Town of Burnham School District" (H. P. 54) was passed to be engrossed; and on further motion by the same gentleman the Bill was tabled pending passage to be engrossed.

Mr. BURGESS: Mr. Speaker and Members of the House: I would like at this time briefly to call your attention to the date of February 9th which is the last date for introduction of private and special bills. Mention is made of this purely so that none of you will find your selves in the position of being on the outside when the time comes, also that this session may progress as well as it is now progressing and that we will not have to stay here into May.

I would like to make one other brief statement: Wherever it is possible, when an item is tabled, if you can, will you assign a special date. That again is a suggestion merely to keep the wheels rolling and is no attempt by me or anyone else to attempt to push anything. I only make that suggestion in the event you can do it. I thank you.
