### STATE OF MAINE

In the Year of Our Lord One Thousand Nine Hundred and Forty Nine

#### MEMORIAL

To the Honorable Senate and House of Representatives of the United States of America in Congress assembled:

Wc, your Memorialists, the Senate and House of Representatives of the State of Maine in the 94th Legislative Session assembled, most respectfully present and petition your Honorable Body as follows:

Whereas, Joseph Cardinal Mindszenty of Hungary was sentenced to life imprisonment by the government of Hungary; and

Whereas, we memorialists feel that such sentence threatens freedom of religion and speech; now, therefore, be it

Resolved: That we, your Memorialists, do hereby respectfully petition and urge the Members of Congress to take whatever action that can be taken to have the sentence imposed upon Joseph Cardinal Mindszenty of Hungary removed; and be it further

Resolved: That a copy of this Memorial, duly authenticated by the Secretary of State, be immediately transmitted by the Secretary of State, by air mail, to the proper cfficers and committees of the United States Senate and House of Representatives, the President of the United States and to each of the Representatives and Senators representing the State of Maine in the United States Congress.
