HOUSE

Thursday, March 3, 1949

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Collind of Belfast.

The journal of the previous session was read and approved.

**Finally Passed
Emergency Measure**

The following Emergency Resolve on its final passage was taken up out of order and under suspension of the rules:

Resolve Appropriating Moneys to Maintain Present Salary Scale for State Employees (S. P. 383) (L. D. 648)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a division was had. 112 voted in favor of same, and none against, and accordingly, the Resolve was finally passed and signed by the Speaker and, on motion by Mr. Burgess of Limestone, was ordered sent forthwith to the Senate.

On motion by Miss Cormier of Rumford, House Rule No. 25 was suspended for the remainder of today's session in order to permit smoking.

The SPEAKER: The Chair, at this time, notes the presence in the balcony of the Hall of the House of the Civics Club of the Freshman Class of Winthrop High School in charge of Mrs. Irene Hibbs. On behalf of the House, we bid you welcome. (Applause).

Orders of The Day

The SPEAKER: The Chair lays before the House the first tabled and today assigned matter, Bill "An Act relating to Taxation of Savings Banks and Trust Companies" (H. P. 1742) (L. D. 1070) tabled on March 1st by the gentleman from Unity, Mr. Brown, pending reference; and the Chair recognizes that gentleman.

Mr. BROWN: Mr. Speaker, I now move that this bill be indefinitely postponed.

The SPEAKER: The gentleman from Unity, Mr. Brown, moves that H. P. 1742, L. D. 1070, Bill "An Act relating to Taxation of Savings Banks and Trust Companies" be indefinitely postponed.

As many as are in favor of indefinite postponement will say aye; those opposed no.

A viva voce vote being taken, the bill was indefinitely postponed and sent up for concurrence.

The **SPEAKER**: The House is proceeding under Orders of the Day.

The Chair recognizes the gentleman from Auburn, Mr. Williams.

Mr. **WILLIAMS**: Mr. Speaker and Members of the House: As there are no matters on the table requiring attention, I would like at this time unanimous consent to address the House.

The **SPEAKER**: The gentleman from Auburn, Mr. Williams, asks unanimous consent to address the House. Is there objection? The Chair hears none and the gentleman may proceed.

Mr. **WILLIAMS**: Mr. Speaker, we have now been in session about two months, and some 1196 bills have been printed. I am sure that we do not all appreciate some of the services that are furnished as a routine matter nor the advantage of utilizing those services.

Early in the session, we passed an order which was routine in nature and which received little attention, authorizing our very efficient Clerk of the House to employ such assistance as was needed in compiling an index, and also authorizing the hiring of necessary assistants. I am sure that you have all found that these assistants are equally efficient and courteous.

It may be that not all of you have used the services that are provided, and possibly you do not know the details under which they are available. Obviously, all bills will be indexed by their titles, but I would like to call your attention to L. D. 1146. This document is indexed under twenty-one different subject matters, and, if you will look at the bill, you will understand why. It is indexed under stoppage, brush, slash, debris disposal, forest fire prevention, fire prevention, lumbering, logging, highways, railroads, electric power lines, telephone and telegraph lines, pipelines, town dumps, dumps, sawmills, portable sawmills, burning, blueberry land, stumpage, pasture land.

With this type of an index, if one of your constituents inquires about some subject matter in which he is interested, if you will go in the second door on your right as you leave the hall of the House and speak to Mrs. Strout or Miss Whalen, either one of them will use this index and give you the legislative document number of the bill. As is quite likely, you will like to know what has happened to that bill. Even though you have the legislative document number, looking in your document book will not tell you the story.

They also maintain a record of the House action on these various bills. You are all familiar with the bill with regard to legislative travel. On January 20th this was referred to the Committee on Salaries and Fees and ordered printed; on February 2nd the "Ought to pass" report appeared on our House calendar; and the report was accepted and the bill was assigned for the next day. On the 3rd, the bill was engrossed. I would like to mention the Senate action. On the 26th it was referred in concurrence; on February 4th it was recommitted to the Committee on Salaries and Fees in non-concurrence. In the House on February 8th we receded and concurred in recommending to the Committee on Salaries and Fees. On the 10th the "Ought to pass in New Draft under new title" report was tabled pending acceptance of the report by Representative Dow and the bill tomorrow assigned. On the 11th the bill was retabled by Representative Dow and assigned for February 16th. On February 16th this report was accepted and the bill tomorrow assigned. On the 17th the bill was passed to be engrossed. On the 18th the matter was tabled in the Senate by Senator Slocum pending acceptance of the report.

If you members have any question at any time in regard to a bill or its progress, if you will consult either of these young ladies they can tell you just what has happened to the bill.

This year a new service has been added in that a complete list of

all bills referred to any particular committee is available. They also have a complete list of all the bills under the name of each representative who introduced the bills. This may be helpful in case somebody passes you a bill and you are not sure how many you have or what they are or where they are.

In conclusion, I want to emphasize the fact that the Clerk of the House, the Speaker of the House, and our Floor Leader are available and will be glad to help any member of the House at any time. I thank you.

The SPEAKER: The Chair thanks the gentleman from Auburn for his explanation of the procedure available to the members of the House.

The SPEAKER: The House is proceeding under Orders of the Day. The Chair recognizes the gentleman from Stratton, Mr. Carville.

On motion by Mr. Carville, the House voted to take from the table the seventh tabled and unassigned matter, Resolve providing for a Fish Screen at John's Pond in Davis Plantation (H. P. 285) (L. D. 412) tabled by that gentleman on February 16th pending final passage.

On further motion by the same gentleman, under suspension of the rules, the House voted to reconsider its action whereby it passed the resolve to be engrossed on February 9th.

Mr. Carville then offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 285, L. D. 412, "Resolve Providing for a Fish Screen at John's Pond in Davis Plantation."

Amend said resolve by striking out all of the second paragraph thereof, and inserting in place thereof the following:

Resolved: That such fish screen shall not be installed until such time as Mrs. Margaret B. Mason, of Rangeley, in the county of Franklin, or some responsible person or persons shall have paid in to the state treasury the amount necessary to install such screen; and shall have assumed, in a manner satisfactory to the Commissioner, all liability for future maintenance of such screen, and the keeping of the same free from sticks, leaves and all debris.'

House Amendment "A" was adopted and the resolve was passed to be engrossed as amended in non-concurrence and sent up for concurrence.

On motion by Mr. Bates of Orono, the House voted to take from the table the eighteenth tabled and unassigned matter, Bill "An Act relating to Chiropractic Services Under the Aid to Dependent Children and Dependents of Veterans' Law" (H. P. 1755) (L. D. 1128) tabled on February 25th by that gentleman, pending reference; and on further motion by the same gentleman the bill was referred to the Committee on Welfare and sent up for concurrence.

The SPEAKER: If there be no further items of business to come before the House, the Clerk will read the notices.
