#### Orders of The Day

Mr. Philbrick of Woodland was granted unanimous consent to address the House.

Mr. PHILBRICK: Mr. Speaker and Gentlewomen and Gentlemen of the House: As representative of the district comprised of the towns of Washburn, Woodland, Perham, and last, but not to be forgotten, New Sweden, at this time I would like to have written into our record in remembrance that on this day, Wednesday, March 23rd, seventynine years ago a resolve to establish the colony of New Sweden was passed by the Legislature. Later in the same year, W. W. Thomas, Minister to Sweden, enrolled and brought from that country a group of men, women and children and planted them in Northern Maine in the quiet rolling town of New Sweden, Aroostook County.

On February 28th this town lost the last of the fifty-two pioneers who voyaged from their Scandinavian homeland to start a new life in Maine in 1870. Mrs. Agnes N. Anderson, only four when she made the long journey with her parents, died at the age of eighty-three. In recent years she was the last living tie between younger residents of New Sweden and their hardy ancestors who hewed the tall pine to make way for homes and farms eight miles northwest of Caribou. But Mrs. Anderson was much more than a link with the historic past. She was a modern witness to the courage and industry which formed the cadre for America's spectacular growth. She lived to see the descendants of the original fifty-two become prosperous potato raisers and lumbermen. She saw them build churches, schools and general stores: she saw boys and girls go

down-state to attend Maine colleges, some returning to Aroostook, others creating successful careers elsewhere. She saw her townfolk reap the fruits of an earned Freedom.

New Sweden is a small but faithful model of the successful immigrant structure of our country; its story is the story of America.

On motion by Mr. Webber of Bangor, the House voted to reconsider its action taken earlier in today's session, whereby it accepted the "Ought not to pass" report on Bill "An Act to Provide for the Surrender of Moro Plantation of Its Organization" (H. Mr. Sargent of Bucksport, was granted unanimous consent to address the House.

Mr. SARGENT: Mr. Speaker, in asking the unanimous consent of the House for the introduction of a resolve at this late date. I would like to make this explanation. In one of towns which I represent, at the town meeting held a week ago Monday, a considerable revision of town officers was made, and the new town officers, in going over the business of the town which was left for them to consider, noted case of a ninety-two-yearold blind woman who from what was very a family in that town, but through adversity had become, in recent years, a town pauper. The Selectmen, knowing this woman had but a few years to live, and wishing to remove the stigma of being a town charge from her, ask leave to have this resolve introduced in order that the woman may receive a State pension.

The SPEAKER: The gentleman from Bucksport, Mr. Sargent, presents a resolve and requests unanimous consent for its introduction.

The Clerk will read the title.

The CLERK: (reading) Resolve Providing for State Pension for Louise J. Gray of Orland.

The SPEAKER: Is there objection to the reception of the resolve?

The Chair hears none, and the resolve has been received by unanimous consent.

On motion by Mr. Sargent, the resolve was referred to the Committee on Pensions and sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Carmel, Mr. McGown.

Mr. McGOWN: Mr. Speaker, I wish to ask unanimous consent to present a resolve.

The SPEAKER: The gentleman from Carmel, Mr. McGown, presents a resolve and requests unanimous consent for its introduction.

The Clerk will read the title.

The CLERK: (reading) Resolve Providing for a State Pension for Victor Mitchell of Etna.

The SPEAKER: Is there objection to the reception of the resolve? The Chair hears none, and the resolve has been received by unanimous consent.

On motion by Mr. McGown, the resolve was referred to the Committee on Pensions and sent up for concurrence.

On motion by Mr. Brown of Wayne, the House voted to take from the table the twenty-second tabled and unassigned matter, Bill "An Act Creating a Merit Award Board to Encourage and Reward Efficiency and Economy in State Government" (S. P. 537) (L. D. 1069) tabled on March 17th by that gentleman pending passage to be engrossed; and on further motion by the same gentleman the bill was passed to be engrossed in concurrence.

On motion by Mr. Spear of South Portland, the House voted to take from the table the twenty-fourth tabled and unassigned matter, Bill "An Act Relating to the Right of Eminent Domain for Municipalities for Recreational Purposes" (H. P. 1510) (L. D. 808) tabled on March 18th by that gentleman pending passage to be engrossed; and on further motion by the same gentleman the bill was passed to be engrossed as amended and sent up for concurrence.

On motion by Mr. White of Auburn, the House voted to take from the table tenth tabled and unassigned matter, Senate Report "Ought to pass" as amended by Committee Amendment "A" of the Committee on Mercantile Affairs and Insurance on Bill "An Act Relating to Insurance Agents and Brokers" (S. P. 408) (L. D. 745) tabled on March 9th by that gentleman pending acceptance: and on further motion by the same gentleman the report of the committee was accepted in concurrence and the bill had its two several readings.

Committee Amendment "A" was read by the Clerk as follows:

COMMITTEE AMENDMENT "A" to S. P. 403, L. D. 745, Bill "An Act

Relating to Insurance Agents and Brokers."

Amend said Bill by striking out in the 5th and 6th lines thereof the underlined words "or accident and health."

Further amend said Bill by striking out the 18th and 19th lines of said Bill and inserting in place thereof the following: 'of his residence, residents, of Maine may be licensed to solicit and write life insurance in such state in similar manner; and to any resident of the state to'

Thereupon, Committee Amendment "A" was adopted in concurrence, and the bill was assigned for third reading tomorrow morning.
