Prayer by the Rev. Mr. Went-worth of Augusta.

The Members stood at attention during the playing of the National Anthem.

The journal of the previous session was read and approved.

COMMITTEE AMENDMENT "A" to S. P. 258, L. D. 1386, Resolve in Favor of the Town of East Millinocket.

Amend said Resolve by striking out after the word "the" in the 6th line, the following words, "funds of the department of institutional service" and inserting in place thereof, the following: 'general fund of the state':

Committee Amendment "A" was adopted in concurrence and the Resolve was tomorrow assigned for second reading.

Report of the Committee on Legal Affairs on Bill "An Act to Amend the Westport Wiscasset Bridge District" (S. P. 460) (L. D. 912) reporting "Ought to pass" as amended by Committee Amendment "A" submitted therewith.

COMMITTEE AMENDMENT "A" to S. P. 460, L. D. 912, Bill "An Act to Amend the Westport-Wiscasset Bridge District."

Amend said Bill by striking out all of the underlined 1st sentence of that part designated "Sec. 6-B" and inserting in place thereof the following underlined sentence:

'The county of Lincoln is hereby authorized to guarantee unconditionally the payment of interest upon any bonds issued by the district pursuant to section 4 or section 12 hereof and to pledge its full faith and credit for the payment of the interest on any of such bonds so issued by the district; provided, however, that such guarantee shall not be extended for a period longer than 50 years from the date of issue of the bonds first issued by the district and guaran-

teed by the county of Lincoln: provided, further, that the county commissioners for the said county of Lincoln are hereby authorized to assess a tax to the towns of Westport and Wiscasset in said county of Lincoln for 33 1/3% of any sums the county of Lincoln is obligated to pay pursuant to its guarantee under this section; and all moneys which shall be raised for the purposes named in this act for which the county may lawfully raise money shall be assessed in the amount of 33 1/3% upon the taxable polls and estates embraced within the towns of Westport and Wiscasset by the assessors of Westport and Wiscasset in the same manner as is provided by law for the assessment of town and county taxes.'
