Orders of The Day

Mr. Clapp of Brooklin, was granted unanimous consent to address the House.

Mr. CLAPP: Mr. Speaker, I would like the unanimous consent of the House to present a resolve. This is for a check which a storekeeper down in my town cashed nineteen years ago in the amount of \$132. This is the only way I can see that this poor storekeeper can get his money, so I would like unanimous consent to present this resolve at this time.

The SPEAKER: The gentleman from Brooklin, Mr. Clapp, requests

unanimous consent for the introduction of a resolve. The Clerk will read the title of the resolve.

The CLERK: (reading) Resolve in Favor of Alfred M. Joyce of Brooklin (H. P. 2022)

The SPEAKER: Is there objection to the reception of the resolve? The Chair hears none and the resolve has been received by unanimous consent.

On motion by Mr. Clapp, the resolve was referred to the Committee on Claims and sent up for concurrence.

On motion by Mr. Boulier of Stacyville, the House voted to take from the table the 14th tabled and unassigned matter, Bill "An Act to Aid Small Woodland Owners" (S. P. 542) (L. D. 1182) tabled on March 16th by that gentleman pending third reading.

The SPEAKER: The Chair recognizes the gentleman from Stacyville, Mr. Boulier.

Mr. BOULIER: Mr. Speaker and Members of the House: This is one of those small bills that do not amount to very much and comes in with a unanimous report from the committee that it ought to pass. Now it only calls for an appropriation of \$30,000 for one year and \$29,-000 for the fiscal year 1950. All it proposes to do, as near as I can find out, is to send out various numbers of inspectors to inspect small land owners' woodlands and tell them whether or not they can cut their wood and how, and help them sell it. It might be good policy down in the southwestern portion of the State where they have already used it for a short time, but I do not think it is good for our section, because most people up in that territory where there are good woodlots have already sold their wood or else are keeping it, and they are in a pretty fair condition to know where and when and how they want to cut

I do not think this bill ought to pass for the simple reason they have too much money tied up in it and it takes too many inspectors

to run around. As I understand the bill, there is an equal amount of money coming from the Federal government to match this, and that will give them practically \$60,000 a year and that would hire eight or ten inspectors to run around and They call it an use State cars. educational proposition. A lot of these woodland owners, I think, no doubt, need education, but I think they are too contrary to accept it, the same as myself. I had rather cut it to suit myself than to have someone coming around and telling me how to do it.

Therefore, Mr. Speaker, I move that this bill be indefinitely postponed, and when the vote is taken I ask that it be taken by a division.

The SPEAKER: The gentleman from Stacyville, Mr. Boulier, moves that Bill "An Act to Aid Small Woodland Owners" (S. P. 542) (L. D. 1182) be indefinitely postponed, and asks that when the vote is taken it be taken by a division.

The Chair recognizes the gentleman from Wayne, Mr. Brown.

Mr. BROWN: Mr. Speaker and Members of the House: I did not think it would be necessary for me to rise this morning to defend this bill, but, due to the fact there is a motion before the House to indefinitely postpone it, I feel I must explain it the best I can.

This bill is designed to provide money enough to hire foresters who, on request of small land owners can go into a small woodlot and advise the farmer or woodlot owner as to the best possible way he can cut the merchantable timber out on his land, the best avenues of marketing, and generally assist the small woodland owners.

I think you will all agree with the fact that in the southerly or south-westerly part of the State there are many woodland owners just stripping their land, slashing it clean, cutting it clean, and getting all of their money out of it at one time. Whether or not that is good or bad for them is their problem, but I do feel that if they knew how to han-

dle their woodlot as a continuing crop, they could probably get money from that land each year to help pay their taxes and it would be money in their pocket to do it in that way rather than slash everything, the mature trees and the immature trees.

This is a bill to make this forestry practice statewide. In the southwestern part of Maine they have been doing it for the past number of years very successfully. The forester over in the southwestern part of the State ran into quite a lot of opposition at first, but after the farmers in that area and the small woodland owners found it was beneficial to them and it was money in their own pockets, they began to ask for the services of the State Forester.

There is nothing compulsory in this measure. The woodland owner has to request the services of the forester, and, on request, he will go in and mark the merchantable timber and advise the going market price and where it can best be sold to advantage.

This type of legislation is taking root all over the country. Just the other day, in the Christian Science Monitor of Friday, March 25th, I noticed this article. I would like to quote from an article written by Kate M. Archibald, special correspondent of the Christian Science Monitor. This has to do with the State of Washington. I quote from that article.

"Wood-lot forestry is the new word in this tree-growing area. The forester may be a farmer or the owner of a small timbered tract, but it is the little lumberman on whom attention is now focused—not the 'big lumberman' who, for good or ill, always has been in the spotlight."

Then it goes on and tells what they are doing in Washington. This had a lot of success out there. There is an article in Monday's Kennebec Journal having to do with the same subject at the University of Maine under the Extension Service I think it is too important a thing to indefinitely postpone. Whether or not the amount of money hitched to it is too great at this time, I am not in a position to say, but I do know that the Forestry Department has kept their appropriations down to the minimum of what they thought they needed to carry on their program.

This is not compulsory legislation; it merely gives the woodland owner an opportunity to have expert advice on his woodland, and it is to encourage him to use his woodlot as a continuing crop, the same as any other crop on his farm.

I hope that the motion of the gentleman from Stacyville, Mr. Bou-

lier, does not prevail.

The SPEAKER: The Chair recognizes the gentleman from Unity,

Mr. Brown.

Mr. BROWN: Mr. Speaker and Members of the House: I am ready to support the motion to indefinitely postpone. My reason for doing that is due to the fact that the Soil Conservation Service is now performing these various services, and all that one needs to do is call up the local conservation office and I am sure a forester will be out to attend to his wants immediately.

The SPEAKER: The Chair recognizes the gentleman from Stacy-

ville, Mr. Boulier.

Mr. BOULIER: Mr. Speaker, I would like to inform the members of this House that at any time they want assistance of that kind they can contact the University of Maine and the Extension Service, and they have a forester there who is perfectly willing and able to help any small land-owner. As a matter of fact, our present Forest Commissioner was in that capacity before he was appointed Forest Commissioner of the State of Maine.

The SPEAKER: The Chair recognizes the gentleman from Guilford, Mr. Campbell.

Mr. CAMPBELL: Mr. Speaker and Members of the House: I rise to support the motion of the gentleman from Stacyville, Mr. Boulier. I feel this would be an unnecessary expense.

The SPEAKER: The question before the House is on the motion of the gentleman from Stacyville, Mr. Boulier, that Bill "An Act to Aid Small Woodland Owners" (S. P. 542) (L. D. 1182) be indefinitely postponed.

Mr. BROWN of Unity: Mr. Speak-

er, I ask for a division.

The SPEAKER: The gentleman from Unity, Mr. Brown, asks for a division. Is the House ready for the question? As many as are in favor of the motion of the gentleman from Stacyville, Mr. Boulier, that the bill be indefinitely postponed will kindly rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Ninety-one having voted in the affirmative and fourteen having voted in the negative, the motion prevailed, and the bill was indefinitely postponed in non-concurrence and sent up for concurrence.

On motion by Miss Cormier of Rumford, House Rule 25 was suspended for the remainder of today's session, in order to permit smoking.

On motion by Mr. Brown of Baileyville, the House voted to take from the table the sixth tabled and unassigned matter, Resolve for Preliminary Investigation of Quoddy Project (H. P. 1764) (L. D. 1129) tabled on March 1st by that gentleman pending reference; and on motion by the same gentleman the resolve was referred to the Committee on Appropriations and Financial Affairs and sent up for concurrence.

The SPEAKER: The House is proceeding under Orders of the Day.

On motion by Mr. Farley of Biddeford, the House voted to take from the table the ninth tabled and unassigned matter, Bill "An Act Relating to the Use of the Public Streets and Highways and to the Power of Cities and Towns to Install Parking Meters" (H. P. 1509) (L. D. 816) tabled on March 9th by that gentleman pending assignment for third reading; and on further

motion by the same gentleman the Bill was assigned for third reading tomorrow morning.

The gentleman from South Portland, Mr. Spear, was granted unanimous consent to address the House.

Mr. SPEAR: Mr. Speaker, there is on display in the Hall of Flags, a model furnished by the government and sponsored by the Highway Department, showing the results of controlled traffic on city streets and the traffic on express ways. I noticed it there this morn-

ing and I wish to call it to the attention of the members in order that they may see this model in operation. It is quite fascinating and quite interesting.

The SPEAKER: If there be no further items of business to come before the House, the Clerk will read the notices.

On motion by Mr. Benn of Smyrna Mills,

Adjourned until 10:00 o'clock to-morrow morning.
