On further motion by the same gentleman, under suspension of the rules, the House voted to reconsider its action whereby it passed the resolve to be engrossed.

On motion by Mr. Robbins of Houlton, the House voted to take from the table the 48th tabled and unassigned matter, House Report "Ought to pass" in new draft (H. P. 2025) (L. D. 1414) of the Committee on Motor Vehicles on Bill "An Act relating to Overtaking and Passing School Busses" (H. P. 489) (L. D. 164) tabled by that gentleman on March 31st pending acceptance of report; and on further motion by the same gentleman, the "Ought to pass" in new draft report of the committee was accepted, and the new draft having already been printed, under suspension of the rules the bill was given its several readings and assigned for third reading on the next legislative day.

On motion by Mr. Dow of Falmouth, the House voted to take from the table the 40th tabled and unassigned matter, Bill "An Act

Appropriating Moneys for Anticipated Overdrafts in the Racing Commission Due to Insufficient Appropriations" (S. P. 607) (L. D. 1298) tabled on March 30th by that gentleman pending third reading; and, on further motion by the same gentleman, the bill was given its third reading, passed to be engrossed and sent up for concurrence.

On motion by Mr. Palmer of Nobleboro, the House voted to take from the table the 19th tabled and unassigned matter, House Report "Ought not to pass" of the Committee on Inland Fisheries and Game on Bill "An Act relating to Fishways" (H. P. 1472) (L. D. 835) tabled by that gentleman on March 23rd pending acceptance of report.

On motion by Mr. Johnston of Jefferson, the "Ought not to pass" report of the committee was accepted and sent up for concurrence.

On motion by Mr. Bearce of Caribou, the House voted to take from the table the 18th tabled and unassigned matter, House Report "Ought not to pass" of the Committee on Inland Fisheries and Game on Bill "An Act relative to Bounty on Foxes" (H. P. 1266) (L. D. 666) tabled on March 23rd by that gentleman pending acceptance of report.

On motion by Mr. Boulier of Stacyville, the House voted to substitute the bill for the report of the committee; and the bill was recommitted to the Committee on Agriculture and sent up for concurrence.
