On motion by Mr. Bubar of Blaine, the House voted to take from the table Item 13, Report of the Committee on Temperance on Bill "An Act to Provide for the Creation of a Liquor Research Commission" (S. P. 470) (L. D. 922) reporting "Ought to pass" as amended by Committee Amendment "A", tabled by that gentleman earlier in today's session pending acceptance of the committee report.

The SPEAKER: The Chair recognizes the gentleman from Auburn, Mr. White.

Mr. WHITE: Mr. Speaker, I move that S. P. 470, L. D. 922 be indefinitely postponed.

The SPEAKER: The gentleman from Auburn, Mr. White, moves that Bill "An Act to Provide for the Creation of a Liquor Research Commission" (S. P. 470) (L. D. 922) be indefinitely pestponed.

The Chair recognizes the gentleman from Portland, Mr. Roundy.

Mr. ROUNDY: Mr. Speaker, before we vote on what seems to be an important matter, it seems to me that in all our minds we should have just what this bill is that we are talking about, so I desire to read two or three sentences in relation to it.

"Liquor Research Commission Created"—that is Section 1.

"The governor, with the advice and consent of the council, shall appoint a liquor research commission consisting of 7 members and shall designate its chairman. Consideration in naming the commission shall be given to all interests concerned."

Now in regard to the duties, in the second section:

"Such commission shall make as complete and accurate a study as possible of the physiological, psychological, economic and social effects of the use of alcoholic beverages in this state. It shall study the latest methods used in the treatment and rehabilitation of alcoholics. It shall study and determine what institutions should be used or established for the care and rehabilitation of alcoholics. It shall study and determine what educational methods and programs should be used in the schools concerning alcohol."

It seems to me that if there is any reasonable proposition in the field of temperance that comes before us it is this one. It takes all interests into account. It gives to the Governor and Council the determination as to who shall be appointed on the commission that is to be appointed. The cost is at a minimum of \$10,000. It was first reported as \$5,000. This would be largely used by some special person under the direction of the commission who would find out the facts to be studied.

It seems to me at the present time when we are receiving a considerable amount of money from the sale of liquor in this State that we may well use a small amount of it to wisely and carefully and thoroughly, using time, make a study as to just what should be the future procedure so far as people like ourselves in the next Legislature shall find reasonable after this commission has made its careful and, I believe, valuable report.

The SPEAKER: The question before the House is on the motion of the gentleman from Auburn, Mr. White, that the report of the committee be indefinitely postponed.

The Chair recognizes the gentleman from Falmouth, Mr. Dow. Mr. DOW: Mr. Speaker, I just ask for information. Does that motion come ahead of the motion to table?

The SPEAKER: The gentleman is entitled to make a motion to table, if he sees fit.

Mr. DOW: Mr. Speaker, has not the motion to table already been put?

The SPEAKER: The Chair understands, Mr. Dow, that a motion to table was carried, but the gent... man who made the motion took the matter from the table, whereupon a motion to indefinitely postpone was made by the gentleman from Auburn, Mr. White, which is the pending question.

As many as are in favor of the motion of the gentleman from Auburn, Mr. White, that the "Ought to pass" report of the committee be indefinitely postponed, will say aye; those opposed no.

A viva voce vote being taken, the motion to indefinitely postpone did not prevail. Thereupon the "Ought to pass" report of the committee was accepted, and the Bill, having already been printed, under suspension of the rules was given its first reading.

The SPEAKER: The Chair recognizes the gentleman from Fort Fairfield, Mr. Dorsey.

Mr. DORSEY: Mr. Speaker, I move that S. P. 470, L. D. 922, Bill "An Act to Provide for the Creation of a Liquor Research Commission" and accompanying papers lie on the table and be specially assigned for Thursday morning.

The SPEAKER: The Chair will state that the rules have already been suspended, therefore we will have to proceed before entertaining the motion of the gentleman from Fort Fairfield.

Thereupon, the bill was given its second reading.

On motion by Mr. Dorsey of Fort Fairfield, the Bill and accompanying papers were tabled pending assignment for third reading. On motion by Mr. Campbell of Garland, the House voted to reconsider its action of April 1st whereby it adopted Committee Amendment "A" to S. P. 321, L. On further motion by the same gentleman, Committee Amendment "A" was indefinitely postponed.

Thereupon the Bill was given its third reading and passed to be engrossed in concurrence.

On motion by Mr. Campbell of Garland, the House voted to reconsider its action of April 1st whereby it adopted Committee Amendment "A" to S. P. 320, L. D. 513, Bill "An Act Relating to the Salaries of the Judge of Probate and Register of Probate, Franklin County."

On further motion by the same gentleman, Committee Amendment "A" was indefinitely postponed.

Thereupon the Bill was given its third reading and passed to be engrossed in concurrence.
