Orders of the Day

On motion by Mr. Haskell of Penobscot, the Senate voted to take from the table bill, An Act for the Assessment of a State Tax for the Year Nineteen Hundred Forty-nine and for the Year Nineteen Hundred Fifty (H. P. 25) (L. D. 79) tabled by that Senator on January 26 pending reference to a committee.

Mr. HASKELL of Penobscot: Mr. President, I now move that this bill be referred to the Committee on Taxation in non-concurrence and in support of that motion, I am privileged to say that the Committee on Appropriations have indicated their willingness that this bill be a taxation bill to permit us to have it heard along with other general tax measures.

Thereupon, the bill was referred to the Committee on Taxation in non-concurrence.

On motion by Mr. Baker of Kennebec, the Senate voted to reconsider its former action taken earlier this morning, whereby Bill An Act Increasing Tax Assessments of Dixfield Village Corporation (H. P. 137) (L. D. 43) was tomorrow assigned for second reading.

Mr. BAKER of Kennebec: Mr. President, this matter being an emergency measure and one of considerable importance to the members of the Dixfield Village Corporation, I now move that the bill be given its second reading at this time.

Thereupon, under suspension of the rules, the bill was given its second reading and passed to be engrossed in concurrence.

Mr. Haskell of Penobscot was granted unanimous consent to address the Senate.

Mr. HASKELL of Penobscot: Mr. President and members of the Senate, this is a very minor matter but there have been distributed on the desks of each member of the Senate these exemption certificates which those of you who use public transportation facilities in travelling to and from the state house, should use. While you are on state business you are entitled to exemption from the 15% transportation tax. It is clearly your right to use them. You must use a certificate each time you purchase your train fare ticket or plane ticket or what have you that is subject to transportation tax.

The Senate office has a good supply of these exemption certificates and those who want them may pick them up and use them.
