SENATE

Thursday, February 10, 1949
The Senate was called to order

by the President.

Prayer by the Reverend Leonard LeClair of Togus.

Journal of yesterday read and approved.

Mr. Boucher of Androscoggin was granted unanimous consent to address the Senate.

Mr. BOUCHER of Androscoggin: Mr. President, I am about to offer to this Senate and to the legislature. a Memorial to Congress. This Memorial to Congress concerns the recent arrest of Joseph Cardinal Mindszenty of Hungary. Do not think I am creating a precedent because if my recollection is correct, the Governor of this state has already made representation to the Congress on this matter. The Congressman from this district, this second district, has already spoken publicly in the hall of the House of Representatives of the Congress in that way of thinking, the American way of life, I think it is only proper that we, the legislature of Maine, take a position on this matter and ask our Congress in Washington to act on this matter.

Therefore I offer at this time, Mr. President and members of the Senate, the following Memorial:

STATE OF MAINE

In the Year of Our Lord One Thousand Nine Hundred and Forty Nine.

MEMORIAL

To the Honorable Senate and House of Representatives of the United States of America in Congress assembled:

We, your Memorialists, the Senate and House of Representatives of the State of Maine in the 94th Legislative Session assembled, most respectfully present and petition your Honorable Body as follows:

Whereas, Joseph Cardinal Mindszenty of Hungary was sentenced to life imprisonment by the government of Hungary; and

Whereas, we memorialists feel that such sentence threatens freedom of religion and speech; now, therefore, be it

Resolved: That we, your Memorialists, do hereby respectfully petition and urge the Members of Congress to take whatever action that can be taken to have the sentence imposed upon Joseph Cardinal Mindszenty of Hungary removed; and be it further

Resolved: That a copy of this Memorial, duly authenticated by the Secretary of State, be immediately transmitted by the Secretary of State, by registered mail, to the proper officers and committees of the United States Senate and House of Representatives, the President of the United States and to each of the Representatives and Senators representing the State of Maine in the United States Congress.

Thereupon, on motion by Mr. Boucher of Androscoggin, out of order and under suspension of the rules, the Memorial was received; and on further motion by the same Senator, the Memorial was adopted and sent forthwith to the House, without reference to a committee.

The Secretary read the Order:

ORDERED, the House concurring, that a Joint Select Committee be appointed consisting of 3 on the part of the Senate and 7 on the part of the House to study the need for revision of the joint rules with respect to joint rule number 1, which provides for the number and designation of the Joint Standing Committees of the Legislature.

The Committee shall report to the Legislature no later than 10 A.M. on March 2, 1949 and any recommendations which the Committee may make shall be with respect to the 95th Legislature.

The President of the Senate and the Speaker of the House shall be ex officio members of the Committee.

Mr. WARD of Penobscot: Mr. President, if this order should receive passage, it simply will call for a committee to make some study in regard to revision with respect to joint standing committees, which is a matter that has been discussed among the members off the record off and on for some time. We have 40 joint standing committees and as of yesterday it was my understanding that 1,285 measures have

been referred to those committees. Of that number of bills and resolves 342 have been referred to the Committee on Claims, 315 to the Committee on Ways and Bridges, which leaves a balance of 628 bills and resolves.

Twenty-four committees have received 44 of those bills, and the balance of 584 bills have gone to 14 of the other joint standing committees.
