On motion by Mr. McKusick of Piscataquis, the Senate voted to take from the table bill, An Act to Provide for the Surrender by Kingsbury Plantation of its Organization (H. P. 1168) (L. D. 595) tabled by that Senator on February 15 pending reference to a committee.

Mr. McKUSICK of Piscataquis: Mr. President, I now move that this bill be referred to the Committee on Towns in non-concurrence. I will say that it has been the customary procedure in past sessions to refer all de-organization legislation to the Committee on Towns, and as it happens, there is an adjacent township which is applying for de-organization which has already been referred to the Committee on Towns and I think it is desirable to have both on the same Committee.

Thereupon, the bill was referred to the Committee on Towns in non-concurrence.

On motion by Mr. Bowker of Cumberland, the Senate voted to take from the table bill, An Act Relative to Payment of Damage Caused by Collision Between Motor Vehicle and Deer (H. P. 1271) tabled by that Senator on February 15 pending reference to a committee.

Mr. BOWKER of Cumberland: Mr. President and members of the Senate, I feel that this bill should go to the Committee on Inland Fisheries and Game. I have talked with the Chairman of Claims to which the bill was referred, and I have also talked with the Committee on Reference of Bills and it is

perfectly all right with them. So, I now move that this bill be referred to the Committee on Inland Fisheries and Game.

Thereupon, the bill was referred to the Committee on Inland Fisheries and Game in non-concurrence, and ordered printed.

A division of the Senate was had. Twenty-eight having voted in the affirmative and none opposed, the bill was passed to be enacted.

On motion by Mr. Batchelder of York, the Senate voted to take from the table bill, An Act to Incorporate the Town of Penobscot School District (H. P. 889) (L. D. 308) tabled by that Senator on February 11 pending passage to be enacted; and that Senator moved that the bill be passed to be enacted.

This being an emergency measure A division of the Senate was had. Twenty-nine having voted in the affirmative and none opposed, the bill was passed to be enacted.

P. 331) tabled by that Senator on February 9 pending reference to a committee; and on further motion by the same Senator, the resolve was referred to the Committee on Ways and Bridges and ordered printed.
