On motion by Mr. Ward of Penobscot the Senate voted to take from the table Bill, An Act Relative to Careless Shooting of Human Beings (H. P. 1476) (L. D. 887) tabled by that Senator earlier in today's session pending reference.

Mr. WARD of Penobscot: Mr. President, in 1945 and again in 1945 similar legislation to this was presented to the legislature and these matters were referred to the Committee on Judiciary, and I move this bill be referred to the Committee on Judiciary in non-concurrence.

The motion prevailed and the bill was referred to the Committee on Judiciary in non-concurrence.

On motion by Mr. Ela of Somerset, the Senate voted to take from the table Bill, An Act Relative to Prosecutions of Inland Fisheries and Game Laws to be Published (S. P. 404) (L. D. 743) tabled by that Senator earlier in today's session pending consideration.

Mr. ELA of Somerset: Mr. President, I now move we recede from our former action whereby we referred this bill to the Committee on Judiciary and concur with the House by referring it to the Committee on Inland Fisheries and Game.

Mr. HASKELL of Penobscot: Mr. President, as every member of the Senate realizes, I am sure, there is nothing sacred about reference by the Committee on Reference of Bills. It is only a suggestion. But I would make this simple statement on the committee's feeling on that bill, and it is this: The bill, itself, provides for a new type of penalty for violation of our inland fish and game laws by providing that the name and offense shall be publicized. It was the feeling of the committee that a bill of that type that does put onto the statutes a new type of penalty—this happens to be fish and game but it could as well be any other type of law a citizen might break-should go to one of the legal committees. We could just as well have introduced a bill that provides that all drunken driving convictions be publicized. We could have a law to provide that any other type of conviction should be publicized. It was the thinking of the committee that when we come to that type of legislation it should have consideration by one of the legal committees.

I do not speak against the Senator from Somerset, Senator Ela's motion. I do explain the reference and I honestly believe it was a correct reference.

Mr. ELA: Mr. President, I wish to explain that the Committee on Inland Fisheries and Game has no particular feeling in this matter. We simply thought it would expedite matters to recede and concur. I conferred with the chairman of the Committee on Judiciary in the Neither of us has any matter. feeling in the matter, and whatever the Senate feels is proper we are happy to accept.

The PRESIDENT: The question before the Senate is on the motion the Senator from Somerset. of Senator Ela that the Senate recede from its former action whereby the bill was referred to the Committee on Judiciary, and concur with the House in reference of the bill to the Committee on Inland Fisheries and Game.

A viva voce vote being had, the motion prevailed and the bill was referred to the Committee on Inland Fisheries and Game in concurrence.

On motion by Mr. Sleeper of Knox, the Senate voted to take from the table Resolve in Favor of Atlantic Sea Run Salmon Commission (S. P. 322) tabled by that Senator on February 9th pending reference.

Mr. SLEEPER of Knox: President, I wish to apologize to you and the other members of the Senate for holding up this matter. I appeared before the Appropriations Committee with a resolve in favor of Atlantic Sea Run Salmon Commission and that powerful committee told me if I would make the resolve larger they would favor it. They were very generous. I prepared a resolve asking for \$60,000 instead of \$15,000. I dropped the bill in the hopper and now find it is referred to my own committee, which as everyone knows is a hollow honor. If the Appropriations Committee doesn't favor the bill it doesn't pass. I have seen several members of this before-mentioned powerful group and they still say if the Sea and Shore Fisheries Committee will have a hearing on it and pass it they will give us the money, and I move, Mr. President, the resolve be referred, as originally intended, to the Committee on Sea and Shore Fisheries.

The motion prevailed and the resolve was referred to the Committee on Sea and Shore Fisheries. Sent down for concurrence.

Mr. Haskell of Penobscot was granted unanimous consent to address the Senate.

Mr. HASKELL: Mr. President and members of the Senate, the last few words of the distinguished Senator from Knox, Senator Sleeper, reminds me that if all of us in the Senate who are committee chairmen would conscientiously read Joint Rule 19, I think we would greatly assist the Committee on Appropriations and Financial Affairs. Those people have the broad task of advising us, recommending to us, how much money should be appropriated by this legislature with reference to general funds, and I will read to you if I may, Joint Rule 19: "The several clerks of the committees to which are referred bills, orders or resolves involving the appropriation or expenditure of money shall forthwith, upon receipt of such bills, transmit a copy thereof, carrying endorsement of reference, to the Committee on Appropriations and Financial Affairs. No bill shall be in order for advertising for hearing or other procedure until such copy is so trans-The Appropriations Committed. mittee shall issue a printed report and tabulation of such bills weekly."

I confess my own guilt and I am sure nearly every committee chairman in the Senate shares that guilt with me, that we are not giving that information to the Committee on Appropriations and Financial Affairs. I think it would greatly assist their efforts and conversely greatly assist all the rest of us if we would carry out the intent of Joint Rule 19 because many of us have spending bills which are not referred to the Appropriations Committee, and certainly it is the only way they can assemble a rounded up summary of our financial problems. I urge the members that they do the thing provided for in Joint Rule 19. I hope in that thought the Appropriations Committee can carry out their intent, which is to tell all of us where we stand weekly with appropriations measures.

Mr. SAVAGE of Somerset: Mr. President, I'd like to concur with what the Senator from Penobscot. Senator Haskell, has said. It will facilitate matters in the Appropriations Committee as we do have all these bills before us. We are contemplating very shortly to get those bills in order so that we can give the legislature some sort of picture of just the amount of money we have, and we cannot give a picture unless the committee chairmen do give us all the bills they have in their committees which involve appropriations.

Pursuant to Joint Order, the Chair laid before the Senate, Resolve in Favor of the Town of Freeman (L. D. 356) recalled from the office of the Governor; and on motion by Mr. Crosby of Franklin, the Senate voted to reconsider its former action whereby the resolve was passed to be enacted; and on further motion by the same Senator under suspension of the rules, the Senate voted to reconsider its former action whereby the resolve was passed to be engrossed.

Thereupon, on motion by Mr. Crosby of Franklin, the resolve was recommitted to the Committee on Ways and Bridges.

Sent down for concurrence.

Mr. SLOCUM of Cumberland: Mr. President, I wish to inquire whether an act relative to legislation for amputee veterans has come over from the House?

The PRESIDENT: The Chair will state that it is not in the possession of the Senate at the moment.

Mr. SLOCUM: Mr. President, this is an emergency measure which would aid the amputee veterans in registering their vehicles without cost. These vehicles having been presented to the disabled veterans by the federal government. dead line for registration is March It is my understanding that the House is planning to suspend its rules and give this measure its several readings today in order that the bill may be sent to the Senate in time to be acted upon today for passage to be engrossed, thus giving us an opportunity to pass it to be enacted tomorrow in both branches of the legislature and send it to the governor. I don't know whether a request for a recess is in order but I believe that the House is planning such action on this emergency measure which would aid the amputee veterans and I request information from the Chair as to the proper procedure, believing this is going to pass the House and be sent forthwith to the Senate today.

The PRESIDENT: The Chair will state that the Senate may be at ease while the whereabouts of the bill are ascertained.

Mr. SLOCUM: Thank you, Mr. President.
