# Emergency Measure

Bill "An Act to Relieve Towns of Maintenance of State and State Aid Highways" (S. P. 454) (L. D. 770) Mr. BOUCHER of Androscoggin: Mr. President, I would like to say that I intend to make a motion, after I have said what I want to say to the Senate. When this bill was put through this Senate a few days ago under the guise of relief for towns I did not oppose the bill believing it was exactly what the title claimed it was, a relief for the towns only. After hearing discussion on the bill in the other Chamber, I find that we are facing an emergency tax measure. I am opposed to an emergency tax measure. I have been opposed to any emergency tax measure. I don't believe it is proper for any legislature to take away from the citizens of the state their right to repeal the imposition of a tax. I do not come from a small town. I come from a small city in comparison with larger cities but there are in the county of Androscoggin twelve small towns, and fairly good sized towns, who have supported me and I feel I represent them as well as the two cities in Androscoggin County. But I do not believe that

of the state. I believe that the best way to make laws, or to enforce laws, is the American way of doing it, the democratic way of doing it, by letting the people inform us what they desire. In this case we do not even give them a chance to inform us but we are trying to tell them and we are trying to push down their throats something they can't even repeal. I can't see the emergency at this time. The law that is now in effect, the tax law, will stay on the books of the state until September 1950 if my understanding is The emergency which has right. been claimed for this bill is said to

or any citizen of the state of Maine desires to remove the right of

be caused by the annual town meetings which will be held in the very near future. Some money will be available for 1949 and some money will be available and collected for 1950, for three quarters of the year 1950, and if a town, maybe in 1950, finds that this law is not in force or has been repealed by referendum, then they can act accordingly.

Great stress has been put on to the emergency of this bill. I want you Senators to understand that if there were no emergency clause on this bill I would vote for it. I do not care for that emergency. I despise it, because I don't believe, in my own conscience at least, that there is an emergency. My understanding of an emergency is something created, most of the time an act of God, which happens very suddenly and which you have to face and relieve immediately. I don't believe that the State of Maine is in that position. I don't believe that the highway department is in that position either. I have traveled over the roads and by-roads of the State of Maine for the best part of my life. I have seen great improvements in the last 25 years on the roads in Maine. I will grant you that through the war years nothing could be done but we have started to improve our roads the last few years and I am in favor of paying as you go for improving those roads and giving the citizens of Maine good roads but I am opposed to trying to do something behind their

backs, when they have no chance to express their opinions, and make them like it.

I do claim there is no emergency and for that reason I shall vote against this bill, and for that reason only. If the emergency clause were taken away I would vote for the passage of the bill and the town relief in the bill, because I believe that the relief given to those towns. the improvement of roads, warrants the keeping of the tax. That is the way I should explain it to the people who sent me here or the way I would attempt to explain it, but I couldn't explain to them my voting for doing away with that God given right of appeal that they have if they don't like a law. Therefore. Mr. President. I move that this bill be laid upon the table.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Androscoggin, Senator Boucher, that this bill be laid upon the table. Is the Senate ready for the question?

A viva voce being had

The motion to table did not prevail.

Thereupon, this bill being an emergency measure,

A division of the Senate was had. Twenty-seven having voted in the affirmative and four opposed, the bill was passed to be enacted.
