Mr. Allen presented Senate Amendment "A" and moved its adoption:

"Senate Amendment 'A' to H. P. 1253, L. D. 555. An Act Relating to the Issuance of Dealers Registration.

Amend said bill by adding at the end thereof the following: Section 2. R. S., c. 19, Sec. 19, additional. Section 19 of Chapter 19 of the revised statutes as amended by chapter 123 of the public laws of 1947. is hereby further amended by adding at the end thereof a new paragraph, as follows: The Secretary of State shall suspend without hearing such registration within 10 days of receipt of written notice from the company that the insurance policy or bond herein required has been cancelled. He shall likewise suspend said registration upon the expiration of the policy and shall not restore same until new certification of coverage is filed by the company.' "

Mr. ALLEN of Cumberland: Mr. President, I merely would like to explain to the members of the Senate that this was an error somewhere down the line, either with the committee or elsewhere. When the new draft came out. Legislative Document 555, this section of Document No. 188, which it was replacing, was inadvertently left out of the bill. The committee had no intention of making this change in the bill. This amendment merely puts back in Legislative Document 555 a section which was inadvertently left out.

Senate Amendment "A" was adopted, and the bill as so amended was passed to be engrossed, in non-concurrence.

Sent down for concurrence.

On motion by Mr. Ela of Somerset, the Senate voted to take from the table Bill, An Act Relative to Hatchery Employees in Classified Service (H. P. 1627) (L. D. 939), tabled by that Senator earlier in today's session pending reference; and on further motion by the same Senator the bill was referred to the Committee on Inland Fisheries and Game in concurrence.

On motion by Mr. Crosby of Franklin, the Senate voted to take from the table Resolve Appropriating Money for the Study and Control of the Spruce Budworm (H. P. 944) (L. D. 385) tabled by that Senator on February 23 pending passage to be engrossed; and that Senator presented Senate Amendment A and moved its adoption:

"Senate Amendment A to H. P. 944, L. D. 385. Amend said Resolve by inserting after the word 'appropriated' in the 5th line from the end thereof, the following words 'from the general fund'".

Which amendment was adopted and the resolve as amended was passed to be engrossed in non-concurrence.

Sent down for concurrence.

On motion by Mr. Ward of Penobscot, the Senate voted to take from the table bill, An Act Relating to Powers and Duties of Liquor Inspectors (S. P. 530) tabled by that Senator earlier in today's session pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on Judiciary and ordered printed.
