Mr. WILLIAMS: Mr. President, the Committee on Reference of Bills suggested that this bill be referred to the Committee on Appropriations and Financial Affairs. which was probably a proper reference, but similar bills of this type have been referred to the Committee on State Lands and Forest Preservation. In order that the Committee may take them all together I move this bill be referred to that committee. I will say that I have talked with the Committee on Reference of Bills and the Senate chairman of that committee. and it was agreeable to all these gentlemen.

Thereupon, the bill was referred to the Committee on State Lands and Forest Preservation, and ordered printed.

On motion by Mr. Ward of Penobscot, the Senate voted to take from the table House Report "Ought Not to Pass" from the Committee on Inland Fisheries and Game on Resolve Closing Sandy Stream Pond in T. 3, R. 9, Piscataquis County, to All Fishing (H. P. 289), tabled by that Senator on February 9th pending acceptance of the report, in concurrence.

Mr. WARD of Penobscot, Mr. President, I have talked with the chairman of the Committee on Inland Fisheries and Game and he is agreeable to have this matter recommitted to that committee for further consideration, so I move that this resolve be recommitted to the Committee on Inland Fisheries and Game.

Senate Amendment "A" to S. P. 473, L. D. 925, Bill "An Act Relating to Service Retirement Benefits for Airplane Pilots Who are Employed as Such by the State of Maine."

Amend said Bill by inserting before the headnote in the 1st line thereof and after the enacting clause, the following:

'Sec. 1.'

Further amend said Bill by striking out the last 2 words of the 1st sentence of that part designated as "V-A.", being the underlined words "forest commissioner", and inserting in place thereof the underlined words 'head of his department'.

Further amend said Bill by adding at the end thereof the following:

"Sec. 2. R. S., c. 60, § 6-A, sub-§ VI, amended. The last sentence of subsection VI of section 6-A of chapter 60 of the revised statutes, as revised by section 3 of chapter 384 of the public laws of 1947, is hereby amended to read as follows: 'In order to obtain the benefits of subsections III, IV and V of this section, the member must have attained the age of 55, must have served 25 years in one of these 3 services the above capacities, and anything to the contrary notwithstanding retirement is compulsory at attained age of 60.'"

Thereupon, on motion by the same Senator, the bill was tomorrow assigned for second reading and the amendment ordered printed.
