Wednesday, March 9, 1949

Orders of the Day

Mr. HOPKINS of Kennebec: Mr. President, I would like to inquire if L. D. 338, An Act Relating to Motor Vehicle Excise Tax for Amputee Veterans is in the possession of the Senate?

The PRESIDENT: The Chair will state that the bill is in the possession of the Senate.

Thereupon, on motion by Mr. Hopkins of Kennebec, the Senate voted to reconsider its former action taken on March 8 whereby the bill as amended by House Amendment B was passed to be engrossed; and on further motion by the same Senator, the Senate voted to reconsider its action whereby House Amendment B was adopted.

Mr. Hopkins of Kennebec presented Senate Amendment A to House Amendment B to Legislative Document 338 and moved its adoption.

"Senate Amendment A to House Amendment B to L. D. 338. Amend said amendment by striking out the underlined word 'not' in the 7th line of the underlined paragraph thereof."

Mr. HOPKINS of Kennebec: Mr. President, in explanation, may I say to the Senators that there appeared to be a defect in House Amendment B as it was adopted yesterday, in that it contained a double negative. This amendment is to correct House Amendment B.

Thereupon, Senate Amendment A to House Amendment B was adopted, House Amendment B as amended by Senate Amendment A was adopted, and on motion by Mr. Slocum of Cumberland, the bill was laid upon the table pending passage to be engrossed.

On motion by Mr. Bowker of Cumberland, the Senate voted to take from the table bill, An Act Appropriating Moneys for Child Welfare Services (S. P. 286) (L. D. 487) tabled by that Senator on March 8 pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed.

Mr. LEAVITT of Cumberland: Mr. President, first I wish to thank the Senator from Penobscot, Senator Haskell, for putting this bill on the table for me in my absence and also waiting until such time as I felt like talking on the subject. I think this morning perhaps would be a good time to talk about this matter.

While it is not absolutely impossible, as has been proven, to overturn a report from a committee as powerful as the Committee on Judiciary, I realize to try to turn over this report would be a difficult matter. Therefore, I do not intend to try to overturn the report. As soon as I get through talking I shall move for acceptance of the "Ought Not to Pass" report. However, I would like to explain to this Senate just what I am trying to get at.

In this State only about 50 per cent of those above 21 who are eligible to vote are even registered. That percentage carries not only in the big cities, of which we have very few, but out in rural districts. We have elections where less than 20 per cent of those registered, vote. Even in our presidential elections we have less than 70 per cent who vote.

I am concerned in getting these people to vote, to get them to register and vote, and it is not a concern of myself alone.

There have been a great many studies made. I have a book here devoted entirely to non-voting in the United States, studies of what should be done and how non-voting can be corrected. There are two thoughts on this subject. One is

that we must educate the people, yet the study of non-voting shows that educated people are the people who stay away from the polls to the greatest extent. Of course, we admit when we talk about the educated people we are talking about people educated in certain lines these people have and perhaps failed to study Civics and Government and allied subjects, so they do not know what a serious thing our government is. Each vote, although a small thing in itself, is like a snowflake. Snowflakes make drifts and only by everybody voting will we have a democratic government and a satisfactory government.

When we meet people on the street, as we all do every day, who say to us, "I do not like what you are doing in Augusta. I don't like the people who are elected. The people elected are all a bunch of crooks"—you meet them every day in the week. When you come back and say to them, "Who did you vote for?" they say "I didn't vote. It doesn't make any difference. There is no sense in my voting."

It seems to me some attempt should be made to bring to the attention of the people of Maine that people are not voting and that it is a dangerous situation. I don't know any way to educate the people. We have tried it in Maine for 120 or 130 years. We have not got very far in education. There are certain countries where they put in what they call "compulsory voting" laws, and in these countries they accept the principle that a vote is not only a duty but an obligation to citizenship, and in these countries, such as Australia, Belgium and Switzerland they have these laws which say "It is your duty to vote and it is your obligation just the same as it is your obligation to bear arms in the event you are invaded." We are all conscious of the fact the next invasion of the United States will not be an invasion from outside but an invasion from inside, Fifth Column, changes in ideology, minorities capturing different states in voting places.

Everybody admits-and I have talked with a great many people in England-that they would not have a socialist government if the people had voted. But there is a lethargy in England which has allowed this country to go for socialistic government. In Russia they have 190 million people controlled by a very small minority of less than 10 to 11 million people. How was it done? By organization-the Fifth Column working insíde until small group captured the country.

You say that cannot happen here. We hope it cannot but if people in this country continue to keep away from the polls consistently as they are apparently doing at the present time, it may happen here and that is the reason I presented this bill.

I will admit if I cannot convince ten men of the mental acumen that we have on the Judiciary Committee that this is a good bill, trying to convince this body is an impossibility, but nevertheless I want to bring to your attention that we have a serious situation and something, some day, has got to be done about it. I just hope that what I have done will add to what Senator Spear of Cumberland did in 1927 and 1929 when he had similar bills here. I hope that sometime in the dim future before something goes wrong, someone can come here in my place and offer a bill which we will have brains enough to pass.

Thereupon, on motion by Mr. Leavitt of Cumberland, the "Ought Not to Pass" report of the Committee was accepted.

Sent down for concurrence.

On motion by Mr. Ela of Somerset, the Senate voted to take from the table Senate Report "Ought Not to Pass" from the Committee on Judiciary on Resolve Proposing an Amendment to the Constitution Providing Authority to the Legislature to Require Compulsory Voting, (S. P. 261) (L. D. 392) tabled by that Senator on March 4 pending consideration of the report.

Mr. LEAVITT of Cumberland: Mr. President, this is a companion bill put into the legislature because I had an idea that if the Judiciary committee did consider this bill which I have just moved to have rejected, they might find that they thought the bill was unconstitutional and needed a constitutional amendment. This bill was put in as a companion to overcome that question. Where the first bill has died, this bill should also die and so I move that the Senate accept the "Ought Not to Pass" report.

The motion prevailed and the Senate accepted the "Ought Not to Pass" report of the committee.

Sent down for concurrence.

On motion by Mr. Slocum of Cumberland, the Senate voted to take from the table bill, An Act Relating to Motor Vehicle Excise Tax for Amputee Veterans (H. P. 862) (L. D. 338) tabled by that Senator earlier in today's session pending passage to be engrossed.

Mr. SLOCUM of Cumberland: Mr. President, I believe the Senator from Kennebec, Senator Hopkins, should be commended in finding an inadvertent double negative and correcting that language in the bill. The bill is, I believe, now properly worded to accomplish the end that we all desire, and I move that the bill as amended be passed to be engrossed.

The motion prevailed, and the bill was passed to be engrossed in non-concurrence.

Sent down for concurrence.
