Friday, March 18, 1949.

Mr. ELA of Somerset: Mr. President, I would like to inquire if Senate Paper 348, Legislative Document 574, "Resolve Appropriating Money to Improve the Approach to

the Fish Way at Aroostook Falls" is in the possession of the Senate?

The PRESIDENT: The Chair will state the bill is in the possession of the Senate, having been held at the request of the Senator from Somerset, Senator Ela.

Mr. ELA: Mr. President, I now move we reconsider our action of yesterday whereby this resolve was finally passed. In explanation of this, I will say there appears to be an error which needs correction. I have checked with the sponsor of the bill, Senator Collins, and he agrees the correction is necessary. I will later offer an amendment to correct the error.

The motion to reconsider final passage prevailed.

Thereupon, on further motion by the same Senator, the Senate voted to reconsider its action whereby the bill was passed to be engrossed.

Mr. Ela presented Senate Amendment "A" and moved its adoption:

"Senate Amendment 'A' to S. P. 348, L. D. 574, 'Resolve Appropriating Money to Improve the Approach to the Fish Way at Aroostook Falls'. Amend said Resolve by striking out all after the title and inserting in place thereof the fol-Resolves, 1947, c. lowing: amended. Resolved: That chapter 146 of the resolves of 1947 be, and hereby is, amended by adding at the end thereof a new paragraph to read as follows: 'All unexpended balances shall not lapse until June 30, 1951, but shall remain a continuing carrying account until June 30, 1951,"

Senate Amendment "A" was adopted, and the resolve as so amended was passed to be engrossed in non-concurrence.

Sent down for concurrence.

On motion by Mr. McKusick of Piscataquis, the Senate voted to take from the table Bill, An Act Relating to State Aid for Community Schools (S. P. 626) tabled by that Senator on March 17th pending reference.

Mr. McKUSICK: Mr. President, I tabled that bill yesterday in order to move that it be referred to the Committee on Legal Affairs. Although its title would seem to imply it was an educational bill, it does concern matters which would seem to be better handled by the Committee on Legal Affairs. It is simply an act making some changes and additions to the school bill passed by the legislature two years ago. The original bill was handled by the Committee on Legal Affairs and the changes in the bill are more or less of a legal nature. I have talked with some of the members of the Committee on Reference of Bills and they agree that is the committee to which it should go. I move the bill be referred to the Committee on Legal Affairs.

The motion prevailed and the bill was referred to the Committee on Legal Affairs, and ordered printed. Sent down for concurrence.

On motion by Mr. Slocum of Cumberland, the Senate voted to take from the table Bill, An Act Relating to Retirement Fund of State Employees in Armed Forces (H. P. 584) (L. D. 189) tabled by that Senator on March 10th pending enactment; and on further motion by the same Senator the bill was passed to be enacted.

On motion by Mr. Brewer of Aroostook, the Senate voted to take from the table House Report from the Committee on Appropriations and Financial Affairs on Resolve Providing for Certain Construction at the Bangor State Hospital (H. P. 632) (L. D. 1350) tabled by that Senator earlier in today's session pending acceptance of the committee report; and on further motion by the same Senator, the report of the committee was accepted in concurrence, the resolve was given its first reading and tomorrow assigned for second reading.

Mr. SLEEPER of Knox: Mr. President, I have permission of Senator Baker to take from the table the forty-second unassigned matter.

Thereupon, the Senate voted to take from the table Bill, An Act Re-Establishing Prohibition (H. P. 1975) (L. D. 1351) tabled by Mr. Baker of Kennebec on March 17th pending reference.

Mr. SLEEPER: Mr. President, the title of this bill and the thing it will attempt to establish is so obviously out of step with everything in line with the State, and in order to expedite our adjournment and save as much money as possible for the State in not thrashing around with windmills, I move this bill be indefinitely postponed.

The motion prevailed, and the bill was indefinitely postponed, in non-concurrence.
