SENATE

Tuesday, March 22, 1949.

The Senate was called to order by the President.

Prayer by the Reverend Robert Brackley of Hallowell.

Senate Committee Reports Ought Not to Pass

Mr. Hopkins from the Committee on Aeronautics on Bill "An Act Relating to the Aeronautical Bill," (S. P. 414) (L. D. 772) reported that the same ought not to pass.

(On motion by Mr. Allen of Cumberland, tabled pending consideration of the report.)

Mr. Ela from the same Committee on "Resolve Proposing an Amendment to the Constitution to Authorize a Bond Issue to Match Federal Funds for the Construc-

tion and Improvement of Airports," (S. P. 415) (L. D. 773) reported that the same ought not to pass.

(On motion by Mr. Allen of Cumberland, tabled pending consideration of the report.)

Mr. Smart from the Committee on Inland Fisheries and Game on Bill "An Act Relative to Search and Seizure of Game," (S. P. 425) (L. D. 830) reported that the same ought not to pass.

Which report was read and accepted.

Sent down for concurrence.

Mr. Bowker from the same Committee on Bill "An Act to Reduce Fatalities and Firearm Accidents in the Woods and Fields of Maine," (S. P. 540) (L. D. 1180) reported that the same ought not to pass.

Mr. SLOCUM of Cumberland: Mr. President, I introduced this measure at the request of Major Linwood Elliott of Falmouth. It was an attempt to educate the men going into the woods by having them take an examination before they got a license to hunt. The number of fatalities was so great this last year that it is the opinion of Major Elliott and myself that something should be done. Major Elliott presented the facts in a masterful way before the committee. The committee, however, considered that the method was impractical. It is hoped that the members of the Senate and other citizens will try to find some way of reducing the fatalities during our coming season, and with regret that some practical method could not have been worked out by the committee. I move that the committee report "Ought Not to Pass" be accepted.

Thereupon the "Ought Not to Pass" report of the committee was accepted.

OTP New Draft

Mr. Ela from the Committee on Inland Fisheries and Game on Bill "An Act Relative to Extending Hunting Season on Deer," (S. P. 300) (L. D. 494) reported the same in a new draft, and (S. P. 630) under the same title, and that it ought to pass.

Which report was read and accepted, and the bill in new draft laid upon the table for printing under the joint rules.

Mr. Haskell from the Committee on Taxation on Bill "An Act Relating to Sub-Jobber of Cigarettes and Tobacco Products," (S. P. 238) (L. D. 352) reported that the same ought to pass as amended by Committee Amendment "A"

Which report was read and accepted and the bill read once.

The Secretary read Committee Amendment A:—

"Committee Amendment A to bill, An Act Relating to Sub-Jobber of Cigarettes and Tobacco Products (S. P. 238) (L. D. 352). Amend said bill by inserting in 5th line thereof after the underlined word 'license' the following underlined words: 'to be known as a wholesale dealers' license'."

Committee Amendment A was adopted and the bill as so amended

was tomorrow assigned for second reading.

On motion by Mr. Leavitt of Cumberland the bill was laid upon the table pending passage to be engrossed.

Orders of The Day

Mr. HASKELL of Penobscot: Mr. President, I am about to ask unanimous consent to introduce a resolve. I think it is the first time since I have been in the Legislature that I have done this. The story quite briefly is this: Yesterday morning in this Chamber, the wife of Frank McGinley came in and told Senator Baker and myself the problem that she and her husband were facing in relation to a technicality in the Teachers' Pension law, and she had been advised only yesterday morning that even for consideration of the problem there must be a legislative resolve. I have been to the Chairman of the Committee on Pensions and he told me that it would in no way hold up his work. I therefore ask unanimous consent to introduce "Resolve in favor of Frank F. McGinley of Eddington."

Thereupon the resolve was received by unanimous consent, and on motion by the same Senator was referred to the Committee on Pensions.

Mr LARRABEE of Sagadahoc: Mr. President, I too have a Resolve which was brought to my attention last Saturday relating to a very deserving case. I have had several calls from church people and from the City of Bath, and I would ask unanimous consent to introduce "Resolve Providing a State Pension for Margarite Hilda Reed of Bath."

Thereupon the Resolve was received by unanimous consent, and on motion by the same Senator was referred to the Committee on Pensions.

Mr. Collins of Aroostook was granted unanimous consent to address the Senate.

Mr. COLLINS of Aroostook: Mr. President and members of the Senate: I note in the balcony members of the Civics Class from the Fort Kent Community High School. As you know, the Community High School at Fort Kent was the first school that was established under the Community School Act, and these people have travelled over three hundred miles to attend a session of the legislature and to learn about the working of State Government. Therefore I hope the Senate will take recognition of that fact at this time.

The PRESIDENT: The Chair is very pleased, on behalf of the Senate, to greet the class from Fort Kent. We hope that their long journey will be rewarded by a very fine presentation of our Legislative

procedure by both Branches. (Applause)

Mr. SLEEPER of Knox: Mr. President, I would like to inquire whether H. P. 1975, L. D. 1351, "An Act Reestablishing Prohibition," is still in the possession of the Senate.

The PRESIDENT: The Chair will state that the bill is in the possession of the Senate being held at the request of the Senator from Knox for reconsideration.

Mr. SLEEPER: Mr. President and members of the Senate, I find that in the rather hasty action which the Senate took in order to expedite legislation that we had presupposed the minds of the proponents of this bill, and we did not understand that there was quite so much feeling. I find, much to our sorrow and shame, that in prohibiting a hearing on prohibition we are following down the same line that made prohibition so unpopular.

It was not the idea of doing away with liquor and intoxicating beverages that was so unpopular, but it was the prohibition part of it that people objected to, and I find that the proponents of this measure object very much to the prohibition of the hearing on prohibition, so I now move that the Senate reconsider its action whereby the bill was indefinitely postponed and that the bill be referred to the Committee on Temperance and a hearing be given on this apparently worthy bill.

Thereupon the Senate voted to reconsider its former action whereby the bill was indefinitely postponed, and on further motion by the same Senator the bill was referred to the Committee on Temperance and ordered printed.

On motion by Mr. Haskell of Penobscot the Senate voted to take from the table Emergency Measure "An Act Relating to Maine Forestry District Taxes" (H. P. 1586) (L. D. 908), tabled by the Senator from Somerset, Senator Savage, on March 18th, pending passage to be enacted. Mr. HASKELL: Mr. President, I will assure the Senate that I have permission from Senator Savage, who is ill, to take this bill from the table, and I now move the bill be passed to be enacted.

This being an emergency measure

A division of the Senate was had. Twenty four having voted in the affirmative, and none opposed, the bill was passed to be enacted.

On motion by Mr. Slocum of Cumberland, the Senate voted to take from the table Senate Report "Ought not to pass" from the Committee on Judiclary on Bill, "An Act Relating to Telephones for Members of the State Police." (S. P. 523) (L. D. 1051) tabled by that Senator on March 18, pending consideration of the report.

Mr. SLOCUM of Cumberland: Mr. President, the members of our State Police are required to have a telephone in their homes as a part of their equipment. They are on twenty-four hour a day service and they get very moderate pay. I am informed that there is before this Body a bill to give them an adequate wage, and that in effect would assist in taking care of the intent of this bill. I therefore move that we accept the Ought Not to Pass report of the Committee.

Thereupon the Senate voted to accept the Ought Not to Pass report of the Committee on Judiciary.

On motion by Mr. Brewer of Aroostook, the Senate voted to take from the table Bill, "An Act Relating to the Tax on Commercial Fertilizer." (S. P. 284) (L. D. 485), tabled by that Senator on March 8th pending passage to be engrossed.

Mr. BREWER of Aroostook: Mr. President and Members of the Senate, due to the fact that this particular bill involves raising new revenue, and the question was raised that it should come from the House, and due to the fact that a similar bill was introduced in the House by another member of the Aroostook delegation, I would ask at this time leave to withdraw the bill.

Thereupon leave was granted to withdraw the bill.

On motion by Mr. Leavitt of Cumberland,

Adjourned until tomorrow at ten o'clock.
