# Wednesday, March 30, 1949

The Senate was called to order by the President.

Prayer by the Reverend Wallace H. Harris of Lewiston.

Journal of yesterday read and approved.

### Order (Out of Order)

On motion by Mr. Turgeon of Androscoggin, out of order and under suspension of the rules, it was

ORDERED, that Elsie Burgess of Edward Little High School, Auburn, and Marjorie LeClair of Lewiston High School, Lewiston, are hereby appointed Honorary Pages pro tem of the Senate during today's session.

Thereupon, the Sergeant at Arms and the Assistant Sergeant at Arms escorted Miss Else Burgess of Auburn and Miss Marjorie Le-Clair of Lewiston to their positions as Honorary Pages of the Senate.

The PRESIDENT: The Chair notes at this time in the Senate balcony the presence of the senior class of Brooks High School and on behalf of the Senate, the Chair makes this group welcome here today.

Mr. Turgeon of Androscoggin was granted unanimous consent to address the Senate.

Mr. TURGEON of Androscoggin: Mr. President and members of the Senate, this being Androscoggin Day, it is only proper to outline a brief history of our county.

Ninety-five years ago, my county—Androscoggin—was incorporated. In fact, it was on March 18th—95 years, almost to the very day. At that time, Androscoggin County stood at the threshold of a tremendous industrial era, for the shoe plants and textile mills we know today were beginning to take shape along our waterways.

Ninety-five years later, Androscoggin County can now boast of two cities, Lewiston and Auburn, and the towns of Durham, Greene,

Leeds, Lisbon, Livermore, Livermore Falls, Mechanic Falls, Minot, Poland, Turner, Wales and Webster.

In our 459 square miles of Maineland are produced each year hundreds of millions of yards of cotton, rayon and woolen cloth; millions of pairs of shoes, and additional millions of pounds of paper. Beyond these outstanding products of our county, we turn out a large variety of lesser-known, but equally important commodities. Wooden ducts, brass and iron castings, paint products, liquids . . . some of the clearest water on the face of the earth, household goods such brooms, beds and rugs . . . furs, incense and chemicals.

Yes, the list is almost endless, for Androscoggin County is the industrial heart of Maine. And so, it's with a great deal of pleasure that we invite you to join us today in our second annual . . . and bigger and better than ever, . . . Androscoggin County Day.

The PRESIDENT: I am sure it is very fitting that the Senator has brought to our attention the very many great things that Androscoggin produces, among which, it produces outstanding statesmen. It is with a great deal of pleasure that the Chair invites the Senator from Androscoggin, Senator Boutin to preside over the Senate during Androscoggin Day.

Thereupon, Mr. Boutin of Androscoggin was escorted to the rostrum, the President retiring.

Mr. ALLEN of Cumberland: Mr. President and members of the Senate, this bill was heard before the Committee on Appropriations and Financial Affairs. It called for \$25,-000, 90% of which would come from the General Highway fund and 10% from the General fund. The Appropriations Committee questioned me three times down there as to why the bill was before them in view of the fact that 90% was coming from the highway fund, which is under the jurisdiction of the Ways and Bridges committee. Therefore, rather than debate the bill at this time, and in view of the feeling of the Committee on Appropriations and Financial Affairs. I think this matter should be referred to the Committee on Ways and Bridges, and I so move.

The motion prevailed and the resolve was referred to the Committee on Ways and Bridges.

Sent down for concurrence.

Mr. Leavitt of Cumberland was granted unanimous consent to address the Senate.

Mr. LEAVITT: Mr. President and members of the Senate, I have been asked by the county commissioners of Cumberland County to present a bill at this time to the legislature to enable them to procure the authority to borrow \$150,000 to repair two bridges in Cumberland County. I have talked with the committee to which this would be referred, the Committee on Legal Affairs, and it will not delay the legislature. It will do something which is very

necessary in Portland harbor and I feel it is very important that it come into this legislature. I ask unanimous consent to present this bill.

Unanimous consent was granted for the introduction of Bill, An Act to Authorize the County Commissioners of Cumberland County to Issue Bonds for Bridge Repairs.

On further motion by Mr. Leavitt, the bill was referred to the Committee on Legal Affairs, and ordered printed.

Sent down for concurrence.

The PRESIDENT: The Senate is proceeding under Orders of the Day. Is there further business to come before the Senate?

Mr. BARNES of Aroostook: Mr. President, there is an item on the House calendar under enactors. relative to authority to various counties to assess taxes for the present year and I have understood that as soon as it is reached in the House it will come over to the Senate and I think it is important that it be acted upon because if it is delayed beyond tomorrow there will have to be an amendment added to permit assessment of taxes during the month of April. I therefore move that we recess for a short length of time.

The motion to recess prevailed.
