SENATE

Thursday, March 31, 1949

The Senate was called to order by the President.

Prayer by the Reverend William T. Bennett of Richmond.

Journal of yesterday read and approved.

From the House

Bill "An Act to Aid Small Woodland Owners." (S. P. 542) (L. D. 1182)

(In the Senate on March 11th, passed to be engrossed.)

Comes from the House, report accepted in concurrence, and subsequently the bill was indefinitely postponed in non-concurrence.

In the Senate, on motion by Mr. Williams of Penobscot the Senate voted to insist on its former action taken on March 11 and ask for a Committee of Conference.

Bill "An Act Relating to Fees of Deputy Sheriffs." (S. P. 121) (L. D. 142)

In the Senate, on March 29th passed to be engrossed as amended by Senate Amendment "A" in non-concurrence.)

Comes from the House, recommitted to the Committee on Salaries and Fees in non-concurrence.

In the Senate, on motion by Mr. Baker of Kennebec, the Senate voted to reconsider its former action whereby the bill was passed to be engrossed; and on further motion by the same Senator, the bill was recommitted to the Committee on Salaries and Fees in concurrence.

House Committee Reports

The Committee on Inland Fisheries and Game on Bill "An Act Relating to Hunting and Fishing Licenses for Certain Persons," (H. P. 284) (L. D. 80) reported that the same ought not to pass.

The same Committee on "Resolve Regulating Fishing in Moosehead Lake in the County of Piscataquis," (H. P. 1140) (L. D. 600) reported that leave be granted to withdraw the same.

The Committee on State Lands and Forest Preservation on "Resolve Authorizing the Forest Commissioner to Convey Land in Plantation of Molunkus," (H. P. 1199) (L. D. 593) reported that leave be granted to withdraw the same.

Which reports were severally read and accepted in concurrence.

The Committee on Taxation on Bill "An Act Relating to Excise Tax in Lieu of Personal Property Tax on Aircraft," (H. P. 1806) (L. D. 1147) reported the same in a new draft, (H. P. 2021) (L. D. 1407) under the same title and that it ought to pass.

Which report was read and accepted in concurrence, and the bill in new draft read once and tomorrow assigned for second reading.

The Committee on Inland Fisheries and Game on "Resolve to Open Perry Pond, Aroostook County, to Ice Fishing," (H. P. 1393) (L. D. 726) reported the same in a new draft, (H. P. 2019) (L. D. 1405) under a new title, "Resolve to Open Plunkett Pond, Aroostook County, to Ice Fishing," and that it ought to pass.

Which report was read and accepted in concurrence, and the bill in new draft and under a new title was read once and tomorrow assigned for second reading.

The Committee on Legal Affairs on Bill "An Act Relating to the Use of the Public Schools and Highways and to the Power of Cities and Towns to Install Parking Meters," (H. P. 1509) (L. D. 816) reported that the same ought to pass as amended by Committee Amendment "A".

Which report was read and accepted in concurrence and the bill read once; Committee Amendment "A" was read and adopted in concurrence, and the bill as amended was tomorrow assigned for second reading.

The same Senator from the same Committee on "Resolve in Favor of Mrs. Ethel M. Rodigross, of Newburyport, Massachusetts," (S. P. 69) reported that the same ought not to pass.

Mr. Barnes from the Committee on Judiciary on Bill "An Act Relating to Actions for Injuries Causing Immediate Death," (S. P. 577) (L. D. 1240) reported that the same ought not to pass.

The same Senator from the same Committee on Bill "An Act Relating to Responsibility of Parents and Guardians for Crimes of Minors," (S. P. 547) (L. D. 1167) reported that the same ought not to pass.

Mr. Baker from the Committee on Legal Affairs on Bill "An Act Relating to a Department of Buildings," (S. P. 594) (L. D. 1265) reported that the same ought not to pass.

The same Senator from the same Committee on Bill "An Act Creating a Recreation Director for the City of Lewiston," (S. P. 580) (L. D. 1242) reported that leave be granted to withdraw.

The same Senator from the same Committee on Bill "An Act Relating to Removal of Town Managers," (S. P. 548) (L. D. 1169) reported that leave be granted to withdraw the same.

Mr. Ela from the Committee on Judiciary on Bill "An Act Relating to Responsibility of Parents and Guardians for Torts of Minors," (S. P. 546) (L. D. 1168) reported that the same ought not to pass.

SLOCUM of Cumberland: Mr. President, this bill was introduced at the request of a number of people who felt that there should be some way of collecting from parents for damage done to property by minors. The hearing was held and none of these interested parties appeared. However, it would seem that fromthe information gleaned from the members of the committee, something in the future should be done to protect the innocent taxpayer from the damage caused to their property by irresponsible minors. An ethical parent, of course, does take care of such damage when it has been done by their children.

At this time, I believe that no further action should be taken and I move that the Senate accept the "Ought Not to Pass" report of the committee.

The motion prevailed and the "Ought Not to Pass" report of the committee was accepted.

Sent down for concurrence.

Mr. Ward from the same Committee on Bill "An Act Relating to Lawful Use of Force," (S. P. 431) (L. D. 782) reported that the same ought to pass.

Mr. SLOCUM of Cumberland: Mr. President, this is the famous "spank" bill so-called. It came out at the committee hearing that parents and guardians have the right to chastise children, and that teachers stand in the position of loco parentis during school hours and do have a right of corporal punishment. It was the opinion of the committee if I interpreted it

correctly that this was unnecessary legislation as that is the law today even though it may be common law.

Since it is the law, then of course it is unnecessary that we again put it on the statutes and I move the acceptance of the "Ought Not to Pass" report of the committee.

The motion prevailed and the "Ought Not to Pass" report was accepted.

Sent down for concurrence.

Mr. Batchelder from the same Committee on Bill "An Act to Create an Industrial Safety Code Commission," (S. P. 379) (L. D. 645) reported that the same ought not to pass.

Mr. Edwards from the same Committee on Bill "An Act Relating to Possession of Chattel Property," (S. P. 435) (L. D. 789) reported that the same ought not to pass.

Mr. Noyes from the Committee on Motor Vehicles on Bill "An Act Designating the Counties of Maine on Motor Vehicle Registration Plates," (S. P. 583) (L. D. 1251) reported that leave be granted to withdraw.

The same Senator from the same Committee on Bill "An Act Relating to the Salary of the Register of Probate and Clerk Hire in Office of Register of Probate in Androscoggin County," (S. P. 554) (L. D. 1177) reported that the same ought to pass as amended by Committee Amendment A enclosed herewith.

Which report was read and accepted and the bill was given its first reading. The Secretary read Committee Amendment A.

"Committee Amendment A to L. D. 1177: Amend said bill by striking out after the enacting clause and before the headnote, 'Section 1.' Further amend said bill by striking out all of Section 2 thereof."

Which amendment was adopted and the bill as so amended was tomorrow assigned for second reading.

Mr. Smart from the Committee on Temperance on Bill "An Act Relating to Certificate of Approval for Brewers," (S. P. 531) (L. D. 1061) reported that the same ought to pass as amended by Committee Amendment A.

Which report was read and accepted and the bill was given its first reading.

The Secretary read Committee Amendment A.

"Committee Amendment A to L. D. 1061. Amend said bill by striking out in the 5th and 6th lines the underlined words "including contracts and dealings with whole-salers"."

Which amendment was adopted and the bill as so amended was tomorrow assigned for second reading.

The Majority of the Committee on Towns on Bill "An Act Relating to Use of Excise Tax on Motor Vehicles," (S. P. 325) (L. D. 517) reported that the same ought not to pass.

Orders of the Day

On motion by Mr. Slocum of Cumberland, the Senate voted to take from the table Senate Report "Ought to Pass" with Committee Amendment 'A' from the Committee on Temperance on Bill, An Act to Provide for the Creation of a Liquor Research Commission (S. P. 470) (L. D. 922) tabled by that Senator on March 25th pending consideration of the report; and on further motion by the same Senator, the report of the committee was accepted and the bill was given its first reading.

The Secretary read Committee Amendment "A":

"Committee Amendment 'A' to Bill, An Act to Provide for the Creation of a Liquor Research Commission (S. P. 470) (L. D. 922) Amend said bill by inserting in the twelfth line after the word 'determine' the words 'and recommend'. Further amend said bill by striking out in the next to the last line the figures '5,000' and inserting in place thereof the figures '10,000'."

Committee Amendment "A" was adopted, and the bill as amended was tomorrow assigned for second reading.

On motion by Mr. Bowker of Cumberland, the Senate voted to take from the table Bill, An Act to Appropriate Moneys for the Expenditures of the State Government for the Fiscal Year Ending June 30, 1949 (H. P. 1110) (L. D. 536) tabled by that Senator on March 28th pending enactment.

This being an emergency measure, a division of the Senate was had. Twenty-five having voted in the affirmative and none opposed, the bill was passed to be enacted.

On motion by Mr. Cobb of Oxford, the Senate voted to take from the table House Report "Ought Not to Pass as Covered by Other Legislation" from the Committee on Judiciary on Resolve Proposing an Amendment to the Constitution Relating to Education (H. P. 1697) (L. D. 1020) tabled by that Senator on March 30th pending consideration of the report; and on further motion by the same Senator, the report of the committee was accepted, in concurrence.

On motion by Mr. Savage of Somerset, the Senate voted to take from the table Resolve Reimbursing Certain Towns for Losses Incurred During Forest Fires of 1947 (S. P. 569) (L. D. 1234) tabled by that Senator on March 30th pending final passage; and on further motion by the same Senator, the resolve was finally passed.

On motion by Mr. Sleeper of Knox
