Friday, January 26, 1951

The Senate was called to order by the President.

Prayer by the Reverend Edna L.

Knowlton of Augusta.

Mr. ALLEN of Cumberland: Mr. President and members of the Senate, I rise on this occasion to move for the indefinite postponement of this order, and in moving for the indefinite postponement, I would state my reasons are thus: My experience in the time I have been in the legislature has led me to believe that this order causes more trouble than it causes good.

In the past two years I have had many persons come to me wanting to borrow my copy of the State Employees Salary List. I appreciate the fact that these people are members of a public service and their salaries, in a sense, are public business. I do not follow the reasoning that the salary of each and every employee should be spread from one end of the state to the other to be compared by other employees who may be jealous of their rating. Their salaries should be available to members of this legislature and to people who are entitled to know what they are earning.

This order, last year for the first time, provided for extra copies to be printed and sold at a price, I believe, of a dollar each. 85% to 90% of them were sold to subordinates in various state departments and from what I can gather, I would estimate the cost of this particular order not only would amount to between five and eight hundred dollars this year, but probably would cost the State of Maine in a loss of morale among its employees, perhaps as much as ten thousand dollars.

I think anything that is good about this order is far out-weighed by the problems and by the evils that its passage would insure. I certainly hope the Senate will agree with me in moving for the indefinite postponement of this order.

Mr. NOYES of Hancock: President, noting the many vacant chairs in the Senate, I will move that this order be tabled especially assigned for Tuesday next.

The motion prevailed and the order was laid upon the table pending motion by Mr. Allen of Cumberland to indefinitely postpone, and especially assigned for Tuesday next.

Mr. LEAVITT of Cumberland: Mr. President and members of the Senate, the Chairman of the Appropriations Committee, Senator Brewer, has asked me if I would make a very short statement as to the progress of that committee. We have to date had five public hearings and have heard twenty three department agencies. The total budget as requested, amounts to about forty million dollars in the general fund per year. From the agencies which we have already heard, aggregate requests the amount to about twenty one million dollars. This would seem to show that we are half way through our work and of course you all know we are not, but we have heard the agencies which are requestion one half, at least of the money that has been asked. We have had no executive sessions up to the present time, but I cannot see from the questions that have been asked and the answers we have received, that the final report will be very far away from the budget requests.
