Orders of the Day

Brewer On motion by Mr. of Aroostook, the Senate voted to take from the table Joint Order Relative to List of Salaries of State Employees (H. P. 371) tabled by that Senator on January 30 pending motion by the Senator from Cumberland, Senator Allen, that the Order be indefinitely postponed.

Mr. BREWER of Aroostook: Mr. President and members of the Senate, I tabled this item, which is a Joint Order, for two reasons; first, the cost of publication and compiling, and secondly, that in the past this salary list has been known to have been used as a scandal sheet.

I tried to talk the members of the House out of asking for this booklet but many of them feel that it is important in their work on committees where salaries have to be taken into consideration, and they felt it was important enough so that if we did kill it in the Senate, they would put through a House Order granting such a privilege.

So rather than antagonize anybody I have taken this matter up with the Senator from Cumber-land, Senator Allen, and you will notice that on the original one, the order calls for around 463 copies. We have cut that down to about 250, one for each member of the Senate and House, five each to the Clerk and Secretary, and ten to the library. Previously, the Secretary and Clerk had ten each and the library thirty. Under this setup I believe it won't be used too promiscuously and I now offer Senate Amendment A and move its

The Secretary read the amendment:

"Senate Amendment A to JOINT ORDER Relative to List of Salaries of State Employees (H. P. 371) Amend said order by deleting from the second line thereof the words and figures, 'four hundred sixtyeight (468)' and inserting in place thereof the words and figures, 'two hundred fifty (250).'

Further amend said order by deleting from the 5th line thereof the words and figures 'two (2)' and inserting in place thereof the words and figures 'one (1)' and from the 7th line thereof the words and figures 'ten (10)' and inserting in place thereof the words and figures five (5)' and from the 8th line thereof the words and figures 'thirty (30)' and inserting in place thereof the words and figures 'ten (10)"."

Which amendment was adopted. The PRESIDENT: The pending question before the Senate at this time is the motion of the Senator from Cumberland, Senator Allen, for indefinite postponement of the order.

Mr. BOYKER of Oxford: President, if the purpose of those who object to this order is in the name of economy, I want to say I am an advocate of economy and there are many ways in our department of state to practice economy. Nothing, it seems to me, is greater or more pleasing a favor to the taxpayers of our state than to take a few dollars of their money to provide for information as to where their money goes.

Who are they who oppose this order? Is it the taxpayers of our state? No. Is it our state employees? No. Our state employees know that in our democratic form of government their salaries are not the same and never will be unless we lead ourselves into a dictator form of government, and government control is not the answer to our state problems. I would like to see this order accepted.

Mr. ALLEN of Cumberland: Mr. President and members of the Senate, I rise only to clarify my own position in view of the fact that a week ago Friday, about one-third of the Senate was missing when we discussed this Joint Order, and if possible to withdraw my motion; if not, to recommend that the Senate pass the amended Order, contrary to my original motion before the Senate at this time.

I still feel that this order is not a good idea. I still feel, as I stated a week ago Friday, that it causes a lot of trouble in our state departments, costs the state ten, fifteen, or twenty thousand dollars, if you want to look at it from the point of view of state employee morale, and as I said a week ago Friday, of one hundred copies sold in the clerk's office, ninety were sold to department employees. I know in the last two years, people have come to me in Portland and asked to look at my copy or borrow it for the purpose of comparing what they got with what someone else got.

The legislature has always had the opportunity to go down to the proper office in the state house and find out what John Jones or Mary Jones makes. There is nothing secret about the salaries of employees of the State of Maine but when you come to publish them and spread them from one end of the state to the other, I think it is unwise. I think the experience of the legislature in publishing these salaries has been very unfortunate. I regret that we are doing it again this year. I think Senator Brewer has stated the facts very clearly. It is not the most important issue before us and in the amended form I would go along very reluctantly with this order and hope that my motion does not prevail.

The PRESIDENT: Is it the understanding of the Chair that the Senator from Cumberland, Senator Allen, wishes to withdraw his motion?

Mr. ALLEN: Yes, sir I would like to do that.

There being no objection, the motion to indefinitely postpone was withdrawn.

The PRESIDENT: The question now before the Senate is on the motion of the Senator from Aroostok, Senator Brewer, that the amended order receive passage. Is this the pleasure of the Senate?

The motion prevailed and the Order as amended received a passage in non-concurrence.

Sent down for concurrence.

On motion by Mr. Palmer of Lincoln, the Senate voted to take from the table bill, "An Act Relating to the Releasing or Dumping of Fish," (H. P. 544) (L. D. 369) tabled by that Senator earlier in today's session pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on Sea and Shore Fisheries in concurrence.

On motion by Mr. Allen of Cumberland

Adjourned until tomorrow morning at ten o'clock.
