Mr. NOYES of Hancock: Mr. President, I move that the Senate reconsider its action of yesterday whereby Committee Amendment A was adopted and I will further move that that Amendment be indefinitely postponed in order that I may submit Senate Amendment A.

In explanation of this amendment, I have talked with the Chairman of the Inland Fish and Game Committee and this proposed Senate Amendment A does exactly what the committee felt that they did in the original amendment, but it does clear up the use of term "Swan's Island proper." the township of Swan's Island we have several islands in addition to the island of Swan Island and if Committee Amendment A were adopted, it would create some confusion. believe that Senate Т Amendment A takes care of that and avoids confusion.

The motion prevailed and the Senate voted to reconsider its former action whereby Committee Amendment A was adopted and Committee Amendment A was indefinitely postponed.

The Secretary read Senate Amendment A:

# Orders of the Day

Mr. Brewer of Aroostook was granted unanimous consent to address the Senate.

Mr. BREWER of Aroostook: Mr. President and members of the Senate, in order to try to keep you informed of the work of the Appropriations Committee and bring you up to date, I will say that as of this afternoon, we will have completed the hearings of all department heads which involve about forty two million dollars plus, the first year; and forty three million by requests, the second year. Of course, as you know, those requests are about fifteen million dollars out of line with the estimated revenue and the Governor and his Budget Committee have cut that fifteen million dollars practically in half which brings it down to in round figures to \$7,700,000.

We will start in on bills involving other expenditures this afternoon and by next week expect to have some of them passed out so you can discuss them in the two branches.

As I say, I will ask for the privilege of trying to keep you informed as to where we are in our deliberations and I thank you for this opportunity this morning.

Mr. Boyker of Oxford was granted unanimous consent to address the Senate.

Mr. BOYKER of Oxford: Mr. President and members of the Senate, yesterday at our regular session in speaking concerning an order which had been taken from the table, I made the statement that there are many instances where economy can be practiced in the

different departments of our state. Yesterday afternoon I was accosted by two persons outside the legislature and one person within our ranks with this admonition, generally: "Mr. Boyker, you are making too much criticism in more ways than one."

Now I would like to tell this Senate just how I stand in the beginning on our problems of government, and to any outsider who thinks it is his concern. We are assembled here honor bound to speak and to act in the interest of the citizens of our state whom we represent and to use the same good judgment as our constituents used in sending us here. And I am not speaking of myself but I am referring to the members of the Senate who I know by their records and with whom it has been my pleasure to serve in other legislatures.

Is there something wrong with the system of our government? I say Yes. 1. Too many fingers in the pie, too many agencies, too many commissions, too many appointees of those persons whose ideas of what the people want are not the ideas of the people themselves, too much advice from persons outside our state to the detriment of the taxpayers' pocketbooks. We want to learn, we want to educate ourselves, we want to govern ourselves. Shall it be "As other states go and as other persons think, so goes Maine" or will it still be "As Maine goes so goes the nation"?

Now we are told by those who may well understand, that there is something drastically wrong with our system of education. In our Governor's message he said, "I am ready to economize in theory and also in practice". Is our education department seventy five percent theory? If it is I think we should economize on theory and elaborate on a little common sense education. At a get-to-gether between the Committee on Correctional Institutions, and the heads of those departments a short while ago, our then State Warden at our State Prison, Wallace Lovell, gave us to understand that persons in his care who had graduated from our common schools ready to enter our high schools and academies, adding two sums together had to count on their fingers. I can go Mr. Lovell one better. I can cite instances where graduates of our common schools ready to enter high-schools and academies, in raising the American flag didn't know whether the stars went at the top or the bottom, but they did know that they didn't have to study unless they wanted to and if they didn't want to work, the state would take care of them.

Now, are we teaching in our schools initiative, originality, ambition? Do we have discipline in our schools? Many of our statesmen of today bless the time when their parents and teachers taught them the straight and narrow path and we, as guardians of the chilren of the future are we leading them in the straight and narrow path?

I have no criticism for the head of any department in our state government but we do know that in the field workers' division of our Health and Welfare department, there is inefficiency, favoritism and unnecessary expenditure of the taxpayers' money, but they say nothing can be done because of our system of government. I am not criticizing the heads of departments because they are not in a position to observe the shortcomings of their assistants as we do repre-

senting the people of our state who have contact with those assistants.

We are asked by our federal government-we are demanded by our federal government-to tighten our belts and deny ourselves. Let our state parks and other ventures in our department of state be postponed during this great national emergency. Let us pay as we go in our highway department, get the farmer out of the mud so to speak and our tourists into our countryside. With perhaps the greatest misfortune that has ever befallen this world, perhaps already in the making, with our federal government giving away our money and the lives of our sons to foreign countries, I have no interest in attempting to make my state a super state until peace is declared, the graves of our soldier dead have been dug and the wounds of our disabled have at least partially healed.

On motion by Mr. Noyes of Hancock the Senate voted to take from the table Resolve in Favor of the Town of Aurora (S. P. 210) tabled by that Senator on February 7 pending reference to a committee, and on further motion by the same Senator, the resolve was referred to the Committee on Claims.
