# Orders of the Day

On motion by Mr. Brewer of Aroostook, the Senate voted to take from the table Joint Order Relative to Markers or Tags for Number Plates (H. P. 790) tabled by that Senator on February 7 pending passage.

Mr. BREWER of Aroosktook: Mr. President and members of the Senate, at the end of my short talk on what this order proposes to do. I will offer an amendment to the original order. Pursuant to our discussion yesterday, if I interpreted the feelings of the members correctly, this order proposes to comply with your suggestions in that the "S" is eliminated from your number as was proposed. The cost to each individual will be two dollars and upon paying the Secretary of State's department two dollars more, it allows you to use plate instead of your old one. It doesn't in any way interfere with any number that you have assigned to you. In fact you have to register your automobile anyway in order to use this plate. However it is similar to that used by the Governor's Council. Also the buying of these plates is optional. You may buy them or not as you see fit.

I now offer Senate Amendment A and move its adoption.

The Secretary read Senate Amendmend A to H. P. 790:

SENATE AMENDMENT "A" to H. P. 790, "Joint Order Relating to Automobile Markers for Members and Officers."

Amend said Order by striking out all after the word "concurring" in the first line thereof, and inserting in place the following:

'that the Secretary of State provide to each member of the Senate and House of the 95th Legislature, in addition to the regular automobile registration plates issued to him, suitable plates to be attached by such member to his automobile, and be it further

ORDERED, that such plates shall designate membership in the Maine Legislature and shall not be used after the first Wednesday of January, 1953, and be it further

ORDERED, that the expenses incurred under the provision of this Order shall be apportioned among the members ordering such plates not to exceed \$2.00 per member, and such money shall be credited to the Motor Vehicle Appropriation of the Secretary of State, and be it further

ORDERED, that the Secretary of State provide to the President of the Senate, the Speaker of the House, the Secretary of the Senate, and the Clerk of the House similar plates designating their official positions."

Which amendment was adopted and the Order as so amended received a passage in non-concurrence Sent down for concurrence.
