Mr. Brewer of Aroostook was granted unanimous consent to address the Senate.

Mr. BREWER of Aroostook: Mr. President and members of the Senate, as of last night, your Appropriations Committee had heard everything in the budget book except two departments; namely, Health and Welfare, and Education. These two departments represent seventy percent of the appropriation. In other words, most of the work we have done involves only thirty percent of the money that we use in our appropriation. As most of you know, Health and Welfare takes about forty-four percent and spends in the neighborhood of fourteen and a half million dollars or better, and Education spends twenty-four and four tenths percent or a little better than eight million dollars.

How much time we will consume in going over these departments I cannot predict. It is merely a matter of routine and time but as I have to keep repeating, we are going to be certain that we have some unanimity of opinion when these two departments do come out, and for that reason, feeling that our figures must be correct and that we must have something to work on, we will pass them to you as soon as we have made our decisions and recommendations.

The PRESIDENT: The Chair would like to make a comment of interest to the Senators. The House this morning is honoring three of our Senate members by requesting their presence a little later in the morning on the Rostrum of the House, as ex-Speakers of the House. Those Senators are Senator John Ward of Penobscot, Senator Nathaniel Haskell of Cumberland and Senator George Barnes of Aroostook. I think sometimes we forget the honors that have been conferred upon our members in the past and I think it is well to bring that to your attention.

On motion by Mr. Barnes of Aroostook the Senate voted to take from the table bill, An Act Relating to Turning Vehicles at Intersections (H. P. 342) (L. D. 199) tabled by that senator on February 22nd pending passage to be enacted.

Mr. BARNES: Mr. President, I was somewhat amazed when I

looked at this bill which apparently came out and had its first acceptance of the committee report while I was away. It so happens that I have a couple of children who are at about the age where they apply for licenses to operate motor vehicles, and the department puts out a book with a lot of rules and regulations in it which are very good for them to learn but also, some of them, very confusing. I am going to read to you the second paragraph of this bill and I want you to pay careful attention to see if you can tell what it means. I cant:

"II. Left turns on two-way roadways. At any intersection where traffic is permitted to move in both directions on each roadway entering the intersection, an approach for a left turn shall be made in that portion of the right half of the roadway nearest the center line thereof and by passing to the right of such center line where it enters the intersection and after entering the intersection the left turn shall be made so as to leave the intersection to the right of the center line of the roadway being entered. Whenever practicable the left turn shall be made in that portion of the intersection to the left of the center of the intersection."

I had always believed that I knew something about the King's English and I have studied and studied that paragraph and I can't seem to make sense of it. I had planned to move for indefinite postponement of the bill and I am not quite sure but that it would be the wise thing to do now. I find, however, that Johnny De Winter understands it very clearly and he drew out a diagram of it for me on a piece of paper and probably when they add this to the book with all the other things the young people have to study when they get their driving licenses there will be a diagram in the book that will make it very simple to understand.

I also understand that this bill is blessed with the sanction of The Uniform Motor Vehicles Code or something of that nature and is probably alright although it sounds like a lot of gobbledygook to me. So I move, Mr. President, the enactment of the measure.

The motion prevailed and the bill was passed to be enacted.
