SENATE

Tuesday, March 8, 1951

The Senate was called to order by the President.

Prayer by the Reverend Royal Brown of Gardiner.

Journal of yesterday read and approved.

I have had a chance to look it over since it was read this morning, and it provides that all cats, six months old or over shall be registered each year with the Town Clerk, together with a description of the cat's size, breed, color, marks, and a fee of fifty cents would be charged.

We are supposed to be down here on serious business. It costs the state money to advertise these bills and in this one I can see no virtue whatever. I know that the sponsor introduced it by request.

I therefore move, Mr. President, that the Senate reconsider action whereby the bill was referred to the Committee on Agriculture.

The motion prevailed and the Senate voted to reconsider action taken earlier in today's session whereby it referred L. D. 1103 to the Committee on Agriculture; and on further motion by the same Senator the bill was indefinitely postponed in non-concurrence.

Thereupon, on motion by Mr. Weeks of Cumberland, the Senate voted to reconsider its former action whereby the bill was passed to be engrossed and that Senator presented Senate Amendment A and moved its adoption:

Senate Amendment A to (H. P. 540) (L. D. 325) bill An Act to Provide for a Town Manager Form of Government for the Town of Rumforl. "Amend said bill by changing the word Australian wherever it appears and inserting in place thereof the word 'secret'."

Which amendment was adopted and the bill as so amended was passed to be engrossed in nonconcurrence.

Sent down for concurrence.

The President laid before the Senate bill, An Act Relating to Sales of Liquor to Minors (H. P. 848) (L. D. 487) tabled on March 6 by the Senator from Androscoggin, Senator Boucher, pending second reading, and especially assigned for today.

Mr. CROSBY of Franklin: Mr. President, my seat mate and Minority Floor Leader from Androscoggin has been stricken with the flu bug as have many others, and cannot be here this morning. He is very desirous of making his stand known on this bill. I therefore move that bill, "An Act Relating to Sale of Liquor to Minors (H. P. 848) (L. D. 487) lie upon the table.

The motion prevailed and the bill was laid upon the table pending second reading.

Mr. Reid of Kennebec was granted unanimous consent to address the Senate.

Mr. REID of Kennebec: Mr. President and members of the Senate, it is proposed to erect a television tower in the City of Bath to receive television signals from Boston. When they arrive at the tower they will be weak and the tower will amplify them, and relay them to homes and apartment houses who desire the service.

Arrangements have only recently been made with the power companies and telephone companies in the area for joint use of the facilities and that is why the bill which I propose to introduce was not put in until this time. I think there is nothing controversial about it and I do not think it will delay the session any.

Therefore, Mr. President, I ask unanimous consent to introduce bill, An Act Relating to Transmission of Television Signals by Wire.

The only purpose of the legislation is to give the television companies the authority, the same as the power companies and telephone companies, to ask for permits to have wires put across streets and so forth.

Thereupon, bill, An Act Relating to Transmission of Television Signals by Wire (S. P. 489) was received by unanimous consent, and on motion by Mr. Reid of Kennebec, was referred to the Committee

on Business Legislation and ordered printed.

Sent down for concurrence.

On motion by Mr. Ward of Penobscot, the Senate voted to take from the table bill, An Act Relating to Publishing Vital Statistics in Town Reports (H. P. 1555) (L. D. 1116) tabled by that Senator earlier in today's session pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on Judiciary in nonconcurrence.

On motion by Mr. Reid of Kennebec, the Senate voted to take from the table bill, An Act Relating to Licenses to Operate Motor Driven Cycles (H. P. 397) (L. D. 233) tabled by that Senator on February 16 pending passage to be engrossed.

Mr. REID of Kennebec: President and members of Senate, as I understand it. this bill would provide that youngsters between the ages of twelve to fifteen years may be licensed to operate motor driven cycles with the consent of their parents. I am opposed to the bill as a parent. I would ordinarily feel embarrassed in opposing it because the committee reported it out unanimously ought to pass. However, not too long ago. precedence was established for upsetting such a report, but the Senafrom Cumberland, Allen was successful in upsetting a unanimous committee report not too long ago. I feel that this is not too important a measure but I do feel that I want to register disapproval of it.

In my opinion, youngsters twelve fourteen years old running around the country on motor driven cycles would create a hazard not only to themselves, but a hazard to other users of the highway. These cycles are capable of speed up to twenty five or thirty miles hour. If the young child riding along the highway does not meet with any crises, he probably would be all right. However, if he should meet with sudden crises he would be unable at that speed to operate the vehicle in such a way as to do no harm to himself or other people on the highway.

I have three children, and I am nervous that they ride bicycles let alone motor driven cycles. I know this bill provides for the consent of the parent, but I also know that one motor driven cycle in any one community would make us parents the victims of our children wanting the same thing. I also know that eventually, children are so persuasive, that we would all succumb to their wishes. I know that because we have three bicycles for three children. Once I had a firm determination that my children would not have a bicycle until they were eighteen years old.

I do not believe that this is a good bill for those reasons, and I move that the bill be indefinitely postponed.

Mr. ALLEN of Cumberland: Mr. President and members of the Senate, I arise this morning to defend a unanimous committee report from the Committee on Transportation on Legislative Document 233. When I first saw this bill I drew conclusions similar to those expressed by my good friend, the Senator from Kennebec, Senator Reid. After hearing testimony and looking into the thing a little bit, our committee, whether wise or whether unwise, felt that this bill was not as dangerous as has been expressed by Senator Reid. In fact, we could see no objections to it and we reported it favorably. That may sound a little bit startling but we delved a little bit into the records, and according to figures which I was able to pick up at the Registration Bureau, you might be interested to know that in the State there are probably—I do not have accurate figures, but there are probably eight or nine hundred vehicles with what we call "whizbikes" attached. They are operated in many parts of the State. We do not see them as much in my town as in some other places, but there are a total of 2.581 motor bicycles and the Department of Motor Vehicles checked through the first one thousand and came up with an average of one to three. Therefore, our estimate is only an estimate and not accurate, but there are evidently eight or nine hundred of these bicycles in the State.

One of the arguments used in the public hearing was that they are being used widely now by youngsters. I am not saying anything should be legalized just because it is being done, but the fact remains that children of this age are using whizzer bikes now. I was unable to find in the record of the State Police headquarters on a statewide basis,-I have not, of course, records from all police depart-ments in the State, but they have no record of accidents at the State Police headquarters across river, in spite of the fact they have been used several years. Obviously, there have been accidents of a minor nature, but there are no statistics at all of accidents to whizzer bikes.

As you know, I have arisen on many occasions in support of safety legislation in this Body and in the House, and I would not ever endanger the public safety of our youngsters. I believe there are seventy-five to a hundred thousand bicycles on the road of the State and I agree with Senator Reid that the question of speed is an angle to be considered. On the other hand, our youngsters are in far fewer accidents on the large number of bicycles than you might think. Most accidents come from pedestrians and children running into streets. Therefore, Mr. President, I hope, of course, that the motion of Senator Reid does not prevail.

I would like to make on observation for a member of the Transportation Committee. Senator Boucher, who is ill, is in favor of the measure and wishes me to so state.

Mr. CHRISTENSEN of Washington: Mr. President, I thought I ought to say a word since I happen to be on the committee. That bill was thoroughly gone over and analyzed from end to end and all reports are that boys from ten to eleven ride those whizzer bikes to day and we were unable to find a record of any accident. That is why we reported out "Ought to Pass" because I think if we license those bikes we will have a little more check on them and they might be a little more careful.

As Senator Reid said, he worried about his children riding on bicycles. He has cause to worry. I hate to meet youngsters on a bicycle weaving all over the road.

The fellow on the whizzer bike goes straight. He has nothing to do but steer. This pedaling and wobbling all over the road is dangerous and motorists have to be careful.

The PRESIDENT: The question before the Senate is on the motion motion of the Senator from Kennebec, Senator Reid that the bill be indefinitely postponed. Is the Senate ready for the question?

A viva voce vote being doubted. A division of the Senate was had.

Twenty-two having voted in the affirmative and six opposed, the motion prevailed and the bill was indefinitely postponed in non-concurrence.
