SENATE

Friday, March 9, 1951.

The Senate was called to order by the President.

Prayer by the Reverend Wilfred Mulley of Gardiner.

Journal of yesterday read and approved.

On motion by Mr. Crosby of Franklin, out of order and under suspension of the rules, it was

ORDERED, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday, March 13th, 1951, at eleven o'clock in the morning. (S. P. 490)

Mr. BREWER of Aroostook: Mr. President, I present an Order and move its passage. In explanation I would like to say that there has been some controversy as to whether we would be allowed to use the plates, legally, that we decided upon the other day.

This Order is put in at the suggestion of the Secretary of State. You notify him that you do want to use this plate and a slip will be issued to you. I now move the passage of the Order.

The Secretary read the Order:

"ORDERED, the House concurring, that Legislative membership motor vehicle identification plates as provided for in the joint order H. P. 790 passed as amended, may be used by the holders thereof in lieu of or in place of the regular registration plates as provided for by law when the owner's vehicle is otherwise properly registered and after the Secretary of State has received notice from said owner of his intention to use such identification plates in lieu of the regular registration plates, such notice to contain such information as the Secretary of State may require in addition to the holder's identification number, and after issuance of a certificate permitting same by the Secretary of State.'

Which Order received a passage. Sent down for concurrence.

On motion by Mr. Haskell of Cumberland, it was

ORDERED that 500 additional copies of S. P. 238, L. D. 515 bill, An Act to Allow State, County and Town employees to receive federal social security benefits, be printed.

Which amendment was adopted, and the bill as so amended was tomorrow assigned for second reading.

Mr. Dennett from the Committee on Liquor Control on Bill "An Act Relating to Eligibility for Liquor Licenses," (S. P. 325) (L. D. 724 reported that the same ought to pass as amended by Committee Amendment "A".

Which report was read and accepted, and the bill read once. The Secretary read Committee Amendment A.

Committee Amendment A to L. D. 624. "Amend said bill by inserting after the underlined word 'not' in the last line thereof, the underlined words 'by reason of conviction of violation of any liquor laws or because of having had his license for sale of liquor revoked.

Which amendment was adopted, and the bill as so amended tomorrow assigned for second reading.

Orders of the Day

On motion by Mr. Marshall of York, the Senate voted to take from the table, House Report "Ought to Pass in a New Draft Under the Same Title (H. P. 1504) (L. D. 1057) from the Committee on Public Utilities on Bill, An Act to Incorporate the Porter's Landing Water District (H. P. 1129) (L. D. 714) tabled by that Senator on March 6th pending acceptance of the report; and on further motion by the same Senator, the report was accepted and the bill was given its first reading. On further motion by the same Senator, the rules were suspended and the bill was given its second reading and passed to be engrossed, in concurrence.

On motion by Mr. Tabb of Kennebec, the Senate voted to take from the table Bill, An Act Prohibiting the Procuring of Liquor for Certain Persons (H. P. 784) (L. D. 465) tabled by that Senator on March 1st pending enactment; and on further motion by the same Senator the Senate voted to reconsider its action whereby the bill was passed to be engrossed.

Mr. Tabb of Kennebec presented Senate Amendment "A" and moved its adoption:

"Senate Amendment 'A' to H. P. 784, L. D. 465, Bill, An Act Prohibiting the Procuring of Liquor for Certain Persons. Amend said bill by inserting in the eighth line after the underlined word 'habits' the underlined words and punctuation: , except this provision shall not apply to liquor served to a minor in the home.""

Senate Amendment "A" was adopted, and the bill as so amended was passed to be engrossed in nonconcurrence.
