SENATE

Friday, March 16, 1951

The Senate was called to order by the President.

Prayer by the Reverend John P. Donovan of Augusta.

Mr. Savage of Somerset presented "Resolve in Favor of the Town of Cornville." (S. P. 506)

Mr. Allen of Cumberland presented an order and moved its passage.

Mr. ALLEN: Mr. President, is it permissible to give the Senate a word of explanation before the order is read?

The PRESIDENT: The Chair will inform the Senator that that would be quite in order.

Mr. ALLEN: Mr. President and members of the Senate, a week ago in discussing with you a bill which I filed in the legislature, because of the state wide losses we are sustaining both in property and in lives due to fire in homes I stated that I would later present for your consideration a joint order that the Recess Committee be authorized to look into this matter of home fires to see if there were any solution which could be arrived at through legislation or other means. This order is in conformity with what other states are doing and it is presented so that in the next two years the Research Committee may have a chance to thoroughly look into the situation which last year cost the lives of sixty-three citizens and a million dollars of property. And for that reason I hope the Senate will receive favorably this order.

The Secretary read the order: "Ordered, the House concurring, that the Legislative Research Committee be and hereby is directed to study the needs of regulating the installation of oil burning or liquified gas equipment utilized for heating or cooking, and be it further

"Ordered, that the committee report the results of its study to the 96th Legislature."

The order received a passage. Sent down for concurrence.

Orders of the Day

Mr. CROSBY of Franklin: Mr. President, I would like to inquire if House Paper 541, Legislative Document 326, An Act to Repeal the Act Creating the Rumford Falls Village Corporation, and Senate Paper 50, Legislative Document 60, An Act to Incorporate the Town of York School District, are in the possession of the Senate?

The PRESIDENT: The Chair will inform the Senator that the two acts are in the possession of the Senate, having been recalled from the Governor by joint order.

Mr. CROSBY: Mr. President and members of the Senate, these acts were recalled from the Governors's office because of a technicality in them which has now been corrected, and I move they now be forwarded to the office of the Governor.

The motion prevailed.

On motion by Mr. Collins of Aroostook, the Senate voted to take from the table House Report Ought to Pass from the Committee on Towns and Counties on bill, An Act Relating to Recording of Highway Maps (H. P. 1239) (L. D. 160) tabled by that Senator on March 9 pending acceptance of the report; and on further motion by the same Senator, the report was accepted in concurrence and the bill was given its first reading and tomorrow assigned for second reading.

Mr. Crosby of Franklin was granted unanimous consent to address the Senate:

Mr. CROSBY: Mr. President and members of the Senate, the Order that was passed this morning changed our time of convening Tuesday to ten o'clock instead of eleven. This was done so that we might take some action on Tuesday on the Appropriation bill. I would suggest to the Senators that they

prepare their amendments as soon as possible so that we might complete our work on this bill, and forward it to the other branch.

I don't think we will get any tax bill until such time the House members have had opportunity to determine for themselves the revenue needs. So I hope we will all cooperate and if possible get this appropriation bill on its way at an early date.

Mr. SLEEPER of Knox: Mr. President, I would like to ask unanimous consent to address the Senate.

Unanimous consent was granted.
Mr. SLEEPER: Mr. President and
members of the Senate, it isn't
often that we pass bills that bring
as much pleasure as the passage
of a certain bill has brought to
me this morning. I want to compliment Senator Ela and his committee on giving an "ought to
pass" report, and I also want to
compliment whoever introduced the
bill. It is Item 4 of the Senate

Committee Reports, Resolve Regulating Fishing in Sourdnahunk and Little Sourdnahunk Lakes in the County of Piscataquis. Last November I spent 30 anxious hours somewhere in that neighborhood and if I had found one of the wardens up there to regulate fishing it would have been a god-send indeed. Sometimes I doubt if I would have been out of there by now if there had not been a contest for President of the Senate and some folks wanted to get me out for some reason. I think it is one of the best bills that will be passed this season. It is wonderful territory to hunt in and perhaps I won't be too timid to go there again if fishing is to be regulated and there will be wardens around there. I would have given my right arm to have seen a warden in that thirty-hour period.
