SENATE

Friday, April 13, 1951.

The Senate was called to order by the President.

Prayer by the Reverend Walter E. Kellerson of Augusta.

Mr. ALLEN of Cumberland: Mr. President and Members of the Senate, through the centuries, Friday the 13th has been an ominous day, a day in which gloom hangs over the heads of all of us. The sun, as you will note, is not shining, as usual, and we obviously will be very careful during today of what we do, how we act and what we say.

There is one among us who is more unfortunate than the rest of us. Not only does he have to put up with Friday the 13th but he sits in seat thirteen and on his automobile there is a plate which says, "Number 13."

Mr. President, I would present, if I may at this time, to the Senator from York, Senator Marshall, a four-leaf clover. No one needs it any more than Senator Marshall needs it today.

Mr. Marshall of York was granted unanimous consent to address the Senate.

Mr. MARSHALL of York: Mr. President, I certainly appreciate the kind words from the Senator from Portland and Cumberland County where they have everything.

I don't see how he was able to buy a four-leaf clover as large as that. I can hardly see it. Before I take that home, I am going to have that magnified. If I don't, my wife will think I haven't been cheating. I fully appreciate the kindness he has shown me.

Mr. WEEKS of Cumberland: Mr. President, I guess this is a bad day for the weak, the poor and the oppressed because I can't fight for this bill any more. So, I move the acceptance of the Committee Report.

Thereupon, the Ought Not to Pass report of the Committee was accepted.

Sent down for concurrence.

Mr. Reid of Kennebec was granted unanimous consent to address the Senate.

Mr. $_{
m REID}$ of Kennebec: President and Members of the Senate, there is an elderly woman named Susie Moody who lives in Waterville and up to last November, she was receiving Old Age Assistance. She had a small piece of property in Falmouth and without realizing the consequence of her action, she sold it for \$1,600.00 and took a mortgage, and note for twelve hundred and received four hundred in cash.

This automatically disqualified her from receiving Old Age Assist-

ance. She has now used the four hundred dollars and she was advised by the Health and Welfare Department that she would have to sell the mortgage before she could be reinstated on the rolls of Old Age Assistance.

The most she can get for the mortgage due to the small value of the property is five hundred dollars and she was advised by the Health and Welfare Department that if she sells it for five hundred dollars because the face value of the note is twelve hundred, it will be considered a sale for inadequate consideration and she will still not be able to get Old Age Assistance. The only way she can do it is by assigning the note and mortgage over to the State of Maine.

I, therefore, ask at this time unanimous consent to introduce a resolve authorizing the State Treasurer to accept from Susie Moody the note and mortgage on this property.

The PRESIDENT: The Senator from Kennebec, Senator Reid, asks unanimous consent to the introduction of a resolve. Is there objection? The Chair hears none and the resolve may be presented.

Thereupon Mr. Reid of Kennebec presented Resolve Authorizing the Treasurer of State to Accept Assignment of Mortgage from Susie E. Moody of Waterville (S. P. 543) which was received by unanimous consent, and on further motion by the same Senator was referred to the Committee on Judiciary and ordered printed.
