Orders of the Day

Under Orders of the Day, the Chair laid before the Senate the first tabled and especially assigned matter being bill, An Act Relating to Running Horse Racing in the Daytime (H. P. 1021) (L. D. 580) tabled on May 10 by the Senator from Aroostook, Senator Barnes pending motion by the Senator from Androscoggin, Senator Kavanagh to reconsider former action whereby the bill was passed to be enacted.

Mr. LEAVITT of Cumberland: Mr. President, I notice that there are two Senators from York County who are absent this morning and they are very interested in this bill. I feel that in deference to them this bill should be retabled until next Tuesday.

A viva voce vote being doubted by the Chair

A division of the Senate was had. Seventeen having voted in the affirmative and seven opposed, the motion prevailed and the bill was retabled pending motion by Senator Kavanagh that the Senate reconsider its former action whereby the bill was passed to be enacted; and the bill was especially assigned for Tuesday next.

On motion by Mr. Haskell of Penobscot, the Senate voted to take from the table bill, An Act Relating to Public Burying Ground in Townships of Medford and Orneville (H. P. 1240) (L. D. 792) tabled by that Senator earlier in today's session pending passage to be enacted.

Mr. HASKELL of Penobscot: Mr. President and members of the Senate, this bill when originally introduced sought to amend Section 5 of Chapter 54 which is a very short section and I will read the section.

"The County Commissioners of any county in which there is an unincorporated place or places wherein or any ancient or public burying grounds shall cause the same to be suitable fences and thereafter maintained; they also shall cause the burying ground aforesaid to be kept in proper condition and any bushes therein to be cut."

The original bill sought to amend that section by providing that another tax levy would be provided for on all property in all of those unincorporated places and that proposition the Senate turned down rather firmly. The bill that is now up for enactment does that same thing with respect to Medford and Orneville in Piscataquis County.

I haven't any hard feelings toward Medford and Orneville in Piscataquis County. But if the proposition of another tax to be added onto the county tax, the local tax, the forestry district and whatever taxes we have is wrong statewide, the principle is just as wrong with respect to these two communities and if we do enact this, I see no reason why we are not going to have as many amendments to this thing as there are unincorporated places in the state.

I think the action of the Senate in denying the whole general proposition of another tax to do what clearly is provided for out of county funds is equally wrong with respect to these communities. Therefore, Mr. President, I move that the bill be indefinitely postponed.

Mr. McKUSICK of Piscataquis: Mr. President, I have no special interest in this. The Towns of Medford and Orneville have been recently de-organized. They are towns of some population and some ability for taxation, rather than all wild land and I think probably the idea originated, I imagine, with our County Commissioners who realize their responsibility as provided in the section which the Senator from Penobscot has read to care for the public burying-grounds in deorganized places.

So, I think the whole proposition simmers down to the situation as to whether all of Piscataquis should be taxed to care for those buryinggrounds in the Towns of Orneville and Medford or whether the property of the two towns should bear the expense. I think that is the whole proposition as far as we are concerned in Piscataquis County.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Penobscot, that the bill be indefinitely postponed.

A viva voce vote being had, the bill was indefinitely postponed in non-concurrence.

Sent down for concurrence.

Mr. Ela of Somerset was granted unanimous consent to address the Senate.

Mr. ELA: Mr. President, in the discussion on the porcupine bill yesterday, certain errors were made in certain statements by me and the Senator from Penobscot for which we both wish to apologize.

We stated and we thought we were correct, that the previous bounty was fifteen cents. We find we were in error. The previous bounty was twenty-five cents. I feel that the error made no difference in the final vote but if the sponsors of the measure really feel that it did, and if the measure comes back to us as most measures seem to have a habit of returning to us—and I say if they think it made a difference in the final vote —I will personally see to it that the Senate has a chance, through a parliamentary move, to again vote on it if they so desire.

Mr. Noyes of Hancock was granted unanimous consent to address the Senate.

Mr. NOYES: Mr. President. I wish to thank the Senator for his correction of the statements made yesterday and I wish to congratulate the nine who voted for porcupine bounties on the loud vote that they did make because he asked for a division. A division indicated we were in the minority by about two to one but in speaking, the noise we made was certainly equal to the majority vote that prevailed. So. I consider that a moral victory and I don't think the fifteen cents had anything to do with the vote.

On motion by Mr. Leavitt of Cumberland, the Senate voted to take from the table bill, An Act Relating to Salaries of County Officers of Androscoggin County (S. P. 422) (L. D. 982) tabled by that Senator on May 9 pending passage to be enacted; and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Brewer of Aroostook, the Senate voted to take from the table bill, An Act Increasing Salaries of Oxford County Officers and Clerk Hire (S. P. 445) (L. D. 1006) tabled by that Senator on May 2 pending passage to be enacted; and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Brewer of Aroostook, the Senate voted to take from the table bill, An Act to Increase the Salaries of Certain County Officers in Washington County (H. P. 941) (L. D. 537) tabled by that Senator on April 20 pending passage to be enacted; and on further motion by the same Senator, the bill was passed to be enacted. On motion by Mr. Tabb of Kennebec, the Senate voted to take from the table bill, An Act Relating to the Liquor Commission (H. P. 1786) (L. D. 1346) tabled by that Senator on May 9 pending passage to be enacted; and on further motion by the same Senator, the Senate voted to reconsider its former action whereby the bill was passed to be engrossed.

Thereupon, the Senator from Aroostook, Senator Barnes presented Senate Amendment A and moved its adoption.

The Secretary read the amendment:

Senate Amendment A to L. D. 1346. "Amend said bill by striking out Section One thereof and inserting in place thereof the following: 'R. S., C. 57, Sec. 6, Subsection IV-A Addition, Subsection 4-A of Section 6, R. S. C. 57 is hereby further amended by adding thereto a new sub-section to be numbered IV-A to read as follows: 'IV-A. The commission at all times and with respect to all policies shall neither discriminate against nor in favor of any person, firm or corporation because of its residence or nonresidence in the state except as provided for in Subsection IV of this section.' Further amend said bill by striking out Section Two thereof."

Thereupon, on motion by Mr. Haskell of Penobscot the bill and accompanying papers were laid upon the table pending the motion of the Senator from Aroostook, Senator Barnes, for the adoption of Senate Amendment A.

Order

(Out of Order)

On motion by Mr. Palmer of Lincoln, out of order and under suspension of the rules, it was

ORDERED, that a message be sent the House of Representatives proposing a convention of both of the legislature to be held forthwith in the Hall of the House for the purpose of extending to the Honorable Charles C. Ralls, of Seattle, Washington, National Commander of the Veterans of Foreign Wars. and his official party, an invitation to the convention attend and address to the same such remarks as he may be pleased to make.

The Secretary retired from the Senate Chamber to convey the message.

On motion by Mr. Boucher of Androscoggin the Senate voted to take from the table bill, An Act Relating to County Commissioners of Androscoggin County (S. P. 190) (L. D. 407) tabled by that Senator on March 1st, pending passage to be enacted.

Mr. BOUCHER: Mr. President and members of the Senate, this bill has now become void due to the fact that we have just enacted another bill concerning the Androscoggin County Commissioners which has the same purpose denoted as this bill, among other things, and I now move the indefinite postponement of the bill.

The motion prevailed and the bill was indefinitely postponed in nonconcurrence.

Sent down for concurrence.

On motion by Mr. McKusick of Piscataquis the Senate voted to take from the table bill, An Act Relating to Funeral Expenses Under Old Age Assistance Law (H. P. 1285) (L. D. 823) tabled by that Senator on March 29th pending passage to be enacted.

Mr. BREWER of Aroostook: Mr. President and members of the Senate, I move the indefinite postponement of this bill. This involves the sum of \$30,000 for each of the two years and I would like to say to the Senate that for I don't know how many years there was no allowance made for funeral expenses of paupers. In the special session they were given a hundred dollars for each funeral with the understanding that they could collect from the relatives of the deceased. This would add fifty dollars more to that amount and I feel that with the money the undertakers pick up from relatives they wouldn't be the penalized if this bill didn't pass, and for that reason I make that motion.

Mr. WARD of Penobscot: Mr. President and members of the Senate, in 1928, I believe it was, I happened to be one of the overseers in Millinocket and at that time the allowance for pauper funerals was \$100 and certainly since then the price of everything has very considerably increased. I certainly think that this increase in this particular matter should be allowed and I oppose the motion for indefinite postponement.

Mr. McKUSICK of Piscataquis: Mr. President and members of the Senate, this bill was heard by the Welfare Committee and it came out with a Unanimous Report Ought to Pass. At the time, it seemed a worthy request. At that time, we did not have the financial picture of the State before us. But since, we have found it necessary to cut down the amount of money available---

At this point, the Secretary returned from the House of Representatives and announced that he had delivered the message with which he was charged.

The PRESIDENT: The Senator may proceed.

Mr. McKUSICK:—As I was saying, at that time we did not have the full financial picture of the State and since that time we have found it necessary to cut down the amounts for those living under the Old Age Assistance program.

And because it does not seem that there is the money available, I am obliged, perhaps somewhat regretfully, to go along with the motion of Senator Brewer.

Mr. BREWER of Aroostook: Mr. President, may I ask through the Chair a question from Senator McKusick?

The PRESIDENT: The Senator may state his question and the Senator may answer if he sees fit.

Mr. BREWER: Senator McKusick, is it a fact that when they were paid in years previous \$100.00, that they were not allowed to collect from the relatives over and above that, do you know?

Mr. McKUSICK: Mr. President, I can not answer that definitely but I have always had the impression that they were not. I couldn't give him any definite impression but that has always been my impression.

Mr. BOYKER of Oxford: Mr. President and members of the Senate, as chairman of the Board of Selectmen, I have found that it is

impossible to collect from the relatives. We have had a hundred dollars and that has gone to the undertaker and that is all he has received in many cases which I have dealt with. It will be impossible to collect from relatives in very many cases.

At this point, a message was received from the House of Representatives by its Clerk Harvey Pease, that the House concurred in the proposal for a Joint Convention to be held forthwith in the Halls of the House.

Mr. WEEKS of Cumberland: Mr. President, I too have had a little experience with this situation. In the first place, I do not believe anyone will deny the fact that we should give at least minimum consideration to a pauper who has passed on. It is true that we make every effort in our town to collect from these people when there are those who have an obligation to pay and we get it. It is also true that burials have been made in the last few years that cost more than a hundred dollars and there have been a number of claims in that situation. Undertakers have come here and put in claims for the balance and they have made a very proper argument and the claims have been allowed. So whether you allow it by statute or by a bill presented to the legislature, you are doing exactly what this bill calls for. We do recognize changing conditions.

Mr. ELA of Somerset: Mr. President, I can answer one question. If the relatives wish to add to the hundred dollars, they may up to \$75 and the state will still pay them \$100. If the relatives want a better than \$175 funeral, they must pay the whole thing. Surgeons, dentists and other professions do a certain amount of charity work. I don't think a single soul will be left unburied if we leave it alone. We have reduced the amount of money for Old Age Assistance and I feel in this case that I must go along with the Senator from Piscataquis, Senator McKusick; and the Senator from Aroostook, Senator Brewer.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Aroostook, Senator Brewer, that the bill be indefinitely postponed.

A viva voce vote being had,

The motion prevailed and the bill was indefinitely postponed in non-concurrence.

Sent down for concurrence.

On motion by Mr. Haskell of Penobscot, the Senate voted to take from the table bill, An Act Relating to the Liquor Commission (H. P. 1786) (L. D. 1346) tabled by that Senator earlier in today's session pending motion by Senator Barnes to adopt Senate Amendment A; and on further motion by Mr. Haskell of Penobscot, Senate Amendment A was adopted and the bill as so amended was passed to be engrossed in non-concurrence.

Sent down for concurrence.

At this point, the Senate retired to the Hall of the House where a Joint Convention was formed.
