# Ought to Pass with Committee Amendment

Mr. Fuller from the Committee on Judiciary on Bill "An Act relating to the Form of Unregistered Bonds" (H. P. 47) (L. D. 48) reported "Ought to pass" as amended by Committee Amendment "A" submitted therewith.

The Report was read.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. McGlauflin.

Mr. McGLAUFLIN: Mr. Speaker, I would like to ask if that is not an emergency measure.

The SPEAKER: The Chair will inform the gentleman that this purports to be an emergency measure.

Thereupon, the Report was accepted, and the Bill, having already been printed, was read twice under suspension of the rules.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Fuller.

Mr. FULLER: Mr. Speaker, I offer Committee Amendment "A" and move its adoption.

The SPEAKER: The Chair will inform the gentleman that the amendment has been reproduced and is automatically before the House. The Clerk will read Committee Amendment "A".

COMMITTEE AMENDMENT "A" to H. P. 47, L. D. 48, Bill, "An Act Relating to the Form of Unregistered Bonds." Amend said bill by inserting after the underlined words "bear the" in the second line of the paragraph designated as Sec. 16-A, the underlined words and punctuation, 'signature, or the'

Committee Amendment "A" was adopted.

Thereupon, on motion of Mr. Martin of Augusta, the Bill as amended was given its third reading under suspension of the rules, and was passed to be engrossed and sent up for concurrence.

#### Orders of the Day

On motion of the gentlewoman from Lincoln, Miss Steeves, House Rule 25 was suspended for the remainder of today's session in order to permit smoking.

The gentleman from Limestone, Mr. Burgess, was granted unanimous consent to address the House.

Mr. BURGESS: Mr. Speaker and Members of the House: It is my great honor and privilege at this time to make a few remarks authorized by the Republican House members at the convention held last evening.

May I first congratulate the press for in the past having always given our public accurate information, and I am asking them sincerely on behalf of every member of this House to give us such assistance as they know we will need this morning in carrying out to the people throughout the State the information which I hope to make public at this time.

My remarks relate to the Liquor Investigation so-called. The public throughout the State are looking to you and me as their representatives to see that the investigation is relentlessly pursued, but they are just as interested that we, being a fair-minded group, make certain that hearsay and all of those statements which have no basis in fact are dropped by the way.

We as the Legislature have elected to serve us in the legal department one Mr. Alexander LaFleur, Attorney General, and it is his job as our legal representative—not only ours as members of this House, he is the legal representative for the citizenry throughout the entire State of Maine, and it is his responsibility that the investigation is relentlessly pursued; and I have confidence in his department and in his honesty and his integrity to carry the investigation to its full conclusion and to present such facts as are pertinent and admissible before a grand jury at the proper time.

I would like the public throughout the State to know that we as members of this House want that done, and it will be done. (Applause)

We have a joint problem, jointly with the Executive Department, that of rebuilding and restoring confidence in our State govern-Governor, Governor ment. Our Cross, has taken the lead in that respect in naming Clarence Crosby, Chairman of the State Liquor Commission Clarence Crosby, as you members know, is a person above reproach, honest, and against whom the finger of suspicion could never be pointed, directly or indirectly. It is by the continued appointment of such people as Clarence Crosby to positions of high importance that we will be able to restore confidence in our State government. But upon our shoulders rests the problem of providing our legal department, the Attorney General's office, with whatever he needs, be it money, assistance morally, or what not, in order to carry this investigation to its full conclusion.

I want to pay a tribute to those gentlemen who served on the Legislative Research Committee. They were unguided by the rules of evidence because there were none available. Our courts have rules of evidence which guide the admission of certain statements. Our Research Committee has been criticized for things they were not responsible for because they were not provided with the tools with which to do the job correctly.

So, on behalf of the House, I want to thank the Research Committee for having done the job that it did do in bringing to the public such facts as they were able to bring.

And now, in conclusion, may I say again that the investigation should not take on a political nature. If we have a job of cleaning any department or the department, if there is anything to clean, let us assume it, clean our own house, and let the public know that we stand for that and will carry it to a full and just conclusion. (Applause)

Mr. Senter of Brunswick was granted unanimous consent to address the House off the record.

The SPEAKER: On the record. The Chair recognizes the gentleman from Augusta, Mr. Albert.

Mr. ALBERT: Mr. Speaker and Members of the House: If I be in order, I move that the poem of the gentleman from Portland, Mr. Mc-Glauflin, be made a part of the official record.

The SPEAKER: The gentleman from Augusta, Mr. Albert, moves that the poem just presented off the record be made a part of the official record of the House. Is this the pleasure of the House?

The motion prevailed, and the following poem by the gentleman from Portland, Mr. McGlauffin, is made a part of the official record of the House:

"AUGUSTA STATE HOSPITAL

I went to the hospital Tuesday

And I walked from ward unto ward.

I saw both the poor and the help-less

Some will soon lie under the sod.

There were women whose eyes had sparkled

With the joy of just being alive. There were men who once had strong bodies,

With ambition to work and to strive.

Now, they are both old and forsaken,

The fire of their lives has burned low.

They neither have hope for the future

Nor any place where they can go.

May our God have mercy upon them

They too are the sheep of His fold.

May he gather each to His bosom There, their valuable souls to hold."

The SPEAKER: At this time, the Chair would like to call to the attention of the Members, under Rules of the House, parts of Rule 19 and Rule 20, which deal specifically with leave of absence. The reason that the Chair is bringing this to the attention of the Members now is because of the numerous requests from various Members as to the operation of the Leave of Absence Committee.

"... no member shall be absent more than two days without leave of the House; and no member shall have such leave, unless it be reported by the committee on leave of absence; and no leave of absence shall avail any member who retains his seat more than five days from the time the same was obtained.

"Any member having obtained leave of absence, and having in his possession any papers relating to the business before the House, shall leave the same with the Clerk." In essence, the Chair requests that any Member who is planning to be absent two or more days or who finds that he has been absent two or more days due to illness after having left the House, to report to the Chairman or some member, preferably the Chairman, of the House Committee on Leave of Absence, the gentleman from Houlton, Mr. DeBeck, and to the Clerk's office.

The House is continuing under Orders of the Day.

The Clerk will read the notices. There are no notices other than those which have been reproduced and distributed.
