'XIV. Automobiles to amputee veterans. Sales of automobiles to veterans who are granted free registration of such vehicles by the secretary of state under the provisions of section 13 to chapter 19. Certificates of exemption of refunds of tax paid shall be granted under such rules or regulations as the assessor may prescribe.' "

# ORDERS

# **Tabled and Assigned**

The SPEAKER: The Chair recognizes the gentleman from Limestone, Mr. Burgess.

Mr. BURGESS: Mr. Speaker, I present an order and, before the action is taken, I would like to make a few brief remarks.

The SPEAKER: The gentleman from Limestone, Mr. Burgess, presents an order. The Clerk will read the order.

The CLERK:

WHEREAS estimated revenues of the department of Inland Fisheries and Game amount to \$1,476,577 in the 1953-1954 year and \$1,465,327 in the 1954-1955 year; and,

WHEREAS the department of Inland Fisheries and Game has submitted to both the Budget Committee and the Committee on Appropriations and Financial Affairs that this biennial income of \$2,941,-904, increased to \$3,096,433 by the estimated carrying balance of \$154,-529, is not sufficient to finance desirable capital needs and is barely sufficient to meet their expanded expenditure needs; and,

WHEREAS Chapter 355 of the Public Laws of 1947 does dedicate the afore-mentioned sums to the department for their expenditure without legislative consideration of what may be the reasonable needs of the department;

NOW, THEREFORE BE IT OR-DERED, the Senate concurring, that,

1. The Joint Standing Committee on Inland Fisheries and Game proceed forthwith to

- a. Study the problem presented by the apparent inadequacy of existing revenues to carry out the legislative intent expressed by the passage of Chapter 355 of the Laws of 1951 whereby dedicated revenues was to be sufficient to meet all department needs.
- b. Determine whether or not a sounder financial control could be accomplished by requiring specific legislative appropriation of department revenues in a manner generally followed in the highway appropriation measure.
- c. Make such further study as the Committee may determine to be desirable in accomplishing maximum efficiency and economy in the department of Inland Fisheries and Game.

In carrying out the purposes of this Order the Committee on Inland Fisheries and Game may consider that it should take unto itself without reference to the Committee on Appropriations and Financial Affairs the task of reporting to the Legislature, bills, resolves or otherwise, such recommendations as it may wish to make.

The SPEAKER: The Chair recognizes the gentleman from Limestone, Mr. Burgess.

Mr. BURGESS: Mr. Speaker and Members of the House: In order to briefly explain the intention of the order. I would like to use a comparison, namely, that of the Highway Department. As we are all aware, revenue to the Highway Department is dedicated for highway use by constitutional amendment. The highway funds come to us, as Legislators, from the Committee on Highways in the form of a regular appropriations bill, which sets forth in the usual manner the amounts to be appropriated for the various expenditure items of the Highway Department.

At the present time, your Inland Fisheries and Game Department find themselves in a deplorable condition. Namely, that the income to that department is dedicated for the use of that department. Your Committee on Appropriations and Financial Affairs believes that at this time a transfer of those activities as far as committee work is concerned should take place from Appropriations to the Committee on Inland Fisheries and Game, in order that they may give it a more thorough study than has ever previously been given in hopes that it will present an appropriations bill, which will set up in effect as accurately as they can determine the amounts needed for personal services, the amounts needed for this, that and the other and that it should be handled as any other department of the State is handled.

Now, Mr. Speaker, with that brief explanation, I move you, sir, that the order lie on the table and be specially assigned for February 25.

The SPEAKER: The gentleman from Limestone, Mr. Burgess, moves that this order lie on the table pending consideration and be specially assigned for Wednesday, February 25 and that it be reproduced. Is this the pleasure of the House?

The motion prevailed and the order was so tabled and assigned.

# Orders of the Day

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Stewart.

Mr. STEWART: Mr. Speaker, I wish to make my contribution to the clearing of the table by moving to take from the table the fifth unassigned item, and I wish to make a motion with respect thereto.

Thereupon the House voted to take from the table the fifth tabled and unassigned matter, House Divided Report—Majority "Ought not to pass" and Minority "Ought to pass" of the Committee on Liquor Control on Bill "An Act Regulating Liquor Advertising" (H. P. 191) (L. D. 202) tabled on February 19 by the gentleman from Portland Mr. Stewart, pending acceptance of either report.

The SPEAKER: The Chair recognizes the same gentleman.

Mr. STEWART: Mr. Speaker, I move the acceptance of the minority "Ought to pass" report and wish to address myself to that motion.

The SPEAKER: The gentleman from Portland, Mr. Stewart, moves to accept the minority "Ought to pass" report.

The gentleman may continue.

Mr. STEWART: Mr. Speaker, at the hearing on the bill it was given a full and fair hearing. That is H. P. 191, L. D. 202, Bill "An Act Regulating Liquor Advertising." It was brought out in that hearing that there were certain aspects of the bill that were vicious. My purpose in presenting my motion at this time is solely for the purpose of bringing to your attention an amendment and asking you to adopt it.

This amendment would eliminate from the bill all the elements of the bill that were brought out in the hearing and considered by the opponents of the bill to be vicious. A reading of the amendment which we are to offer in connection with this motion brings out the fact that the law as it now reads claims authority to regulate liquor adver-tising. The Revised Statutes read: "No advertising of liquor within the State shall be permitted except in such form as may be specifically authorized by the Commission, provided that radio, billboards, signs, newspapers, magazines and periodicals may carry advertising subject to the regulations of the Commission."

It is the purpose of this amendment to clarify the present law in regard to a new invention, television, and to spell out the powers in regard to advertising that are now claimed for the Commission by the Revised Statutes. It would clarify and perhaps prevent any litigation in the future if this bill in amended form received favorable consideration.

We are all impressed with the courage and conviction and sincerity of the sponsor of this bill, the lady from Presque Isle (Mrs. Christie). It is my hope that you will go along with the minority report and accept the minority report so that this amendment may be adopted which just adds a further clarification to the existing law and which eliminates all controversial items which were in the original bill. I so move, Mr. Speaker.

The SPEAKER: The question before the House is on the motion of the gentleman from Portland, Mr. Stewart, that the House accept the minority "Ought to pass" report of the Committee on Liquor Control.

The Chair recognizes the gentlewoman from Presque Isle, Mrs. Christie.

Mrs. CHRISTTE: Mr. Speaker and Members of the House: I am sure we all recognize the possibilities of television and we realize that television is coming into Maine or has come into Maine and by that means we may have a great deal of education. Education may be for good or it may be for evil. The possibilities of evil from liquor advertising over television are greater perhaps than through any other medium. I want to go along with the motion of the gentleman from Portland (Mr. Stewart) in favor of this bill as amended.

The SPEAKER: Is the House ready for the question?

As many as are in favor of the motion of the gentleman from Portland, Mr. Stewart, to accept the minority report "Ought to pass" of the Committee on Liquor Control on Bill "An Act regulating Liquor Advertising" (H. P. 191) (L. D. 202) will please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Mr. TOTMAN of Bangor: Mr. Speaker—

The SPEAKER: For what purpose does the gentleman rise?

Mr. TOTMAN: Mr. Speaker, am I out of order in asking a question at this time before the count is accepted?

The SPEAKER: The gentleman may direct his question.

Mr. TOTMAN: May I direct a question to Mr. Stewart before the report is given by the monitors?

The SPEAKER: If you desire to address a parliamentary question to the Chair the Chair will entertain the question.

Mr. TOTMAN: My question, Mr. Speaker, is not parliamentary. It is simply a question for information. I do not understand the amendment and I would like to ask a question of information.

The SPEAKER: The Chair will state that the amendment is not now before the House. The question before the House which is being voted upon at this time is on the acceptance of the minority "Ought to pass" report of the Liquor Control Committee.

Mr. TOTMAN: Perhaps I did not make myself clear, Mr. Speaker. I wanted to ask of Mr. Stewart what we are voting on.

The SPEAKER: The House is voting on the motion of the gentleman from Portland, Mr. Stewart, that the minority report "Ought to pass" from the Committee on Liquor Control on Bill "An Act Regulating Liquor Advertising" be accepted.

Fifty-six having voted in the affirmative and thirty-six in the negative, the minority "Ought to pass" report is accepted.

This being a printed bill, under suspension of the rules, it was given its two several readings.

Mr. Stewart then presented House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 191, L. D. 202, Bill, "An Act Regulating Liquor Advertising."

Amend said Bill by striking out everything after the enacting clause and inserting in place thereof the following:

**R.** S., c. 57, Sec. 59, amended. The first sentence of section 59 of chapter 57 of the revised statutes is hereby amended to read as follows: 'No advertising of liquor within the state shall be permitted except in such form as may be specifically authorized by the commission, provided that radio, billboards, signs, newspapers, magazines, and periodicals may carry advertising subject to the regulations of the commission; and

further provided that no television programs advertising liquor originating in the state and no advertising of liquor in television films to be used in programs originating in the state shall be permitted except in such form as may be specifically authorized by the commission and subject to the regulation of the commission.<sup>2</sup>

House Amendment "A" was adopted and the bill as amended was tomorrow assigned for third reading.

The gentleman from Pittsfield, Mr. Cianchette, was granted unanimous consent to address the House. Mr. CIANCHETTE: Mr. Speaket and Members of the House: After reading this morning's paper, I feel compelled to speak briefly to express my regrets at the remarks made by the Governor in his speech last night in Portland in which he referred to the liquor scandal and to the request by the Attorney General for an additional \$35,000 to continue his probe.

I regret that our Governor has seen fit to express his lack of confidence in the members of this Legislature.

I regret that he has seen fit to do this even before the matter to which he refers has been reported out of committee.

I regret his implication that the members of this Legislature lack the intelligence to act competently upon the matters brought before them.

I regret the impression that this Legislature has been influenced by a political slush fund.

I regret that he has seen fit to place the blame for this liquor situation upon the shoulders of his predecessor in the office of Governor while complaining that the man who attempted to bribe this Governor was being ill-treated.

Finally, I regret that those who are charged with the prosecution and correction of this filthy mess cannot quietly proceed with both eyes directed toward their work rather than one eye constantly upon the headlines.

The SPEAKER: The House is proceeding under Orders of the Day.

If there is no further business to come before the House at this time, the Clerk will read the notices.
