The Chair recognizes the gentleman from South Portland, Mr. Fuller.

Mr. FULLER: Mr. Speaker, I think we are all cognizant of the fact that the Appropriations and Financial Affairs Committee is, without question, the busiest committee of the Legislature.

This order would relieve them quite a bit and also would not give the Department of Inland Fisheries and Game a blank check, which they now have and which the officers do not want. I, therefore, hope that this order may receive passage.

Thereupon, the Joint Order (H. P. 1031) received passage and was sent up for concurrence.

The SPEAKER: The House is continuing under Orders of the Day.

Mrs. CHRISTIE (of Presque Isle): Mr. Speaker—

The SPEAKER: The Chair will request that the gentlewoman from Presque Isle, Mrs. Christie, defer her motion. The Clerk calls at-

tention to the fact that the House has a specially assigned matter, Bill "An Act relating to Inspection of Schools," House Paper 254, Legislative Document 284, tabled for later in today's session by the gentleman from South Portland, Mr. Fuller, pending third reading.

Thereupon, on motion of Mr. Fuller of South Portland, the House voted to take from the table Bill "An Act relating to Inspection of Schools" (H. P. 254) (L. D. 284). The same gentleman then offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 254, L. D. 284, Bill "An Act Relating to Inspection of Schools."

Amend said Bill by striking out in the next to the last line thereof, the underlined punctuation and word ", terms".

House Amendment "A" was adopted, and the Bill was given its third reading, passed to be engrossed as amended and sent to the Senate.

The SPEAKER: The Chair recognizes the gentlewoman from Presque Isle, Mrs. Christie.

Mrs. CHRISTIE: Mr. Speaker, I would like to take from the table the fifth tabled and unassigned matter and I would like to speak briefly in regard to that bill.

The SPEAKER: The gentlewoman from Presque Isle, Mrs. Christie, moves to take from the table the fifth tabled and unassigned matter, House Divided Report, Majority "Ought not to pass" and Minority "Ought to pass", of the Committee on Liquor Control on Bill "An Act relating to Limitation of Liquor Licenses", House Paper 192, Legislative Document 203, tabled by that gentlewoman on February 19 pending acceptance of either report. Is this the pleasure of the House?

The motion prevailed.

The SPEAKER: The gentlewoman may continue.

Mrs. CHRISTIE: Mr. Speaker, on inquiring of the Liquor Commission in regard to the matter of issuing licenses, I find that they have no restrictions whatever as to population in relation to the number of licenses allowed. Their only restrictions are in the matter of the desirability of applicants for licenses. For that reason, it seems to me that there should be something done about this matter.

In the State of Maine, they may have as many licenses as the people who want to secure licenses apply for and it seems to me that this is not a good situation. The more outlets we have, the greater sales we will have in our State and I feel that that is not good. The more sales, the more alcoholism and we find from the report of the Liquor Research Commission issued in 1950 that there are at least 5,000 alcoholics in the State of Maine as of the time of that report.

The Commission also said that they are very much disturbed about the great increase in drinking, they are alarmed, that is the word they used, about the increase in drinking among the young people.

If we were to have fewer outlets or, at least, were not to have more outlets, we would reduce the temptation for alcoholics to drink. Sometimes, just passing by a place where liquor is sold and getting the odor of that liquor is enough to make an alcoholic want to drink where, perhaps, if he were not so closely in contact with that odor he would not drink so much.

According to the figures, I have found that Maine has 2,077 liquor outlets at the present time, places where they can sell on the retail level. In the Town of Ashland, they have 2,370 members and yet, in that town, they have one spirituous and vinous liquor license, that is, a cocktail lounge, one club license, three restaurants, and eight bottled beverage licenses. You can readily see that this makes altogether too many outlets for a small town like that.

In connection with this, I would like to tell a little story that was told to a member of my family by a teacher in the town of Ashland. She said, one day, a little boy came into the school and he said: "I can't buy any dinner today." He said: "My mother drinks and she is in bed drunk and she couldn't give me the money to buy the dinner." I am sure that this case could be multiplied a thousand times or more in our State of Maine and it is a bad situation. She said that conditions in the schools in Ashland are terrible.

The Federal Bureau of Investigation records show a disturbing increase in crime. Drunkenness accounts for a major part of the duties of the police. To learn about this, read your police reports.

I would like to tell you about the Town of Houlton. In 1941 and '42, they had some liquor outlets. The arrests for intoxication in 1941 were 427, for drunken driving 17. In 1942, arrests for intoxication were 378, for drunken driving 15. In the fail of 1942, Houlton voted dry all across the board and beginning in January 1943 they had a dry period of two years. In 1943, arrests for intoxication were 129 and for drunken driving 11. In 1944, for intoxi-cation 79 and drunken driving 8. You see, it dropped from a high in 1941, a wet year, of 427 to a low of 79 in the second dry year. Then, in 1944, Houlton very unwisely, in my opinion, voted in a liquor store and in 1945, the first year under the liquor store, there were arrests for intoxication of 494, for drunken driving 21, and in 1946, for intoxication 603, and drunken driving, 29.

This clearly indicates that even one community voting dry helped greatly in the police problem of that area. Of course, this is better than having just reduced outlets. This got rid of the outlets for two years and a very marked decrease in police activities resulted.

Now, we are not inclined to think very much about sob stuff but I do want to read some quotations from a letter that I received some time ago from a woman in this city. She said: "I feel a new strength whenever I see your name because I associate it with the abolishment of drink or trying to abolish drinking. My vitality has been so sapped by all that has happened that I cannot even write that which is in my mind. My own grief is terrible but there is still room in my heart to pray for young mothers with drinking husbands, old mothers with drinking fathers and sons." That is only part of the letter which was written to me and I have received other letters from this same city in regard to the problem in the home because of the drinking of alcoholic beverages.

To my way of thinking, this bill would, at least, put some restriction, not too much, but a little restriction, on the number of outlets and thus, perhaps, reduce a little bit the temptation to drink on the part of a great many people who are spending money for alcoholic beverages that they should be spending in their homes. I move the acceptance of the minority report.

The SPEAKER: The gentlewoman from Presque Isle, Mrs. Christie, moves that the Minority "Ought to pass" Report of the Committee on Liquor Control on Bill "An Act relating to Limitation of Liquor Licenses," House Paper 192, Legislative Document 203, be accepted. Is this the pleasure of the House?

(Cries of "No" and "Yes")

The SPEAKER: As many as are in favor of the motion of the gentlewoman from Presque Isle, Mrs. Christie, that the minority "Ought to Pass" Report of the Committee on Liquor Control on Bill "An Act relating to Limitation of Liquor Licenses." House Paper 192, Legislative Document 203, be accepted will please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Forty-seven having voted in the affirmative and seventy having voted in the negative, the motion did not prevail.

Thereupon, the Majority "Ought not to pass" Report was accepted and sent up for concurrence.

The SPEAKER: The House is continuing under Orders of the Day.

The Chair recognizes the gentleman from Brooks, Mr. Dickey.

Mr. DICKEY: Mr. Speaker, I rise for a point of information.

The SPEAKER: The gentleman may state his point.

Mr. DICKEY: Mr. Speaker, I would like to ask who is responsible for the inserting of the third item under today's notices.

The SPEAKER: The Chair has no knowledge at this time.

Mr. DICKEY: Mr. Speaker, is it all right for me to ask the Clerk who is responsible for having this inserted? To my mind there is no Committee on Apportionment at this time.

The SPEAKER: For the gentleman's information, under Orders of the Day, the Chair intends to announce the House membership of Apportionment.

Mr. DICKEY: Mr. Speaker, I further ask in my point of information, inasmuch as we do not have a Committee of Apportionment, I am highly desirous of inquiring who inserted this item for the committee to meet when we do not have a committee.

The SPEAKER: The Chair will state at this time that provisions for such a committee have been made by means of a joint order, (S. P. 157) seven on the part of the Senate and sixteen on the part of the House.

The House is continuing under Orders of the Day.

The Chair at this time will make appointments to the Committee on Apportionment on the part of the House. The Clerk will read the appointments.
