# Orders of the Day

Mr. Butler of Franklin was granted unanimous consent to address the Senate.

Mr. BUTLER: Mr. President and members of the Senate: You of course realize that we have a cloture rule already established, but if you would keep in mind, please, that if you have some special pension bills which you are thinking of putting in and you perhaps are hesitating to present in the belief that they may be applicable under the Federal legislation, if you will please present them just the same so they can be processed. The committee have gone into detail with the department and have found that the organization is progressing rapidly, but it will be well into the session before that department is in a position to process such pensions as are entitled to come within the Federal act, which will be well after our deadline, but they do have the authority to transfer from pensions to the Federal act where the recipient is eligible for it. This will facilitate the committee's work and you in turn will assist your constituents by looking after their needs and processing their requests in the regular channels so that we may act upon them. I thank you.
