#### Senate Committee Report

Mr. Low from the Committee on Taxation on Bill "An Act to Provide Credit or Refund for Tobacco Tax Stamps and Correcting Error in Discount for Tobacco Tax Stamps" (S. P. 20) (L. D. 4) reported that the same Ought to pass as Amended by Committee Amendment "A".

"Committee Amendment A to bill. An Act to Provide Credit or Refund for Tobacco Tax Stamps and Correcting Error in Discount for Tobacco Tax Stamps." (S. P. 20) (L. D. 4)

"Amend said bill by adding at the end thereof before the emergency clause the following: "Section 5. Effective date of Section 1. The provisions of Section one of this act shall be retroactive to January 1, 1955."

Which amendment was adopted and on motion by Mr. Low of Knox the rules were suspended, the bill given its second reading and passed to be engrossed.

#### Orders of the Day

Mr. Parker of Piscataquis presented the following order and moved its passage:

ORDERED, the House concurring, that the Committee on Highways be and hereby is authorized and directed to report to the legislature such recommendations as may seem proper with respect to proposed reclassification of highways. It is the intent of this Order that the report be in the form of a resolution and that the resolution be directly related to the several plans presented informally by the Highway Commission in its series of meetings on highway problems.

Mr. PARKER: Mr. President and Members of the Senate, probably no subject received any more discussion or debate than the highway reclassification program in the last session. It is the thought of the highway committee that if this matter could be given some thought early in this session with the idea in mind that this touchy problem could be settled prior to the annual town meetings in our state that we would be doing a service to our towns. It is that thought that prompted this order this morning.

I am sure that we will make every effort to present the thinking of the towns in the state in the resolution that we will bring up if we have that opportunity.

Mr. SILSBY of Hancock: Mr. President, would it be in order to have the clerk read the Order again?

The Secretary read the Order.

Thereupon, the Order received passage.

Mr. BUTLER of Franklin: Mr. President, I move that the Senate reconsider its action taken earlier this morning whereby it referred to the Committee on Judiciary bill, An Act Amending the Mining Law (S. P. 78)

I make this motion because this same bill came before us two years ago at the last session, at which time it was referred to the Natural Resources Committee. While I fully appreciate that the Natural Resources Committee is not the Judiciary Committee, yet I also fully appreciate that the principle for which we are working on this problem is pertaining directly to natural resources, and as such I feel that the Committee on Natural Resources is better able to look into the problem instead of referring it to the Committee on Judiciary which will be more interested in crossing the T's and dotting the I's than complying with the request of those who are interested in the further development of our natural resources. It is with that thought in mind and that only that I feel we should refer this bill to the committee which is fundamentally studying the natural re-sources instead of the Judiciary Committee.

The PRESIDENT: The question before the Senate is the motion of the Senator from Franklin, Senator Butler, that the Senate reconsider its action whereby S. P. 78 "An Act Amending the Mining Law" was referred to the Committee on Judiciary. The Chair recognizes the Senator from Kennebec, Senator Reid.

Mr. REID: Mr. President, I wish to oppose the Senator from Franklin, Senator Butler, in one respect and go along with him in another. I am sure that my agreement to go along with him in the other is acceptable to him. I do not think the Judiciary Committee, at least as far as the past is concerned, is interested only with the dotting of the I's and crossing of T's, because I think it has a great responsibility. If, however, the Senator's feelings are so strong that this particular bill belongs in that committee, my feelings are not so strong, but I will go along with him on his motion to reconsider

The PRESIDENT: Is it the pleasure of the Senate that we reconsider our action whereby S. P. 78, "An Act to Amend the Mining Law" was referred to the Committee on Judiciary?

The motion prevailed, and the bill was referred to the Committee on Natural Resources and sent down for concurrence.

The PRESIDENT: The Chair recognizes the Senator from Hancock, Senator Silsby.

Mr. SILSBY: Mr. President, in the matter that we have just passed, the order on the Committee on Highways, I would like to move for reconsideration to the end that this order may be tabled to give me the opportunity to examine the last paragraph.

The PRESIDENT: The Senator from Hancock, Senator Silsby, moves that the Senate reconsider its action whereby the order in reference to the Committee on Highways was passed. Is this the pleasure of the Senate?

The motion prevailed and the Senate voted to reconsider its action. On further motion by the same Senator, the order was tabled pending passage.
