Orders of the Day

Mr. Reid of Kennebec was granted unanimous consent to address the Senate.

Mr. REID: Mr. President and members of the Senate: This is just a brief report of the progress resulting from the meeting of the committee of the whole that we had last week with respect to notices to weeklies of legislative hearings.

For those who wanted to make sure that we did not commit ourselves beyond the point we should go, a release was sent out, dated February 2, 1955, with the following preamble:

"The following tabulation of legislative hearings for next week represents all of the available information as of the date of this release. It is not necessarily a complete list of all legislative hearings for the following week. It is offered only as a news release and is not an order to advertise the hearings. It should not be interpreted as representing a complete list of all Bills that may advertised for hearings week. This is our first effort on a Wednesday release. Next week we will try to assemble at least some of the lists for Tuesday release. We invite your comments and criticism, hopeful that we can give you a news service of some value." That is signed by our President.

That release which was sent out contains four mimeographed sheets and a good list of a number of committee hearings and a fairly complete list of bills. Of course we have not had time to get complete responses, but I do have letters from The Brunswick Record and Sanford Publishing Company expressing their appreciation.

I would remind the Senate chairmen of the committees that if they will this afternoon obtain so far as they can a list of the bills that are in their committee rooms now that they are sure are going to be heard next week and have the clerks of your committees make up that list and give it to Mearle Norton, then those weeklies that publish next Wednesday will at least have something, and then tomorrow please get the complete list in as early as you can and have it in the hands of Mearle Norton. If you do that, probably the bulk of bills to be heard next week can be advertised in those newspapers that publish on Thursday.

I think that the system outlined at the hearing of the committee on the whole is really working out mechanically and will be of a great deal of benefit and interest to the weeklies.

The PRESIDENT: The Chair would add to that comment that as many chairmen as can get next week's hearings list into Mrs. Norton sometime before 2:30 or 3:00 this afternoon should do so, so that she can get them out and the papers that are published tomorrow will have them.
