Mr. COLLINS of Aroostook: Mr. President and members of the Senate, I would like to offer a bill for unanimous consent and in so doing, I would like to explain to the Senate why it is necessary to do so.

Two years ago, the legislature passed a bill creating the Caribou Hospital District. We find now that one of the conditions of the bill needs a technical change, and I did not discover this until after the deadline on the entering of bills for private and special legislation. I got legal opinion which stated that it would be better if this technical change was made. I am sure it will not delay the work of the legislature. I have been assured by the Senator from Penobscot, Senator

Woodcock, that if the bill is referred to Legal Affairs, they are willing to accept it and I therefore offer this bill for acceptance by unanimous consent.

Thereupon, bill, An Act Amending the Charter of the Caribou Hospital District was received by unanimous consent, referred to the Committee and on Legal Affairs ordered printed.
