The Committee on Claims on "Resolve in Favor of The Richmond.

Maine, Camp Grounds of the Church of the Nazarene." (H. P. 91) (L. D. 102) reported that the same Ought to pass.

Mr. LOW of Knox: Mr. President, this is the first of about a dozen claims by various people for damages done to them by escapees from various state institutions. All told, those claims will approximate ten to fifteen thousand dollars. This one here is about \$1394. The committee reported this claim "Ought to Pass," with some misgivings. You can either argue that the boys who escaped are wards of the state and the state is responsible for them and should pay for the damage which they do, or you can equally well argue that in the case of a father whose boys went and did damage that he would be responsible and would have to pay for damage which they did.

In voting on this measure I think we ought to realize we are establishing a precedent for these other claims, and if we vote for this one we ought to expect to vote for all the other ones. In order that we may have a little time to think on this, I move that this bill be tabled and especially assigned for next Tuesday.

The PRESIDENT: The Senator from Knox, Senator Low, moves that this bill and accompanying papers be laid upon the table and be especially assigned for Tuesday next. Is this the pleasure of the Senate?

The motion prevailed and the resolve was laid upon the table pending acceptance of the report.

Orders of the Day

The PRESIDENT: The Chair now lays before the Senate H. P. 107, L. D. 115 House Report Ought to pass as amended by Committee Amendment "A" from Committee on Judiciary on Bill "An Act relating to Right of Way for Police and Fire Vehicles and Ambulances," tabled on February 15, 1955 by the Senator from Kennebec, Senator

Reid, and especially assigned for this legislative day.

The Chair recognizes the Senator from Kennebec, Senator Reid.

Mr. REID of Kennebec: Mr. President, this is a bill relating to sirens on police cars, department trucks, emergency repair vehicles and ambulances.

The present law reads that police, fire department trucks, emergency repair vehicles and ambulances when operated in response to call shall have the right of way, and on the approach of any such vehicle the driver of any other vehicle shall immediately draw his vehicle as nearly as practicable to the right-hand curb.

The present bill proposes to change that on the theory that drivers of motor vehicles ought to move over whether or not the ambulance or police car, as the case may be, is approaching it; in other words if it comes from any direction. And so the bill proposes to amend it by saying "on the approach of any such vehicle from any direction and when such vehicle is sounding a siren or displaying emergency lighting devices."

The committee was at a loss to understand how the approach from any direction could apply to lighting devices because they naturally could not be seen except on approach; and for that and other reasons they amended the bill only to include the necessity of moving over when you heard a siren from any direction and when such vehicle is sounding a siren, and reported the bill "ought to pass" with Committee Amendment "A". The other branch added an amendment which says "provided however that operators of such vehicles shall approach intersections with due care."

After that amendment it occurred to the Committee that that sponsor was in favor of the ambulances and police cars whereas the amendment seems to favor the motorist; and therefore a conversation was had with the sponsor, and I am at liberty to say that he was under a misapprehension in respect to this suggested amendment. I therefore propose to move that the "Ought to pass as amended by Committee Amendment 'A'" report be ac-

cepted, and if it is accepted to move the indefinite postponement of House Amendment 'A' in non-concurrence.

Mr. President, I move the acceptance of the Committee report "Ought to pass as amended by Committee Amendment 'A'".

Committee Amendment 'A'".

Thereupon, the ought to pass as amended report of the committee was accepted in concurrence and the bill read once; on motion by Mr. Reid of Kennebec, House Amendment "A" was read and indefinitely postponed, Committee Amendment A was read and adopted and the bill as amended by Committee Amendment A was tomorrow assigned for second reading.

PRESIDENT: The The Chair notes in the gallery a group of young men and women from Westbrook High School. It is my pleasure to welcome you to the legislature and we hope you enjoy our sessions. We hope you will visit with us and let us show you the courtesy of the state house so that you can take back with you a little better understanding of your state government. We are very glad to have you here.

On motion by Mr. Low of Knox, the Senate voted to take from the table Resolve in Favor of Gordon M. Stewart of Paris, Administrator, d.b.n.c.t.a. of the Estate of Eva M. Elliot, Late of Otisfield, Deceased (S. P. 29) (L. D. 18) tabled by that Senator on February 15 pending passage to be engrossed; and on further motion by the same Senator, the resolve was passed to be engrossed.

Mr. Weeks of Cumberland was granted unanimous consent to address the Senate.

Mr. WEEKS of Cumberland: Mr. President and Senators, during the month of December, 1954, there appeared in the Gannett publications, a series of editorials under the general heading of "Modernizing the Legislature." There were twentyone of these editorials, each with their individual heading, dealing with "Research," "For Better Laws," "Reapportionment," "The

House is Too Big," and other subjects of serious importance to all of us and the people of the State of Maine. Mr. Dwight Sergeant, chief editorial writer of the Gannett papers, is the one who prepared editorials after a long period of research and study, and they represent very solemn and cautious and serious thinking.

These editorials have now been assembled in a pamphlet and the Senate and House have been sup-

plied with them. The Sergeant-at-Arms has them over on his desk. I call this to your attention so that you may avail yourselves of the opportunity to pick up one of these and because I believe there is some very, very good reading for all of us in them. Thank you.
