WHEREAS the Committee believes that it is not desirable to increase the cost for maintenance or construction of highways at the local level; and

WHEREAS, the Committee believes that many municipalities could not undertake the needed improvement to rural highways under Plans 2, 3, 4, and 5;

Be it resolved that the Committee recommends to the 97th Legislature

the adoption of Plan 1 with the provision that any town which so desires may apply to the State Highway Commission for reclassification of any part of its state aid highway

Mr. PARKER of Piscataguis: Mr. President and Members of the Senate, because of the importance of this order and because of the fact that in our previous session two years ago, there was a great deal of misunderstanding, and because of the fact that our committee has gone to great lengths to iron out some of this misunderstanding I move that this recommendation be accepted. that it be placed on file and that a copy be forwarded to the Highway Commission.

# Orders of the Day

On motion by Mr. Hillman of Penobscot it was voted to take from the table H. P. 101, L. D. 109, Bill "An Act Relating to Free Fishing Licenses to Residents 75 Years of Age." tabled by that Senator on February 16th pending passage to be engrossed.

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Hillman.

Mr. HILLMAN: Mr. President, I move that H. P. 101, L. D. 279, Bill "An Act Relating to Free Fishing Licenses to Residents 75 Years of Age" be indefinitely postponed.

The PRESIDENT: The Senator from Penobscot, Senator Hillman, moves that the bill be indefinitely

postponed.

The Chair recognizes the Senator from Somerset, Senator Carpenter.

Mr. CARPENTER: Mr. President and Members of the Senate: I feel that I must defend my position of this bill.

This bill was originally intended to permit free fishing and hunting licenses and it was made to read "free fishing licenses." I still think the bill is a good one. It will not in any way affect the economy of the Fish and Game Department. We have few people seventy-five years of age and over who will actually take out a license, and I think personally it is a nice little gesture to pass on to the people who are on the very eve of their lives. I hope that the motion of the gentleman from Penobscot, Senator Hillman, does not prevail.

The PRESIDENT: The Chair recognizes the Senator from Oxford, Boyker.

Mr. BOYKER: Mr. President and Members of the Senate: Do we feel that in denving a hunting license to those citizens of our State seventyfive years of age that we fear that a man seventy-five years of age in the woods with a gun in his hand will be a nuisance and a hazard to life and property? We have in the State of Maine today around 300 Spanish - American War veterans seventy-five years of age. Now the Spanish - American War Veterans may have used arrows and the spear but I know that they used guns because I was there. We have in our State also around four thousand veterans seventy-five years of age and they may have used shot-guns but I know some of them who used rifles. And so I say that these men in the woods with one gun or two in their hands are not a menace or hazard to life and property, and the same is true of other citizens seventy-five years of age whose hobby has been hunting throughout their lives. I say

that in giving those men a free hunting license we show them our appreciation for the part which they have paid through their lives in building up the good that is in our State today.

The Secretary read House Amendment A which had been previously read and adopted in the House, and read and adopted in concurrence in

the Senate.

Mr. CARPENTER of Somerset: Mr. President, when the vote is

taken I request a division.

Mr. DOW of Lincoln: Mr. President I would like to inquire of the Senator from Somerset, Senator Carpenter, whether this free fishing license would include fishing for lobsters and digging for clams. In my county I have quite a number of people seventy-five years of age, fishermen who would like to catch lobsters and dig clams for the sport of it. If this does not cover them also. I should feel that this is class legislation and I would have to concur with the Senator from Penobscot, Senator Hillman in the indefinite postponement.

The PRESIDENT: The Senator has heard the question and may answer if he wishes.

Mr. CARPENTER: Mr. President I would like to inform the Senator from Lincoln, Senator Dow, that this does not include fishing for lobsters but if he feels free to go along with the bill and not vote for indefinite postponement, I will gladly offer an amendment tomorrow.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Penobscot, Senator Hillman, that the bill be indefinitely postponed and the Senator from Somerset, Senator Carpenter has asked for a division.

Is the Senate ready for the question?

A division of the Senate was had. Nineteen having voted in the affirmative and ten opposed, the bill was indefinitely postponed in nonconcurrence.
