'Section 1. R. S. Chapter 81, Section 1. The second paragraph of Section 1 of Chapter 81 of Revised Statutes is hereby amended to read as follows:

'The board shall be composed of five practicing architects or four practicing architects and one Professor of Architecture who shall be appointed by the Governor with the advice and consent of the Council, to serve for three years and until their successors are duly appointed and qualified. Each member of the board shall receive a certificate of his appointment from the Governor.'

D. 429 "Resolve Continuing Unexpanded Balances for Repairs and Construction in Certain State Institutions, tabled by that Senator on February 24th pending assignment for second reading.

Mr. FULLER of Oxford: Mr. President, this bill proposes to continue certain unexpended balances of moneys allocated in 1953 for repairs to certain state institutions and construction, State Hospitals,

Sanatoriums, Schools for Boys and Girls, Reformatory for Men, Reformatory for Wen, Reformatory for Women. I wish to propose an amendment that will include four of the State Teaches Colleges: Aroostook State Teachers College, Presque Isle, for repairs; Farmington State Teachers College, for construction of class room and library; Gorham State Teachers College, for construction of Men's dormitory; and Washington State Teachers College, Machias, for repairs and construction.

Mr. President, I present Senate Amendment "A" and move its adoption

Thereupon, the amendment was adopted without reading and under suspension of the rules, the bill as amended was given its second reading and passed to be engrossed.

Sent down for concurrence.

On motion by Mr. Farris of Kennebec, the Senate voted to take from the table House Report ought to pass as amended from the Committee on Legal Affairs on bill "An Act to Grant a New Charter to the City of Gardiner" (H. P. 110) (L. D. 118) tabled by that Senator on March 3 pending acceptance of the report; and on further motion by the same Senator, the ought to pass report was accepted and the bill read once; Committee Amendment A was adopted without reading, and under suspension of rules, the bill as amended was given its second reading and passed to be engrossed in concurrence.

On motion by Mr. Jamieson of Aroostook, the Senate voted to reconsider its action taken earlier in today's session whereby bill An Act Relating to Lights on Rear of Trucks (H. P. 1023) (L. D. 1163) was referred to the Committee on Transportation; and on further motion by the same Senator, the bill was laid upon the table pending reference to a committee.
