Orders of the Day

Mr. WYMAN of Washington: Mr. President, I would like to inquire if

L. D. 37, Resolve to Apportion One Hundred and Fifty-one Representatives Among the Several Counties, Cities, Towns, Plantations and Classes in the State of Maine, is in the possession of the Senate?

The PRESIDENT: The Chair will state that L. D. 37 is in the possession of the Senate having been held at the request of the Senator from Washington, Senator Wyman.

Mr. WYMAN: Mr. President, I move that the Senate reconsider its action whereby this resolve was passed to be engrossed and in so doing I realize that it is inevitable that Washington County is going to lose two representatives and have six. However, I do think we can effect a more equitable distribution of the classes as they are now provided in this bill and if you vote Yes and reconsider this bill, I will offer an amendment to change the classes as they are now constituted in the bill in Washington County only.

The motion prevailed and the Senate voted to reconsider its former action whereby the resolve was passed to be engrossed.

Mr. WYMAN: Mr. President, I now offer Senate Amendment A to House Amendment I and move its adoption. There is now as the classes are constituted in this bill, a difference of some 2200 people between the largest and the smallest classes, and this amendment will tend to reduce this inequity and make the classes more even as the Constitution provides. I therefore move the adoption of the amendment.

Senate Amendment A to House Amendment I to H. P. 22, L. D. 37. "Amend said amendment by striking out the 9th line thereof and inserting in place thereof the following: 'and Jonesport 1 representative, Lubec, Machiasport, Trescott, Whiting, Charlotte'.

Further amend said amendment by striking out the comma and word ', Charlotte' in the 3rd line from the end thereof."

Thereupon, the Senate voted to reconsider its former action whereby it adopted House Amendment I: and Senate Amendment A to House Amendment I was adopted; House Amendment I as amended by Senate A was adopted.

Mr. COLLINS of Aroostook: President, I would like to inquire through the Chair if the various amendments you have referred to take in an amendment relating to Aroestook County reapportionment? It way my understanding that there was a House Amendment provided I think by Representative Finnemore and I understood that that was adopted. I haven't seen any redraft of the reapportionment and for that reason-I think there were two amendments and I would like to know whether they are in the bill before it is passed to be engrossed.

Thereupon, the Secretary read House Amendment A to House Amendment B to L. D. 37.

The PRESIDENT: This being a very important matter, the Senate may be at ease for a few moments.

The PRESIDENT: The Chair will state at this time that through the efficiency of your super-efficient Secretary, arrangements have been made whereby this bill when it reaches final engrossment, will be again printed, and in your books.

Thereupon, the resolve as amended by House Amendment A; House Amendment B as amended by House Amendment A thereto; House Amendments C, G, E: House Amendment I as amended by Senate Amendment A thereto, was passed to be engrossed in non-concurrence.

On motion by Mr. Carpenter of Somerset, the Senate voted to take from the table House Report Ought to Pass from the Committee on Inland Fisheries and Game, on bill "An Act Relating to Rabbit Hunting in Oxford, Franklin and Somerset Counties (H. P. 8) (L. D. 7) tabled by that Senator on March 10 pending acceptance of the report; and on further motion by the same Sentor, the ought to pass report was accepted, the bill was read once, and House Amendment A was read and adopted in concurrence.

The PRESIDENT: Is it now the pleasure of the Senate that the Secretary of the Senate be instructed to present to the Senator from Somerset, Senator Carpenter this token of our appreciation of the fact that this is his birthday?

The Secretary presented Senator Carpenter with a gift, amidst the applause of the Senate.

The PRESIDENT: Is it now the pleasure of the Senate that the Sentor from Somerset be granted unanimous consent to acknowledge this gift?

Mr. CARPENTER: Mr. President and members of the Senate, I thank you very much for this token representing my birthday which, incidentally, makes me feel rather aged. As a matter of fact, it was just about thirty-nine years ago on a morning like this that I—

The PRESIDENT: The Chair thinks the Senator has gone far enough. (Laughter)

The PRESIDENT: The Senate is proceeding under Orders of the Day.

On motion by Mr. Jamieson of Aroostook, the Senate voted to take from the table bill "An Act Relating to Lights on Rear of Trucks." (H. P. 1023) (L. D. 1163) tabled by that Senator on March 8 pending reference to a committee.

Mr. JAMIESON: Mr. President, it was my understanding that the committee had heard this bill and had come out with an ought to pass report.

The Secretary read the endorsements on the bill.

Thereupon, on motion by Mr. Jamieson of Aroostook, the bill was referred to the Committee on Transportation in concurrence.
