Thursday, March 17, 1955

Senate called to order by the President.

Prayer by the Rev. Austin H. Wright of Augusta.

These potatoes are presented to the members of the Legislature with the compliments of the Bangor and Aroostook Railroad. You will note in this potato a new variety that has been developed in the last four years, namely a Russet Burbank, and I think you will find that they are of the very highest quality for baking potatoes, and Aroostook County yields to no other section in the United States when it comes to the quality of this product. I want to express the appreciation of the Aroostook delegation to the Bangor and Aroostook Railroad, and I would call to your attention also the little pamphlet that they put out, "The Maine Line," and I am sure that when you bake potatoes you will also call for Aroostook potatoes in the future.
