Wednesday, April 6, 1955

Senate called to order by the President.

Prayer by the Rev. Rodney W. Roundy.

Journal of yesterday read and approved.

#### **House Papers**

#### In the Senate

The Senate was called to order by the President.

#### Orders of the Day

Mr. REID of Kennebec: Mr. President, I would inquire if L. D. 543 is still in the possession of the Senate?

The PRESIDENT: The Chair will state that bill An Act Exempting Funeral Services from the Sales Tax is in the possession of the Senate having been held at the request of the Senator from Kennebec, Senator Reid.

Mr. REID: Mr. President, I now move that the Senate reconsider its action of yesterday whereby it accepted the "Ought not to pass" report of the committee.

The motion to reconsider prevailed.

Thereupon, on motion by Mr. Low of Knox, the bill was laid upon the table pending acceptance of the committee report.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table the 42nd tabled and unassigned item, being "Resolve for the Laying of the County Taxes for the Years Nineteen Hundred Fifty-five and Nineteen Hundred Fifty-six (H. P. 1154) (L. D. 1368) tabled by that Senator on April 5 pending assignment for second reading; and on further motion by the same Senator, the rules were suspended and the resolve was given its second reading.

Mr. BOUCHER: Mr. President: I would like to find out if House Amendment B to House Amendment B is a part of this bill.

The Secretary read the endorsements on the bill.

(In the Senate, on April 5, the rules were suspended, the bill read once without reference to a committee, House Amendment B to House Amendment B was read and adopted; House Amendment B as amended by House Amendment B thereto was adopted, and the bill was then laid upon the table pending assignment for second reading.)

ing assignment for second reading.) Mr. BOUCHER: Mr. President, I now move that the bill be passed to be engrossed in concurrence.

The motion prevailed and the bill was passed to be engrossed, as amended, in concurrence.

On motion by Mr. Wyman of Washington, the Senate voted to take from the table bill "An Act Relating to the Closing of County Offices on Saturday" (H. P. 79) (L. D. 76) tabled by that Senator on March 22 pending motion by the Senator from Franklin, Senator Butler, that the bill be indefinitely postponed.

Mr. WYMAN of Washington: Mr. President and members of the Senate: This bill refers to the office of the Clerk of Courts only; the title reads "Closing of County Offices," but it actually refers to the office of the Clerk of Courts only since the other county offices were closed

by the last legislature, or given permission to close.

When this bill was before the Committee on Towns and Counties there was no opposition to it at that time and there was a considerable amount of evidence in support of the bill. The committee considered the fact that all of the other county offices may be closed on Saturdays and that this is the only county office which remains open. It further considered the fact that at times it is advantageous to attorneys to have this office open, but most of the evidence showed that they have very little business on Saturdays and a good many Saturdays go by without the clerk having any papers to enter. We further considered that we are discriminating against the Clerk of Courts in that we are keeping them in the office on Saturdays when all the other county offices are out

In addition to this, this legislation is permissive, not mandatory; the County Commissioners may keep the offices open on Saturday if they wish as they may other offices. Therefore, I hope that the motion of the Senator from Franklin, Senator Butler, to indefinitely postpone this matter may not prevail.

Mr. BUTLER of Franklin: Mr. President, when this first came up two years ago the argument then was "We will not touch the Court," therefore we were induced and persuaded to close the rest of the court house. This is only another example of "If you at first do not succeed, try and try again," and so they have tried by this second method to close the court house on that day.

Apparently none of the attorneys are greatly disturbed as to whether they are going to go to work on Saturday or whether they can go to work on Saturday. I do not know why I should have to stand up when I am only a small county attorney. I do feel there is a principle that if we wish to do something we are still open to the public, and we do have a monopoly upon doing certain things and we are allowing that to be deceased by working fewer hours. I feel that this is not the good American way of doing business such as our forefathers started

but rather to see how little we can do in as short a time as possible. I do not expect the motion to prevail tecause it does not have any sentiment or the belief that we should do the best we can. I therefore request the opportunity to withdraw my motion for indefinite postponement, which, if granted, I then would move passage.

The **PRESIDENT**: The Senator from Franklin, Senator Butler, asks permission of the Senate to withdraw his motion. Is there objection? The Chair hears none and the Senator is granted that permission.

Mr. LOW of Knox: Mr. President, if this bill is to have passage it would seem only reasonable to make it effective at the beginning of the summer when it will mean most to all the county clerks rather than some time in August when the summer is half over. In order to present an emergency amendment I therefore move that we reconsider our action in passing this bill to be engrossed.

The motion prevailed and the Senate voted to reconsider its action whereby the bill was passed to be engrossed.

The Senator from Knox, Senator Low, then presented Senate Amend-ment "A" and moved its adoption. Senate Amendment "A" was read

by the Secretary as follows: SENATE AMENDMENT "A" to H. P. "9, L. D. 76, Bill "An Act Relating to the Closing of County Offices on Saturday."

'Amend said bill by inserting before the enacting clause the following emergency preamble:

Emergency preamble. Whereas acts of the legislature do not become effective until ninety days after the adjournment unless passed as emergencies and whereas in order to permit the closing of the county offices of the Clerk of Courts during the summer months of 1955 it is necessary that the following legislation become effective as soon as possible, and whereas in the judgment of the legislature these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety, now therefore;

"Further amend said bill by adding at the end thereof the following emergency clause: 'In view of the emergency cited in the preamble this act shall take effect when approved.' "

Senate Amendment "A" was adopted and the bill was passed to be engrossed as amended by Senate Amendment "A" in non-concurrence and sent down for concurrence.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table Item 20 on today's calender, The Committee on Liquor Control on Bill "An Act Relating to Excise Tax on Seven-Ounce Bottles of Malt Liquor," (H. P. 672) (L. D. 748) reporting that the same "Ought to pass," which report was tabled by that Senator earlier in today's session, and the same Senator moved the pending question.

The Senate then voted to accept the "Ought to pass" report of the Committee in concurrence. House Amendments A and B were read by the Secretary and adopted in concurrence and the bill was tomorrow assigned for second reading.
