Mr. LOW of Knox: Mr. President, may I ask which bill was just tabled on my motion?

The PRESIDENT: The Chair understood your motion to refer to bill, An Act Relating to Sales to and Consumption of Liquor by Minors (S. P. 302) (L. D. 810)

Mr. LOW: There seems to be some confusion in the item. I wished to table L. D. 1106.

Thereupon, on motion by Mr. Low of Knox, the Senate voted to take from the table bill, An Act Relating to Sales to and Consumption of Liquor by Minors (S. P. 302) (L. D. 810) tabled by that Senator earlier in today's session pending passage to be enacted; and on further motion

by the same Senator the bill was passed to be enacted.

On motion by Mr. Low of Knox, the Senate voted to reconsider its action taken earlier in today's session whereby it passed to be enacted An Act Relating to Expenses of Persons Committed to State Prison for Safekeeping (S. P. 392) (L. D. 1106); and on further motion by the same Senator, the bill was then laid upon the table pending passage to be enacted.

On motion by Mr. Low of Knox, the Senate voted to take from the table An Act Relating to Expenses of Persons Committed to State Prison for Safekeeping (S. P. 392) (L. D. 1106) tabled by that Senator earlier in today's session pending passage to be enacted; and on further motion by the same Senator the Senate voted to reconsider its former action whereby the bill was passed to be engrossed.

Mr. LOW of Knox: Mr. President, the language of this bill is not clear. The Attorney General has pointed out that it might be construed that any county which sent a prisoner to State Prison for temporary safekeeping might become liable for all the expenses of the prisoner. In order to clarify that language I offer Senate Amendment A and move its adoption:

SENATE AMENDMENT "A" to S. P. 392, L. D. 1106, Bill "An Act Relating to Expenses of Persons Committed to State Prison for Safe-keeping."

Amend said Bill in the next to last line by striking out the underlined word "the" before the underlined word "amount" and inserting in place thereof the underlined words and punctuation: 'each such person, a proportional'

Which amendment was adopted.
Mr. FARRIS of Kennebec: Mr.
President, may I inquire as to the status of the bill at the moment.

The PRESIDENT: The bill has had its two several readings, and the motion is in order that it pass to be engrossed.

Thereupon, on motion by Mr. Farris of Kennebec, the bill and accompanying papers were laid upon the table pending passage to be engrossed.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table the 44th tabled and unassigned matter, Bill "An Act to Clarify the Liquor Laws," (S. P. 245) (L. D. 685) tabled on April 6th by that Senator pending adoption of House Amendment "A".

Mr. BOUCHER of Androscoggin: Mr. President, I would like to have the report of the committee.

The PRESIDENT: The Secretary will read the committee report.

The SECRETARY: Bill "An Act to Clarify the Liquor Laws," (S. P. 254) (L. D. 685), Report from the Committee on Liquor Control reporting the same "Ought to pass" as amended by Committee Amendment "A".

On March 29th the Senate accepted the report and on March 29th Committee Amendment "A" was adopted. On March 30th the bill was passed to be engrossed as amended by Committee Amendment "A". Comes from the House passed to be engrossed as amended by House Amendment "A" and as amended by Committee Amendment "A" in non-concurrence.

Mr. BOUCHER: Mr. President and members of the Senate: This House Amendment "A" was offered in committee and was denied. After the bill was reported "Ought to pass" with Committee Amendment "A" apparently the House members of the committee decided to present

House Amendment "A" and did not consult the committee at that time. Therefore I move the indefinite postponement of House Amendment "A".

The PRESIDENT: The Secretary will read House Amendment "A".

The SECRETARY: House Amendment "A" to Bill "An Act to Clarify the Liquor Laws." (S. P. 254) (L. D. 685)

Amend said bill in Section 10 by adding at the end thereof the following underlined sentence:

No merchandise shall be construed to be reasonably compatible with a stock of malt liquor for the purpose of licensing a retail store which consists of gasoline or oil, used or new cars, parts thereof or accessories, clothing, hard ware, paints or building material, electrical appliances or equipment or household furniture or furnishings.

In the House read and adopted.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Androscoggin, Senator Boucher, that House Amendment "A" be indefinitely postponed in non-concurrence. Is the Senate ready for the question?

As many as are in favor of the motion of the Senator from Androscoggin, Senator Boucher, will say aye; those opposed will say no.

A viva voce vote being taken, the motion prevailed and House Amendment "A" was indefinitely postponed and the bill was passed to be engrossed as amended by Committee Amendment "A" in non-concurrence.

Sent down for concurrence.

On motion by Mr. Farris of Kennebec, the Senate voted to take from the table "An Act relating to Expenses of Persons Committed to State Prison for Safekeeping" (S. P. 392) (L. D. 1106) tabled by that Senator earlier in today's session pending passage to be engrossed as amended by Senate Amendment "A", and on further motion by the same Senator the bill was passed to be engrossed as amended by Senate Amendment "A" in non-concurrence Sent down for concurrence.

Mr. Chapman of Cumberland was granted unanimous consent to address the Senate:

Mr. CHAPMAN: Mr. President and members of the Senate: Even at this late date I request unanimous consent to introduce a resolve In explanation of that request I would like to state the following:

A short while ago certain escapees from the State School for Boys in the process of their escape stole an automobile, and in pursuit by police officers after they had stolen the automobile got into a rather bad accident, injuring one Kenneth Boynton and his wife and child rather seriously. As a result of that, suit was brought against the superintendent of the State School for Boys by these parties who were injured, particularly in view of the fact that the escapees involved were financially irresponsible and execution-proof. After the parties to the suit conferred with the Attorney General's office it was thought, according to a certain theory of law, that the State of Maine itself might be liable, and on that basis the Attorney General's office prepared an authorization resolve for suit against the State of Maine in the conventional manner, there being precedent for this, and presented it to me with request for introduction. As I say, this took place a short while ago and after the deadline for introduction of bills was in effect.

I might say that this particular resolve is not to assess liability or responsibility on the State of Maine, it relates merely to permission to sue, and even that permission must be reviewed by the committee itself. I have inquired of the Chairman of the Committee on Claims and have been assured that it will delay their work in no manner and will not delay the adjournment of this legislature. I therefore request that the resolve be accepted by unanimous consent.

The PRESIDENT: The Senator from Cumberland, Senator Chapman, presents a resolve. The Secretary will read the resolve by title only.

The SECRETARY: "Resolve authorizing Kenneth H. Boynton and Ernestine Y. Boynton of South Portland to sue the State of Maine."

The PRESIDENT: Is there objection to the reception of the resolve? The Chair hears none and the resolve is received.

On motion by Mr. Chapman, the resolve was referred to the Committee on Claims, ordered printed.

Sent down for concurrence.

The PRESIDENT: The Chair would make a general comment on the adjournment motion. Tomorrow being Good Friday, it might be desirable that the session be at one o'clock rather than one-thirty. The Chair awaits a motion.
