#### SENATE

Tuesday, April 12, 1955

Senate called to order by the President.

Prayer by the Rev. Roger D. Blinn of Gardiner.

Journal of April 8 read and approved.

#### Orders of the Day

Mr. COLLINS of Aroostook: Mr. President, I move that the Senate resolve itself into a committee of the whole for the purpose of having an off the legislative record discussion of the general fund appropriations measure.

The motion prevailed.

Thereupon the Senate resolved itself into a Committee on the Whole.

The PRESIDENT: The Senate is now proceeding on the record.

On motion by Mr. Hillman of Penobscot, the Senate voted to take from the table bill "An Act Relating to Hunting of Partridge and Pheasants." (H. P. 533) (L. D. 590) tabled by that Senator on April 5 pending enactment; and on further motion by the same Senator, the bill was passed to be enacted.

Mr. WEEKS of Cumberland: Mr. President, I have in my possession here this morning an act relating to authority of County Commissioners of Penobscot County to convey an easement in land. I won't go into any discussion as to why I, from Cumberland County, happen to have this, and why it was not put in on time, but at least, I have been requested to ask your indulgence to the point where you will give me unanimous consent to introduce it. If you do so, I will make a motion that it be referred to the Committee on Natural Resources.

There being no objection, bill An Act Relating to the Authority of the County Commissioners of Penobscot County to Convey an Easement in Land was received by unanimous consent; and on further motion by the same Senator, the bill was referred to the Committee on Natural Resources, and ordered printed.

Mr. Reid of Kennebec was granted unanimous consent to address the Senate:

REID Kennebec:  $\mathbf{Mr}$ of Mr. President, I understand that the Committee on Agriculture has assigned a hearing for next Tuesday. I would respectfully urge all Chairman of Committees if they are to have further hearings, to assign them for next Tuesday so that at that time all hearings will be closed and we can get down to the business of executive sessions rather than to spread them over and possibly interrupt morning and afternoon Senate sessions.

With regard to the bill just received by unanimous consent, I would suggest to Senator Butler, if this can be assigned for next Tuesday, it would be very helpful.

Mr. CARPENTER of Somerset: Mr. President, the reason for tabling this matter the other day was

that we were in the process of having an increase in fishing licenses and the amendment I am going to present will simply clarify the additional increase in the license.

I present Senate Amendment "A" to Committee Amendment "A" and move its adoption.

The PRESIDENT: The Senator from Hancock, Senator Silsby asks the Senator from Somerset, Senator Carpenter, to explain just what this means, and the Senator may explain if he wishes.

Mr. CARPENTER of Somerset: Mr. President, that clarifies the biennial revision to make the 25-cent increase in the fishing license.

Mr. SILSBY of Hancock: Mr. President, do I understand that this is a further increase of hunting license or that there is no further increase?

Mr. President, I move that the amendment lie on the table.

On motion by Mr. Silsby the bill and accompanying papers were tabled pending the motion of the Senator from Somerset, Senator Carpenter, that the Senate adopt Senate A m e n d m e n t "A" to Committee Amendment "A".

Mr. Lessard of Androscoggin was granted unanimous consent to address the Senate.

Mr. LESSARD: Mr. President and Members of the Senate: I rise on a matte: today that I feel we should not overlook.

After a war in which there is victory we are all very elated and there is much celebration because a cause has been won. I know that you like mysel: perhaps were rather astounded but highly pleased in the report which has come to us via television last night and in the morning papers where by the great medical profession and scientists have won a war against perhaps one of our most deadly enemies, and that is polio. I think today that America has won one of the greatest victories that has ever been won in this country or that the world has seen during our lifetime. I just could not let this opportunity pass without at least bringing it to the attention of the people whom we represent that we in this legislature are cognizant of this great victory. I do not know the procedure, but perhaps sometime in the near future some resolution or memorial can be drawn to show our appreciation in behalf of the people of Maine for the great victory which has been won over this dreaded disease. As I say, I could not let this opportunity pass this morning, and I know that you share with me the great feeling of victory. I think a great war has been won which will tend to help all mankind in the future

The PRESIDENT: The Chair can think of no more appropriate procedure for this Senate to take than for us to stand f or thirty seconds in recognition of the tenth anniversary of the death of one individual who represented the public interest in the ravages of polio, Franklin D. Roosevelt.

(The Senate thereupon stood in silence for thirty seconds)

The PRESIDENT: The Senate is proceeding under Orders of the Day. The Chair notes the early hour and the long table.

Mr. SILSBY of Hancock: Mr. President and Members of the Senate: I have conferred with Senator Carpenter and I think I understand the purpose of the amendment that he has offered here. In L. D. 436, as I understand it, there is an amendment to that bill which authorizes the Commissioner to appoint certain people to sell licenses and in drafting the original bill there was not any consideration given to the fee to the persons collecting. If my understanding is correct I do not want to stall the mechanics of the Legislature and I wish to take it from the table.

The PRESIDENT: The Senator from Hancock, Senator Silsby, moves to take from the table L. D. 436, tabled by him earlier in today's session. Is this the pleasure of the Senate?

The motion prevailed and the bill was taken from the table.

The PRESIDENT: The question now before the Senate is the motion

of the Senator from Somerset, Senator Carpenter, that the Senate adopt Senate Amendment "A" to Committee Amendment "A". Is this the pleasure of the Senate?

The motion prevailed and Senate Amendment "A" to Committee Amendment "A" was adopted. Subsequently under suspension of the rules the Senate voted to reconsider its action whereby C o m m ittee Amendment "A" was adopted and to adopt Committee Amendment "A" as amended by Senate Amendment "A", and to pass the bill to be engrossed as amended.
